The Golf Course

Designed by renowned golf course architects Bill Newis and Stan Leonard, it was first opened in 1976

Redwood Meadows meets the criteria of a truly memorable course. Eighteen individual and distinctive holes, yet retaining a collective continuity from the first tee to the last green.

Because of the many trees, it might appear to have very narrow fairways, where in actual fact, the landing areas are quite spacious. Having said that, there is no doubt that good course management decisions are an integral part of successful play at Redwood.

Redwood Meadows has matured incredibly well and provides a challenge for both the recreational and competitive golfer. Designer Bill Newis took full advantage of the natural terrain and the area teems with wildlife. There are several water hazards which come into play on seven of the eighteen holes.

When Redwood hosted the PGA Nationwide Tour (now called the Web.com Tour), it was ranked by the players as one of the two best courses on tour.

Membership

Redwood Meadows is a semi-private club with 500 shareholders. We do welcome public players with some restrictions on weekends (Friday, Saturday and Sunday)

Members not only enjoy one of the finest course layouts in Calgary, but also enjoy modest yearly rates for playing privileges.

Shares are available through the club office and a transfer fee is associated with the sale transaction.

Each initiated member is entitled to add family members to the yearly dues rates.

Non-Member Associate memberships are available through the club for one year only.

For Senior players (over 55 on March 1) we have a weekday (Monday thru Friday) membership rate.

Intermediate, Full-Time Student (18-23 On May 1) may receive a discounted membership rate.

Juniors (under 19 on May 1) are eligible for special rates.



Programs

The Members have elected a membership executive to operate club tournaments, social functions and handicap computer system.

Redwood Meadows offers Ladies Day and Senior Day every Tuesday morning. Men's Day is held on Wednesday afternoons throughout the season and each member is permitted one guest for these events each day.

Junior lessons and camps begin each May and continue through to August.

There is organized Interclub match competitions for Men, Ladies, Seniors and Juniors throughout the golf season.

Member's club tournaments are held on Saturday and Sunday and are posted for the year with sign up in the Pro Shop.

Corporate and Charity tournaments commence on Monday and Thursday and are usually accompanied with a member shotgun on the same day.
