I understand that the tournament will be played as long as the golf course is deemed playable, that cold weather, rain or winds are not acceptable reasons to cancel. The Course Superintendent reserves the right to deem the golf course unplayable or unfit for power cart use. If the golf course is deemed unplayable, an alternate date will be booked, and if this is not possible, 100% of the original deposit will be refunded. If the golf course is deemed unfit for power cart use, power cart fees will be deducted from the final invoice.

I agree that Redwood Meadows Golf and C.C. is not responsible for any lost or stolen property. All tournament signage must be removed from the Golf Course before the end of the tournament day.
