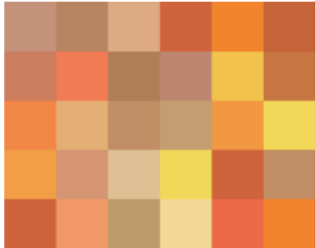

In addition to the general rules and regulations on the reverse, the following conditions are imposed:

2. All items sold must be approved by staff. You must list all items sold on reverse side.
3. Set up may begin at 7:00am and must be completed by 10:00am. Break down must start by 5:30pm and completed by 6:00pm.
4. No alcoholic beverages or food may be sold except for pre-package cakes, cookies, ice cream, snow cones.
5. No glass containers may be sold.
6. Leave area in clean condition.
7. Organization/individual who applied for the contract is responsible for repairs or replacement if damage occurs.
8. Agreement must be made with adult assuming responsibility for organization.
9. Only food permitted to be sold is by Food Trucks.
