 - a. #3999 Income numbers rounded
 - **b.** Salaries/ Benefits combined to #6709
 - i. Payroll Tax Amounts incorrect will be reduced because pastors Salary not subject to Social Security Taxes
 - **c.** #6540 Church Insurance getting quotes
 - **d.** #6570 Church Décor will be cut. Getting quotes for watering. Volunteers needed for interior.
 - **e.** #5905 Confirmation meals higher, but includes Dinner Church expenses, maybe rename and start a new category
 - **f.** #4013 does include Dinner Church income
 - **g.** Anonymous Gift and match went into General Undesignated Fund except for about \$5,000 not yet matched.
