- 5. Approval of November treasurer's report- Report was given by Peter we started the month -\$33,436.57 and took in \$55,291.46 in contributions and \$2,530.00 in special offerings. Our expenses totaled \$69,009.21 leaving us at -\$11,187 and a cash balance of -\$44,624.32. A motion was made by Bridget, seconded by Dennis, **APPROVED.**

 - a. Pastor Naomi- Gave preliminary information of talks that are happening with Troy Pederson and the YMCA to be a site for childcare. They will be looking to form a committee after the annual meeting.
 - b. Pastor Dean- Welcomed Pastor Tim, reported on Grief Care and reminded council chairs to get their annual reports to the office.
 - c. Pastor Tim- Has felt welcomed so far and thanked us for the call. His installation will be January 12th and 13th with a reception during the Ed hour.

She then made a motion about First Fruits Giving designations and after much thought they will remain the same as last year, seconded by Peter, **APPROVED.**

- a. 2019 Annual Budget- The budget was handed out for everyone to view. Peter went over some highlights and explained that they added 2% from the 2018 to 2019.
