April 23, 2013 was a big day for PAMET SD!!! After a few months of waiting, the IRS has informed Let Negado, that PAMET SD has been determined to be exempt from Federal Income Tax under section 501(c)(3) of the Internal Revenue Code. PAMET SD was also determined to fall under the 509(a)(2) public charity organization under the Code sections.

The determination means contributions to PAMET San Diego are tax deductible under section 170 of the code. The organization is qualified to receive tax deductible bequests, devises, transfers or gifts under section 2055, 2016 or 2522 of the code.

PAMET SD has recently submitted California Franchise Tax Board Form 3500A to apply for CA State tax exemption. It is all the hard work of the officers and members of the organization that made the application process go smoothly and confirm its public charity status before the association celebrates its third founding anniversary on June 6, 2013.
