### **ARTICLE XII APPOINTED OFFICERS AND STANDING COMMITTEES**

**Section 1** Now reads: There shall be the following appointed officers: Finance Chair, Scrapbook Chair, SERCH Editor, Chaplain, Auditor Awards Chair, ESA for St. Jude Chairs – Senior and Junior, **Easter Seal Chair**, Hotel Contracts Chair and the Association of the Arts Chair.

**Reason:** The name of the new publication is called the **Journey**. This is a housekeeping change.

16. Expenses for a SERC representative visitation to State Conventions shall be included in the SERC budget and shared among the representatives to help defray the cost of the visitation based on transportation (reasonable air fare or mileage as allowed by the IRS rate) meals or lodging. There will be no reimbursement of mileage, meals or lodging for any SERC representative to her home State Convention unless approved by the President. (November, 2008)

**Change to read:**

16. Expenses for a SERC representative visitation to State Conventions shall be included in the SERC budget and shared among the representatives to help defray the cost of the visitation based on transportation (reasonable air fare or mileage as allowed by the IRS rate) **baggage fees**, meals or lodging. There will be no reimbursement of mileage, meals or lodging for any SERC representative to her home State Convention unless approved by the President. (November, 2008)

Reason: To include **baggage fees**, which used to be a part of the cost of airfare.
