Seems like we were just starting through the winter season and now Easter is here and gone. Several of our residents have already left for the long trip home with many more to follow shortly. For those of us who remain, there are still challenges of keeping the park in great condition for all residents. In order to keep all work moving forward and to identify new needs our Board had its

regular April meeting on schedule. Our meeting began with Tim opening up with a list of Old Business items. At a high level this included notification to those present of: Review and acceptance of the new Reserve Study.

Tim reported that the Generac emergency generator installation scheduled for the clubhouse remains on track to complete as planned and within budget. Progress on updating the STW Prospectus is making good progress.

Tim reported that lighting updates for the clubhouse sidewalks are on schedule.

In addition to the pending Old Business several New Business items were raised and addressed as follows:

- It was approved that May 16, 2019 will now be the last scheduled formal board meeting until October 17, 2019.
 Should a need arise before then, Tim will call a meeting and set up a conference bridge to facilitate it. One additional meeting was necessitated to ensure that bids for potential summer projects may be reviewed by the Board prior to execution.
- Warranty work on the pool is progressing well with the general over all condition of the pool improving.
- Plans for work this summer are tentatively set to focus on the clubhouse and shuffleboard court structures. Bids will be gathered for the next meeting which will cover a new roof, spouting, windows and drop-down screen for the clubhouse. They will also include bids for repairs

- to the shuffleboard building storm gutters and rusting side panels.
- A new sound system for the club house was approved and Ernie and Peggy will be heading up making this happen. Many thanks to the Ladies Group for their offer to help pay for this.
- Bids will be explored related to upgrades to the existing security systems in the park. This will be discussed at the next board meeting.
- As a result of increased demand with new resident requirements, we are going back to the original forms for space in the storage area down by the shed. Each shareholder will be required to fill out a form and space will be made available on a first come first come basis. Note: All vehicles stored in this area must be licensed and non-commercial in nature to be there. Spaces will be limited to one per share holder. Jack Pugh will be working on this over the summer months.

Finally, please note that work orders need to be filled out by owners of the property and given to the office for execution, for those residents who have not made other arrangements for home upkeep while they absent from are property. This is required both for residents who are here and need assistance as well as residents who are up north and need work done over the summer to keep up the homes. appearance of their Once completed please do NOT give completed work orders to Polly or request her to complete them for you. Completed Request for Contract Work forms should

submitted to the office. Hours worked as a result of these requests will be billed to each resident by the park directly. Polly will book her time as usual and the park will maintain required equipment to do the work. NOTE: Each work order will be billed to the resident at \$25.00 an hour on the full hour. This is required to allow Polly time to store and lock up park equipment after work is completed.

Spanish Trails West, Rules and Regulations

Reminder

(These Rules and Regulations pertain to share- holders, non-shareholders as well as guests, visitors, renters, tenants, lessees, or sub-lessees)

X, D. Subletting: Homes in Spanish Trails West may be sublet one time per calendar year for a period of not less than three (3) months to the same sub-lessee. Prospective renters must apply to be occupants of Spanish Trails West and must be approved by management prior to occupancy. The initial sub-lessee may have occupancy in Spanish Trails West for a period of up to two (2) years. After this two (2) year period of occupancy in Spanish Trails West in any home, the sub-lessee may be extended with written approval of management. This approval will not be unreasonably withheld. Sub-lessee shall be deemed to include any occupant of Spanish Trails West who is not an owner or spouse of an owner or otherwise residing with an owner of a mobile/manufactured home in Spanish Trails West. In the event an owner is deceased, his/her heirs may assume residency in Spanish Trails West if they qualify to reside in the park. An application must be submitted and approved before taking occupancy.
