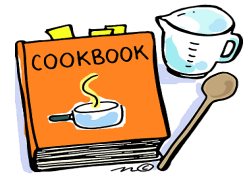

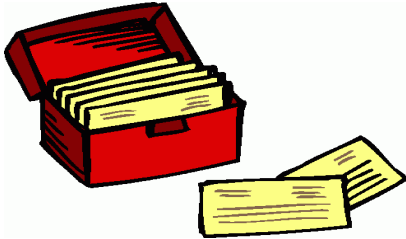

FROM MY RECIPE BOX:



Here is one of my very favorite recipes:

Butter Cake

INGREDIENTS

1 cup butter, softened
2 cups sugar
4 large eggs
2 teaspoons vanilla extract
3 cups all-purpose flour
1 teaspoon baking powder
1/2 teaspoon baking soda
1/2 teaspoon salt
1 cup buttermilk

BUTTER SAUCE

1 cup of sugar
1/2 cup of butter - cubed
1/4 cup of water
1 – 1/2 teaspoons of almond extract
1 – 1/2 teaspoons of vanilla extract

DIRECTIONS

In a large bowl, cream butter and sugar until light and fluffy. Add eggs, one at a time, beating well after each addition. Beat in vanilla. Combine the flour, baking powder, baking soda and salt; add to creamed mixture alternately with buttermilk, beating well after each addition.

Pour into a greased and floured 10-in. tube pan. Bake at 350° for 65-70 minutes or until a toothpick inserted in center comes out clean. Cool 10 minutes. Run a knife around edges and center tube of pan. Invert cake onto a wire rack over waxed paper. For sauce, combine the sugar, butter and water in a small saucepan. Cook over medium heat just until butter is melted, and sugar is dissolved. Remove from the heat; stir in extracts.

Poke holes in the top of the warm cake; spoon 1/4 cup sauce over cake. Let stand until sauce is absorbed. Repeat twice. Poke holes into sides of cake; brush remaining sauce over sides. Cool completely. **Yield:** 16 servings.

Homemade Peach Cobbler

Ingredients

1 cup self-rising flour 2(16oz) cans sliced peaches in heavy Syrup
1 cup white sugar ½ Cup butter
1 cup milk

Directions

1. Melt Butter or Margarine in 9x 13-inch pan
2. Mix together the flour, sugar, and milk. Pour mixture into the pan. Spread peaches, including syrup
Evenly around the pan.
3. Bake at 350 degrees F (175 degrees C) for 30 to 40 minutes, until the crust turns golden brown.
Let cool for about 10 minutes before serving.

Where do I begin.... There are so many things happening with International, Regional and State Foundation at this time of the year and if I could have the space, I would fill up our Newsletter. First and foremost, introductions are in order, I am Terry Holifield, SERC and SCSC Foundation Chairman. I have been with ESA since 1991, SC state president and I ask for the chair of Foundation each year, so I am especially proud to be SERC Foundation under Malinda Remington. Thank You.

Someone once said to me in the 90's, Foundation is a "do nothing" position, they were so wrong, Foundation is the heart of ESA. ESA was started, as we all know, by a group of community minded, educated leaders, it was more than a book club or beautification club, ESA has its base in education. So why not join the Foundation? it's only \$25, a onetime fee and \$15 each year or \$250 x 2 payments to equal \$500 for a lifetime membership. The money from membership fees and finance projects, like the Fantasy Event, help to fund our education material, scholarships, etc. We all have different degrees of education within our membership, we educate people all the time about ESA, St. Jude, Easter Seals, what we are doing, who we are, etc. Why not Foundation?

At this time of year, those of us, who are busy with processing scholarships, know the date for receiving those scholarships will soon end for this year. Then the judges, each Foundation State Chairman has recruited, will start their part and change someone's life by granting them a scholarship from our Foundation. Finding Judges within ESA would be easy, because we are all born with the heart of a volunteer beating in our chest. ESA Foundation Judges must be outside of ESA membership, so I find teachers, parents, body piercers, office workers, engineers, nurses, retired people, and even Miss USA coordinators. They don't judge our state applications, they judge anywhere but SC. With our newest all electronic/computer set up, gone are the days of 300+ scholarships, in paper form, laying around your dining room table for a month as you personally inspected each application and then handed them to each judge. Today with a click of a mouse, a scholarship can be forwarded to its next assignment in 5 minutes. What happens if someone doesn't have the GPA needed, or two form letters, etc.? The applications are sent to Kathy Loyd and another group determines if they move on. For \$5 per scholarship, an appicate can apply for as many as they qualify. A few years ago, in Oregon, I had the pleasure of hearing the story of two Scholarship winners. One received 3 scholarships and the other 5. We changed their lives. One young lady lost her mother in high School. Her GPA suffered, she wrote so beautifully of her struggle with her loss and how she started to pull herself together, that given a chance, she would never let us, ESA Foundation, regret awarding her a scholarship....and so, as she told of her accomplishments, they became my accomplishments. We changed her life. Maybe one day, one of us will sit across from her and when she sees "ESA", a smile will come across her face, as she thinks back to the moment she received the news that her dreams were within her reach.

ESA Foundation is not just for college bound students. We have scholarships for certifications seminars, training to continue your accreditation or diversifying your job skills for hair dressers, to engineers, for teachers, and more.

ESA Foundation also offers assistance with recognizing people through awards: The Humanitarian Award, The Stewardship Recognition and the Robert and Dixie Palmer Recognition Award to name three.
