Rules & Regulation Reminders



LBV Rules and Regulations are to be followed by all homeowner's and renters. CDM and the Board are actively pursuing all violations. If you misplaced your copy of the Rules and Regulations or did not receive one, please stop by the Association Office and pick up OTHER: a copy. All rules must be followed by homeowners and renters. Here is an example of some of the rules to be aware of. since these are the most violated rules.

REMINDER RULES AND REGULATIONS PLEASE ADHERE TO THE FOLLOWING:

PET RESTRICTIONS:

Each owner is allowed one common household pet weighing a maximum of 35 pounds at full growth and must be registered with the Association Manager with a photo of the pet.

• **DOGS ARE NOT ALLOWED IN POOLS OR POOL AREA.**

Pets outside the unit must be on a leash at all times. Pet feces MUST be picked up ٠ immediately. Subject to a \$75 fine.

PARKING RESTRICTIONS:

- Parking Permit must be visibly displayed.
- No Parking in Red Fire Lanes
- ONE CAR MUST be parked in the units garage and the other car is permitted to be parked in an available parking space.
- All vehicles parked, including RV's, boats and trailers must be "street" legal.
- Guest parking is allowed in open parking spaces only and for a period of 72 hours • (3 days). If longer, guests must obtain a guest parking pass.

- No overloading of garbage above the rim of the bin.
- No smoking in the pool and pool area.
- Nothing is to be placed on, suspended from or attached to the balconies, decks, railings, or patios.
- Balconies, decks, patios and entrance ways are to be kept neat and clean at all times.
- All garage doors must remain tightly closed except when entering or leaving the garage, or in use.
- Washing any vehicle with a hose is prohibited.
- Climbing over block walls, fences and gates is prohibited.

HOLIDAY PARTY IN DECEMBER

It's been awhile since we had a get together. With new people moving into our community and the "snowbirds" back in Laughlin, a December Holiday Party is in the planning stages. We are planning to hold it at the American Legion Hall on Bruce Woodbury Drive. Tentatively scheduled date is **Saturday, December** 7th or the 14th. We have not received confirmation from the American Legion on the date. There is no cost to attend the party, but you are welcome to bring a dish or dessert. A sign up sheet will be posted at the bulletin board.

Last year we did a "white elephant." It was such a success and so much fun and enjoyed by all. This year we are asking those that want to participate in the "white elephant" game to bring a wrapped gift costing no more then \$10. Popular items last year were scratch offs, but a funny, weird or a nice gift will also be fun surprises. Here's some insight of how the "white elephant" game is going to work.

- 1. Each player brings one wrapped gift to contribute to a common gift pool.
- 2. Players draw a number from a hat to identify the order they go in.
- 3. The first player selects a gift from the gift pool and opens it.
- 4. The following players can choose to either pick an unwrapped gift from the pool or steal a previous player's gift. Anyone who gets their gift stolen in this way can do the same.
- 5. To keep things moving along, there are a couple of limits on gift swapping:
 - A present can only be stolen once per turn.
 - After three swaps, the turn automatically comes to an end.
- 6. After all players have had a turn, the first player gets a chance to swap the gift he or she is holding for any other opened gift. Anyone whose gift is stolen may steal from someone else (as long as that person hasn't been stolen from yet). When someone declines to steal a gift, the game comes to an end.

So start thinking now about your gift and mark your calendars. Look for the Holiday Party dates, times, sign up and other details on the bulletin board. The information will be posted when received. When I have the information I will inform you. All homeowners and renters are invited.

Serving on the Board of Directors is a voluntary position. There is no pay, the job can be time consuming, and there are lots of decisions to be made on behalf of other people. A fiduciary responsibility is no easy matter. You are always working towards the best interest of the people that you serve. The management company must take direction from its Board of Directors. All legal contracts must be approved and signed by the Board. All financial reports are reviewed by the Board. The management company cannot act independently from the Board. So, if you are reading this correctly, you may assume that there are lots of meetings and discussions. This is where YOU come in. Input and communication is a key ingredient when serving on the Board. Everyone has a voice We need people with good ideas, willing to work for the betterment of the Association.

Please get involved, stay informed and do your part. Join in, to become a viable part of our community.
