"The Amateur Radio Emergency Service (ARES) consists of licensed amateurs who have voluntarily registered their qualifications and equipment for communications duty in the public service when disaster strikes. Every licensed amateur, regardless of membership in ARRL or any other local or national organization, is eligible for membership in the ARES. The only qualification, other than possession of an Amateur Radio license, is a sincere desire to serve. Because ARES is an amateur service, only amateurs are eligible for membership. The possession of emergency-powered equipment is desirable, but is not a requirement for membership." — ARRL

There are no dues or membership fees associated with being part of ARES. To join ARES, please fill out an ARES membership form located here and contact Rial Sloan, AI4ZV to register your membership on the Georgia ARES database.

Ballots were counted today, and challenger Doug Rehman, K4AC, of Mt Dora, Florida, narrowly defeated incumbent Southeastern Division Director Greg Sarratt, W4OZK, of Huntsville, Alabama, 961 to 949 votes. Rehman was among challengers who ran against Sarratt in 2010.

Sarratt has served as a Director since 2007.

There was no change in the Vice Director position. Incumbent Jim Millsap, WB4NWS, handily outpolled challenger George Hawrysko, K4AWA, 1429 to 467 votes. Millsap, of Acworth, Georgia, was appointed in 2012 to complete the term of Andrea Hartlage, KG4IUM, who resigned when she moved out of the Southeastern Division.

ARRL President Kay Craigie, N3KN, informed the candidates of the election results by telephone. ARRL International Affairs Vice President Jay Bellows, K0QB, observed the balloting and reported the results.

- 2) a -- EME (Earth-Moon-Earth or "moonbounce") stations send "O" to listen for their own echoes and alert others to their presence.
- 3) <u>Armed Forces Day</u> when hams make crossband QSOs with stations on US Military bases. With call signs of WAR, AIR, NAV and such, they have memorable QSLs.
- 4) c -- The county hunters pursue the USA-CA Award.
- 5) b -- Dust off that brass and pound away before heading out to that midnight gala.
- 6) a -- Who said chivalry was dead?
- 7) d -- Tune up to 29.600 -- the FM simplex calling frequency -- or try some of the repeaters between 29.5 and 29.7 MHz.

- 12) d -- The lower the band, the lower maximum data rate becomes, down to 1200 bps in the HF bands.


Bonus: Repeater outputs on 147.00 MHz comply with both -600 kHz and +600 kHz offset planning.
