

# The 2010 MISS SK BAGUIO®

This is an official Preliminary to the **2010 MISS SK BAGUIO ® Pageant** which is independently produced by Baguio City Federation of Sangguniang Kabataan. I hereby apply as an entrant to the **2010 MISS SK BAGUIO®** Pageant and I acknowledge and agree as follows:

1. I will be at least sixteen (16) and under twenty-one of age on **October 1, 2010**.
2. I am not married, have never been married and have never had a marriage annulled. I have never given birth to a child and am not now pregnant nor am I a parent. If any of these conditions change, I will notify the Pageant Director immediately, and I understand that this may affect my eligibility.
3. I have never participated in a previous MISS BAGUIO or MISS HRAB from 2008-2010.
4. I am of good health and moral character.
6. I represent that I have not and will not engage in any activities which, if disclosed to the public, would bring, or tend to bring, myself, my pageant director, the MISS SK BAGUIO® Pageants, SK Baguio City Federation or any of their subsidiaries, affiliated or related companies into disrepute, ridicule or contempt not limited to, but to include any type of use of illegal drugs, any other illegal behavior or activity, professional or amateur nude or semi-nude dancing or modeling in any sexually oriented business or club, any type of nude or semi-nude photographs or video tapes, prostitution, any felony conviction, probation or misdemeanor involving moral turpitude.
7. I now reside and have resided in my barangay as my permanent and primary residence for a period of at least (6) months immediately prior to the beginning of my local pageant (although I may have attended a college of university elsewhere).
8. I agree that if selected to participate in the **2010 MISS SK BAGUIO ® Pageant**, I will participate in the Pageant and will abide by all rules and regulations governing that Pageant.
10. I agree that if I win the title **2010 MISS SK BAGUIO ®**, then I will not participate in any pageants during the time that I hold, unless authorized in writing by the SK Baguio City Federation and Miss SK Baguio Organization.
11. I understand and agree that all issues as to eligibility shall be determined by the **2010 MISS SK BAGUIO ® Pageant**, and I agree to abide by that determination both as to myself and other applicants.
16. I understand that if I am selected as the winner, all decisions concerning my preparations for the pageant are to be made by the Brgy Pageant Director.
17. I agree that the site, date, time, production manner and method of judging of the state contests shall be solely within the direction of the Pageant Director and the decision of the judges shall be final.
18. I agree to abide by all the rules of the state and national contest.
19. I understand and agree that if I am selected as the winner, all decisions concerning production, promotions, photographs, program, appearances, and all other aspects of the **2010 MISS SK BAGUIO ®** Pageant as well as throughout my reign are solely at the discretion of the Brgy Pageant Director.
20. I further agree to permit my photograph, voice recording and name to be used without charge for all publicity and commercial purposes and telecasts of the citywide pageant.
21. I understand and agree that I am free to withdraw from the competition at any time, but under no circumstances will I be entitled to a refund or transfer to another contestant any fee, whether in full or in part, that I or my sponsors have paid. There will absolutely be no exception to this policy.
22. I agree that I will make no immoral acts whatsoever during my reign to protect image as Ambassador to the Youth. I understand and agree that doing so could result in the loss of my title and return of any and all prizes awarded.
23. I agree that I will not incur, and am not authorized to incur, any debts on behalf of the **2010 MISS SK BAGUIO ®** Pageant.

Failure of the winning contestant to comply with any of the terms, provisions, restrictions or obligations hereof shall at the option of SK Baguio Federation and Miss SK Baguio Organization and the Brgy Pageant Director shall result in entrant's disqualification, loss of title and return of any and all prizes awarded.
