<u>Important Reminders</u>

- All vehicles must be unloaded and removed from the market site by 8:15 and booths must be ready for the public by 8:30. No set up or take down of booth space and materials is allowed during market hours. This is for public safety and respect for fellow vendors.
- Produce must be clearly separated by producer if sold with a second certificate. All prices must be clearly marked.
- All produce must be listed on Producer's Certificate(s). Market Manager will ask you to remove any non-listed products immediately.
- Purveyors of a processed product such as: jams, dried fruits/herbs, oils, vinegars, etc. which are regulated under State, County, Health and Safety Codes must show proof you have complied with all requirements. All ingredients must be listed. For more information contact the Department of Environmental Health.
- A sales permit is required for all vendors of nursery products, cut flowers, etc. For more information contact State Board of Equalization.
- Even though we understand unforeseen circumstances may occur, you must notify the Market Manager at least 48 hours in advance of your commitment date in order to avoid an Assessment Fee upon return, and so that we may offer your space to another vendor.
- Please notify the Market Manager of any changes in your dates of commitment right away.
- Fees are due at the end of the market day and are based on booth size and location.
- The Winery hosts certain events like the Wine Adventure in July and the Harvest Festival in October, which will require us to set up in a different location at the winery. You will receive your assigned space from the Market Manager for those days on a first come first serve basis.
- Stall fees are \$10/\$12 for a 5' wide space, \$18/\$22 for 10' wide space (discount given to LCFF members). This optional LCFF membership will also get you featured on our website, inclusion in all promotional material, and a vote in all LCFF matters.
