I, WILLIAM EPPERSON of the County of Hawkins, State of Tennessee, being weak of body, but thanks be to God, of sound mind and memory, do make, constitute, and ordain this my last will and testament in the manner and form hereafter described, that is to say, my will and wish is that after my decease my Executors pay all my just debts, and further my wish is that he pay to my daughter HULDY. now HULDY BOYD, the sum of fifty cents and also pay to my daughter PHAMEY, now PHAMEY BEARD, fifty cents, also pay my son HOPSON EPPERSON fifty cents and also pay my daughter SINA, now SINA BRADSHAW, fifty cents and also pay to my daughter KASSIA, now KASSIA McCLEANE (McCANE), fifty cents and also pay to my son, STEPHEN EPPERSON, fifty cents, also pay to my daughter SUSANNAH, now SUSANNAH DICKARD, fifty cents, and for the many good services my daughter NANCY has rendered us, my

will and wish is that she have her cow, her wheel, her bed and furniture.
