There is a great response from the men there in treatment and they are asking the speakers to come more often. They need one year of sobriety. Tony will be going to Synergy next week and talk about this. Tonya M. is taking speakers to the women at Synergy. INTERGROUP. Mike H. announces that the next Intergroup is on Thursday, September 19 at 7PM. The next Unity Dinner is scheduled for November 16 and the specifics will soon be finalized. The hotline at the Central office has all slots filled at this time. Mike will be going to the Central office/Intergroup conference from September 25-30th. This will be the last conference he will attend as he plans to retire in May 2020. He works about 20 ½ hours per week. LITERATURE: Will M. went through the pamphlets that were left from the previous literature chair. There were about 60 different pamphlets which will be used to fill some of the current racks.
