Official Tax-Exempt Status: With the pro-bono assistance of Eric Oldenkamp and Alissa Shafer, student interns in the Legal Planning Clinic at the William Mitchell School of Law, our organization finished revising our Bylaws, submitted Articles of Incorporation to the State of Minnesota, and received tax-exempt (501(c)3) status. Citizens for Global Solutions, MN, is now an **independent affiliate** (rather than a Chapter) of the national CGS. The reason we changed our relationship is to ensure that our tax-exempt status will not be jeopardized by the political lobbying activities of the national organization. As a result, you can be assured that your membership dues and donations to CGS-MN will be tax-exempt. Former Board member June Parrott led this effort, pursuing a suggestion from our former CGS Secretary, Barbara Gerten.

Joseph Schwartzberg established "The Workable World Trust" to disseminate the ideas in his book, *Transforming the United Nations System: Designs for a Workable World* (2014). The first major event funded by the Trust will be a "Creating a Workable World" conference to be held October 9 and 10 in Cowles Auditorium in the Humphrey School of Public Affairs, University of Minnesota.
