- **All Emergencies - Dial 911**
 - a. All life threatening situations
 - b. All suspected crimes in progress (examples include, but not limited to)
 - i. Shots Fired/Shooting
 - ii. Robbery

- **Non-Emergencies - Dial 933-4444**
 - a. To speak to a tele-communicator and have the call recorded, press 9
 - b. When an officer is needed at the scene but the situation is **not life threatening**.
 - i. Loud Music
 - ii. Neighbor Troubles
 - c. To speak to a Communications Supervisor- 935-7472

- **District Notifications - 935-7232**
 - a. Non-emergencies when a squad is not needed (ie. Residence being vacant while on vacation and would like squads to check on the property)
