iPad IT Implementation Planning

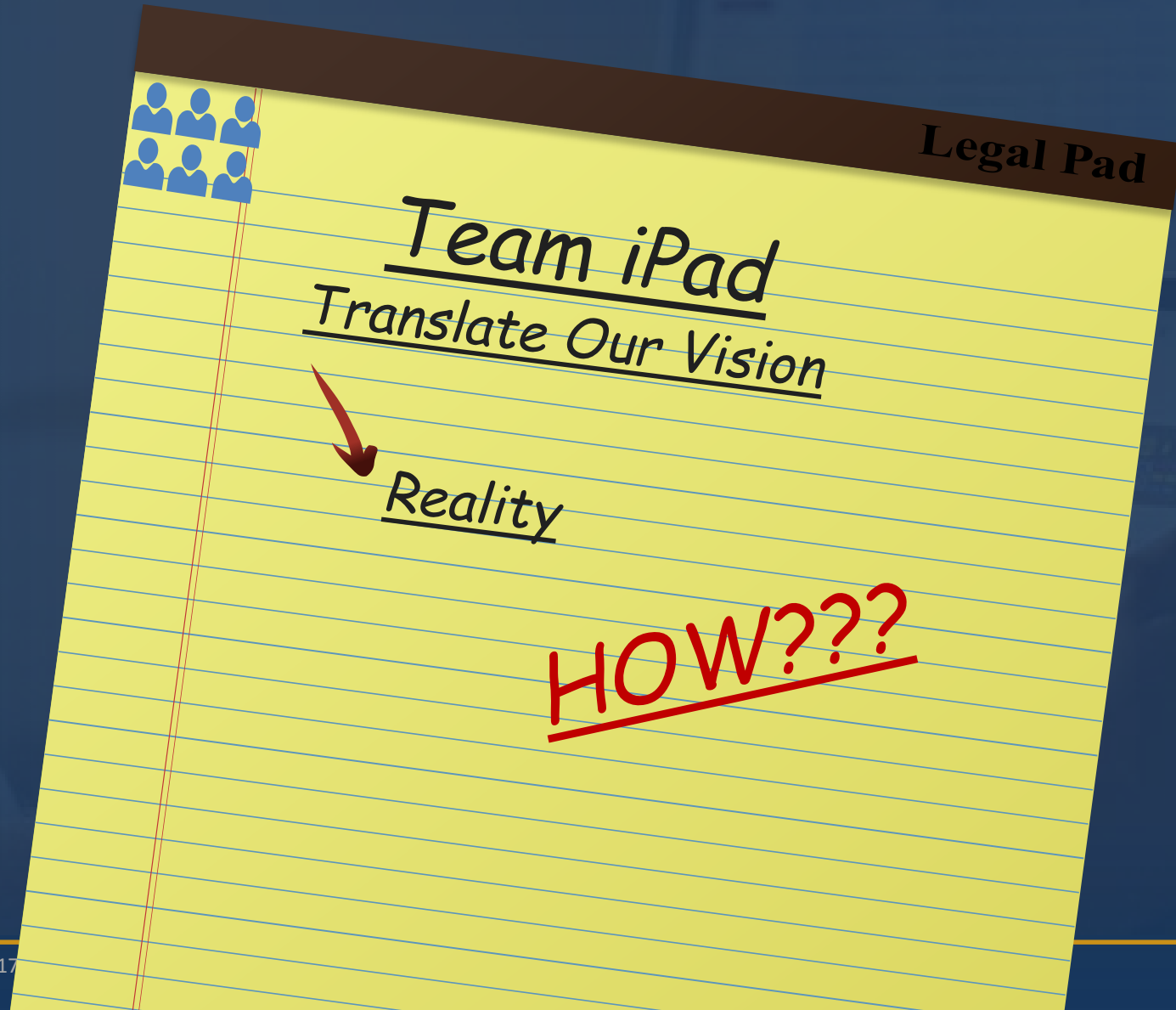
Mobile Device Management

- Centrally managed
 - Configure wirelessly
 - Wipe or Lock Devices
 - Monitor
 - Assign Apps, Bookmarks, settings, printing, etc. through "Smart Groups"
- Deploy agency restrictions and content
- Can use Staging Account to Sync with HR System

Don't restrict too much

Don't think users can set up their own iPads

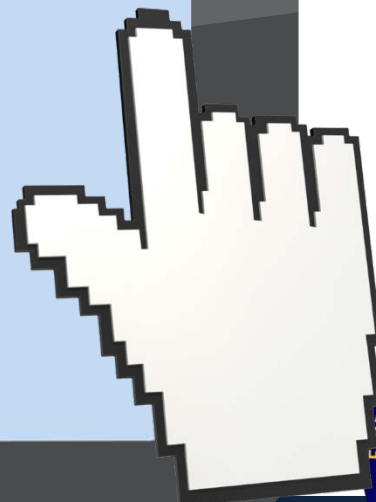
