

Roy Alden called the meeting to order in the church kitchen at 6:40 PM. Rev. Tim said a brief prayer. Roy decided to get right to business and Rev. Tim offered up the nomination of Josselyn Langworthy to attend as Lay member to the Annual Conference (June 11-13, 2020). The council moved to accept her nomination.

There was a very short discussion on the "Big Breakup" of the UMC which will probably happen in May. It is still not completely clear on how the details will emerge or how it will affect our church specifically as yet.

#### REPORTS SUBMITTED PRIOR TO MEETING

#### CLUSTER:

The meeting came to order at 9:20 am with the following in attendance. Victor Han, Sandra Bartley, HyungYong Choi, Tim Wilcox, Cheryl Stratton and Paula Lilley. Pastor Choi offered devotions using Genesis 39.

#### **Treasurer's Report**

Paula gave the treasurer's report. There is currently \$823.33 in the check book. \$400.28 was collected at the Cluster Thanksgiving service. That amount was dedicated to the Celebrating Families initiative. It was agreed to transfer the money for Celebrating Families to the Limestone Church to be dispersed from there when needed. A check for \$100 was given to the Cluster from the Presque Isle Pastors Discretionary fund for use by the cluster as needed.

#### **Thanksgiving Service**

The Thanksgiving service held in Presque Isle was deemed a success with good attendance. The Discipleship Award was well received. The service and fellowship time after were given positive ratings.

#### **Blue Christmas**

The Blue Christmas service received mixed review. It was a meaningful service with good music. However, attendance was very low. Tim is willing to help with the service again next year but we need to look at way to try to increase attendance.

#### **Gray Memorial Water Damage**

Pastor Tim reported that Gray Memorial is back worshiping in their sanctuary after the water damage. Much cleanup has been done but there is on-going work still in progress. He thanked all who came from various churches to help and for the many prayers.

#### **Festival of Trees**

Pastor Cheryl reported that the Festival of Trees was a great success again this year. \$105,000 was raised from the event. She received a thank you from the person who won the tree, a person with young family who loved all the gifts that were part of our tree. We were asked to participate again next year.

#### **Celebrating Families**

Pastor Cheryl showed a video from the Celebrating Families initiative. She has attended a collaborative meeting about the project.

Susan Collins' office is going to write a grant for the program.

Cheryl asked that a subgroup be formed in the cluster to work on Celebrating Families. Pastor Han volunteered. If there are others in the cluster who would be interested they may join the subgroup

More money needs to be raised for the initial training. Cheryl suggested the possibility of a golf tournament to raise some more funds. She would like the names of people who would be in a position to help with that event. A silent auction was also suggested to help with the funds.

She hopes that we can be in a position to bring the program here in early autumn. She will reach out soon to police departments and school counselors to let them know this program will become available.

#### **Pulpit Exchange**

January 19<sup>th</sup> is Christian Unity Sunday. It was suggested and accepted that we have a pulpit exchange on that Sunday. The 4 pastors present are all able to participate. Pastor Victor will send out an email to all cluster pastors to ask about participation. He will make the arrangement for the exchanges.

#### **Joys and Concerns**

Several joys and concerns were raised. Pastor Han offered prayers for those joys and concerns expressed. (End of Cluster Report)

#### UMM:

#### 1. Call to order and opening prayer:

- Meeting was called to order at 0830 by V.P. Louis Greenier. Members present were: Louis Greenier, Dave Belyea, Richard Clark, Bill Thomas, Dale Sharp, Neal Genz, Del Ramey, Ralph Ferguson, Bruce Fitzpatrick, Rev. Tim Wilcox, and Judson Drake. Opening Prayer was led by Richard Clark. One guest joined us – Robbie Irving.
- Meeting was adjourned at 0830 for Del's famous pancakes, ham, scrambled eggs, fruit, juice and coffee.
- 2. Program: After breakfast we reconvened at 0900 for our program presented by Robbie Irving, one of the owners of Irving Farms. Robbie is a 6th generation Irving in this farming operation. He gave us a short history of his family's farming activities beginning with the original settler John ca 1860. Today Robbie and his uncle Scott and Jeff raise 950 ac. of table stock potatoes for the fresh market as well as operate a fleet of 15 trucks and run a marketing business. He also talked about their high-tech high volume packing facility that can load over 6 trailer loads a day; and the new Caribou russet potato variety that is fast becoming one of their main varieties. A very interesting presentation of a very successful business in our back yard
- **3. Prelate's message:** Prelate Richard Clark read a passage from Luke Ch. 11, v. 5 7; and Mathew Ch. 22, vs 1-3 and 8-14. The message was about many are called few are chosen. He related his personal experience with a middle of the night call to come to church to help deal with flooding from the sprinkler failure.

#### 4. Old Business:

- Secretary's Report: the November 23rd meeting minutes were accepted as written.
- Treasurer's Report: not available. It was noted we spent \$ 150.00 for the kitchen stove and \$ 70.00 for the ladies breakfast. Checkbook balance as of today is \$ 806.91
- Discussed Christmas tree sales. Final results not in yet, but there are 60+ trees left unsold. A boy scout troop project will pick up the leftovers on Jan. 4<sup>th.</sup>
- Final results not in yet and deliver to the TCL mulch project
- The UMM sponsored the "Tree of Lights" and by December 22nd, a total of 136 bulbs for a total of \$670.00. These funds will help them with future UMM projects

#### 5. New Business:

- Speaker planned for next meeting will be Steve Wipperman, Maine Forest Service Arson Investigator Judson will contact him.
- Discussed our current funds balance. Consensus was we should look at a project or program to contribute some toward. It was noted that Gray Memorial is behind \$10,000 on our 2019 mission shares

#### 6. Other Business:

- Judson gave us a briefing on the insurance adjuster visit this week. Damage was well documented and reduced significantly by fast reaction of the Trustees, volunteers, and contractors!
- o Next meeting will be on January 25th.
- Meeting adjourned at 1040

SPRC: The SPRC held a regular monthly meeting on Thursday, January 9 with six members and Rev. Tim in attendance. Rev. Tim opened the meeting with prayer. Minutes were approved. A report of the church council adjustments to the SPRC budget lines was given. Liaison reports were made. The church school staff submitted issues with an attendance sheet placement and television placements, citing a lack of communication prior to placement of these items in the Sunday school rooms. Margaret Cyr attended to put forth to the committee her concerns about music availability for Sunday morning services, citing that she would like to be able to provide music however other commitments may interfere without much advance notice. Other music providers may not be available on or prepared on short notice for Sundays and therefore pre-recorded music may be necessary in the coming weeks and months. The committee then continued with a concern from the Worship committee about who is providing child care during Sunday services and the qualifications held by these persons. Not knowing when the last background checks had been done, the committee decided it was time again to run background checks on all staff members for whom checks are required. Rev. Tim reported that he would be away the week of the February school vacation so the committee is to locate someone to provide a sermon on February 16. He also reported on visits made, and on upcoming events including a pulpit exchange on Sunday, January 19 when he will preach in Hodgdon and Daniel Jackson from the United Parish Church in Fort Fairfield will preach at Gray Memorial.

MISSIONS & EVANGELISM: The Angel Tree gifts and monetary donations were picked-up the week before Christmas. Very grateful! Requested that next year we be given gift options for each child. The committee will also require people to sing for their "angel ornaments" next year as there were a couple tags not returned this year.

#### WORSHIP:

Our last meeting was on Friday, January 3, 2020. The following was discussed:

Mission Project donations, as well as all gift/monetary donations for the Angel Tree" were picked up by the School Point-of-Contact the week before Christmas. She was very grateful for the church's on-going support.

Asked for volunteers to meet on Thursday, January 9<sup>th</sup> at 10:00am to remove all the Advent decorations.

Blue Christmas Service on Monday, December 16<sup>th</sup> at the Caribou Assembly of God Church – poor attendance, but service was very uplifting

Christmas Eve Service – low attendance, but very nice service!

Richard Clark finished reading the book "How to Start a New Service" and passed it on to Diane Fitzpatrick; once she finishes, the group (Rev. Tim, Bobbi, Richard & Diane) will meet to discuss what to do next

Christmas plants – people can take them home

January 5 – Epiphany Sunday; children will add the final "characters" to the nativity scene (Wise Men)

January 12 – Baptism of the Lord Sunday; will move baptismal font to in front of the railing so people can dip their fingers in as a remembrance of their own baptism

January 19 – Human Relations Day; decided to ask Ruthann Weeks to speak briefly about the significance of the Caribou Ecumenical Food Pantry to the local communities that it serves; also announce that we will accept a free will offering on February 2<sup>nd</sup> – "Souper Bowl" Sunday that will be donated to the Food Pantry!

February 9 – Scouting Sunday; waiting for confirmation from Dave Belyea that Scouts will attend and participate in the service

February 26 – Ash Wednesday; Rev. Tim will have "Ashes on the Go" from 7-8:30am. Contact Aroostook Republican for an article? Claire – advertising? Alaina – Facebook post?

Rev. Tim was not able to record Advent Radio Spots this year due to the flooding incident at the church. Plan to do them leading up to Easter.

March 1 – Lent begins! Talked a little about March being Women's History Month – some ideas: significant women in the bible? Significant women in Methodism? Our church? Will discuss again in February.

#### April dates:

April 5 – Palm Sunday; April 6-10 – Holy Week Noon Services; April 12 – Easter Sunday (Neal Genz will contact Golf Course about a Sunrise Service)

Status of usher coordinators for 2020 – Neal has volunteers for Jan, Feb, Mar, Jun, Jul, Aug, Sep & Nov. Need volunteers for Apr, May, Oct, & Dec. Rev. Tim will make announcements during Worship Services.

We had a discussion about Child Care volunteers and this matter will be discussed with SPRC at their next meeting.

Margaret Cyr suggested we consider purchasing blue Advent paraments so we can switch them with the current purple ones some years.

Rev. Tim told us the Aroostook Cluster selected January 19<sup>th</sup> for a Pulpit Exchange.

Neal noted that he would bring up to UMM the possibility of having a Shrove Tuesday Pancake supper (Feb 25<sup>th</sup>). Next meeting – Friday, February 14<sup>th</sup> at 9:30am.

#### TRUSTEES:

Treasurer's Report: Judi passed out a copy of the treasurer's report and each item was noted with explanation/discussion on some of them. Judson indicated which bills paid would be covered by insurance. Del made a motion that the report be accepted, Tamara seconded. Passed. We have received \$650 from Grant Memorial to go toward restoration.

#### **OLD BUSINESS**

Judson read his letter to the trustees thanking them for their quick action in helping in the mop up of the recent "Christmas flood" and beginning the work that he has continued to finish via his Lazarus plan to physically get our church back to normal - and better.

<u>Emergency lighting</u>. The present emergency lighting in the fellowship hall stays on just long enough to allow church occupants to get out of the building, but not nearly long enough to allow for any activity. There are no emergency lights in the sanctuary. Judson will install larger batteries in the present lighting.

<u>Sprinkler malfunction.</u> Our insurance company, Church Insurance, will "go after" the sprinkler system for the malfunction. The system is new and had been inspected in 2019.

<u>Standard Operating Procedures (SOP)</u>. Judson will put three copies of an operation booklet throughout the church. He will have a prototype for the board to discuss at the next meeting. Example: what to do and who to call if the sprinkler system malfunctions.

<u>Upper Parking Lot.</u> The occupants of the apartment building across Prospect St. and their "visitors" are using the upper church parking lot. This makes it difficult for the lot to be plowed, and the Wilcox family and Judson are continually picking up garbage, some of which indicates illegal activity. Judson suggests that we have an additional sign(s) made: No parking after 9:00pm. Vehicle will be towed. The cost is about \$39.00 per sign. The police have been notified and will enforce. Beaulieu's will tow. The cost of retrieving a vehicle is \$50. A motion was made to purchase and put up signs by Louis, seconded by Wendy. Passed.

#### **NEW BUSINESS**

<u>Dry out.</u> The main body of the church is dry. The attic is dry.

Attic insulation. A 2" foam envelop barrier has been put down in the attic. The "denim" insulation discussed at last meeting proved to be too expensive. More insulation will be added tomorrow by Insulators Unlimited. They will also do an energy audit in the near future. There is no more snow in the valleys on the church roof. There is, however, ice on the parsonage roof. The insulation, or lack thereof, there needs to be addressed.

<u>Light boxes</u>. Underwood has put in insulated light boxes.

<u>LED lighting.</u> The first leg of the new lighting in the sanctuary has been completed. The lights in the ceiling are obviously brighter. The altar cross is so bright that Judson is sure the folks in the space station can see it – which should be a great comfort to them. He will install a dimmer.

<u>Breaker box and wall switches</u>. Both will be installed soon. (Underwood works in the church when they are not needed at the new school.) We have received an anonymous \$10,000 donation to help pay for the electrical work. The trustees may have to come up with \$1,000.

<u>Old wiring</u>. The tangle and mess of old wiring, some of which went nowhere, has been pulled out. Judson's Do Not Burn list has been completed.

<u>Church office copy machine.</u> The machine, donated by Bob Thompson, is about ten years old. The rollers have been replaced several times at considerable cost. Office Depot (aka Office Max) is the supplier and repair source. Judson is going to meet with them, looking at new machines and also at their leasing program.

<u>Parsonage range</u>. The parsonage range is malfunctioning. It is a Frigidaire manufactured by Whirlpool and sold by Lowe's. The repairman comes from Bangor. The range was donated by a parishioner. Price \$450. Judson suggested that if the repair is ½ or more of the price of the range that we look at purchasing a new range with a 10-year warranty. Del made the motion, Louis seconded. Passed.

<u>Ladies Powder Room</u>. The title of this bathroom-to-be was changed to the Upstairs Unisex Restroom. \$4,000 has been

received by an anonymous donor to make the storage closet by the library entrance into a restroom. Some of our parishioners have indicated that getting down the stairs to the restrooms near the fellowship hall is a problem.

<u>New cushions</u>. Also for the benefit of our older parishioners – new back and seat cushions in memory foam for the back two pews. (It was suggested that these be put in the front two pews.)

<u>Elevator</u>. The elevator continues to be cranky and sometimes non-functioning. Judson has visions of a new elevator – in the future.

Capital Campaign. Del and others on the board continue to be asked about the 10% tithe of the capital campaign money to be given to the Caribou Ecumenical Food Pantry. Some parishioners (and board members) are against it. This tithe was decided at the first leadership meeting with Bradley Call as a common practice during a capital campaign. The 18 members at that meeting (an open meeting) voted on giving to the Food Pantry. The problem is not especially the pantry being the recipient but that the tithe should not be part of the campaign. It was, however, indicated in the brochure passed out to all and in Will Barnum's presentation. Some, evidently, did not notice the 10% part of the campaign. The trustees did not come to a conclusion. It was noted that the campaign was successful without being "pushy." A suggestion that campaign monies received and progress in church repairs paid for with that money might be included in the church bulletin and/or newsletter.

<u>Sound studio.</u> Judson is looking ahead to the future and would like to build a state-of-the-art recording station in the balcony so that the Sunday service could be recorded and sent over radio to shut-ins. This might even be used for streaming to lap tops loaned to such homes. There has already been money promised for this project. It would not cost the church. An informal vote was taken and all trustees like the idea.

<u>Bells and chimes on tour.</u> Tamara asked for permission to take the bells and chimes to Newport Vermont the last Saturday in April. There was some discussion about insurance coverage. The instruments are covered. Louis made a motion that Tamara have that permission, Del seconded. Passed.

Council Chair Roy Alden suggested that Judson make a list of jobs and give a short presentation to the Congregation so that they will be in the loop.

Trustees are responsible for refreshments at fellowship hour on February 9th.
