LIMITED POWER OF ATTORNEY

This Power of Attorney shall remain in force and effect for the following period of time unless revoked earlier by me in writing: April 7th through 11th, 2016, and I agree and represent to those dealing with said attorney that this Power of Attorney may be voluntarily revoked only by revocation given the same general distribution as this original Power of Attorney.
