RULES

Current International Judo Federation Contest Rules as modified as follows:

- 1. Current IJF medical rules will apply with the exception that a competitor may ask for a doctor without losing the match; and a doctor may ask to examine a competitor without that competitor losing the match.
- 2. Co-ed competition will be allowed in this tournament for age 10 and under only if there are not enough participants to fill a division.
- 3. Junior competitors under the age of 13 (thirteen) will not be allowed to use strangulation techniques.
- 4. Junior competitors under the age of 17 (seventeen) and any novice competitors will not be allowed to use joint lock techniques.
- 5. Junior competitors (with the appropriate waivers signed) competing in a senior division will be allowed to use chokes and joint locks in the senior division, except for novices and anyone 15 years of age and under.
- 6. Except when a competitor is competing in more than one division, a 3 minute rest period will be required between back to back matches. When competing in more than one division, back to back matches not in the same division will not require a rest period.
- 7. Scoring will be double elimination, except scoring for 3-man brackets will be round robin. The winner may have lost once; all other contestants will have lost twice.
- 8. Judo Gi: The new judo gi sizing rules will not be enforced. Competitors must have a white gi. Blue gi is optional. Blue and white obis (belts) will be provided. White player wears a white gi and white obi. Blue player wears a white gi and blue obi or a blue gi.
- 9. Double knee drop morote seoinage will NOT be allowed.

Mat size complies with IJF and is 18x18 meters. The CARE system will be used by referees.

Weight Divisions:

WEIGHT CHALLENGE: Competitors are responsible for weighing in at their dojo under the supervision of the dojo instructor and providing accurate weight. There is no weigh-in at the tournament, however weights will be verified as needed. If a coach or official believes a competitor's weight and bracketing may create an unsafe condition, the competitor will be asked to verify weight. At the discretion of the tournament director, an inaccurate weight may disqualify the competitor.

JUNIOR DIVISIONS: Light, Medium, and Heavy categories are grouped utilizing the Junior National Standards not to exceed 10 pounds spread. Contestants will be matched first by sex, then by age group, then weight, then by rank. Age groups to be used are: 5-6 (U7), 7-8 (U9), 9-10 (U11), 11-12 (U13), 13-14 (U15), and 15-16 (U17).

A contestant that does not fit in the age/weight class will be dropped from competition or, with the appropriate waiver forms signed, moved up to the next higher age or weight group by the Tournament Director.

SENIOR WEIGHT DIVISIONS: Light, Medium, and Heavy. Contestants will be matched by weight, then by rank.

MASTERS: Competitors will be matched first by age, and then competitors will be matched by weight, then by rank. Age groups will be 35-40, 41-45, 46-50, 51 and up. Masters competitors may elect to play in a younger senior division, or may be moved to another age division if there are not enough competitors to fill a two person division.

MATCH TIME: Match time will be 3 minutes for all divisions.

The TEXAS MATCH system will be used to bracket competitors & operate the matches.

NOTICE TO ALL CLUBS

Routing of Tournament Documents

In order to make sure that tournament documents are not lost nor misplaced, please follow these instructions:

COMPETITION ENTRY FORMS AND WAIVERS: Check to be certain that all entry forms have been signed by the judoka (competitor) and their parents (when judoka is a minor). All waivers must be signed; failure to do so may result in elimination of the judoka from competition. Check to make sure that the correct amount of entry fees (\$20 for each competitor, and \$10 additional division per contestant) are included. Mail entry forms and fees TO ARRIVE NO LATER THAN Wednesday March 21, 2018, or hand deliver competitor information to the tournament director by 8:00 p.m., Wednesday March 21, 2018. All contestants will be required to provide verification of registration.
