<p><u>Child Day Centers (CDC)</u> Licensed Child Day Centers are child day programs offered to (i) two or more children under the age of 13 years in a facility that is not the residence of the provider or of any of the children in care or (ii) 13 or more children at any location. A child day program is a regularly operating service arrangement for children where, during the absence of a parent or guardian, a person or organization has agreed to assume responsibility for the supervision, protection and well-being of a child under the age of 13 years for less than a 24-hour period. http://www.dss.virginia.gov/facility/child_care/licensed/child_day_centers/</p>	<p><u>Licensed Family Day Homes (LFDH)</u> The Code of Virginia mandates the licensure of family day homes that provide care for five or more children (exclusive of the provider's own children and any children who reside in the home). The care may be offered in the home of the provider or in the home of any of the children in care. <p>What is your mission or purpose in starting a childcare service? What can you provide the children in your care? How do you want your business to operate? What is your budget and what costs can you expect to have? A business plan is important to develop and assists you in creating a structured and well thought out business model. This document in</p>	

turn will also assist you in developing a budget. If you do not know where to start, consider calling a counselor at the Small Business Development Center at (757) 664-2590 for assistance and training opportunities.

Talk to your City

Some city's ordinances are more stringent than the VA Department of Social Services regulatory status requirements. Make sure you contact your city to obtain specific information you will need to run a business within your city limits.

| <p>Contact your local Planning Department (or your local city department responsible for zoning) and find out if your home or ideal space is eligible under the zoning ordinance established by the city. If it is, inquire about any additional requirements you will need to meet— such as building requirements and conditional use permits. Most cities and counties will require you to obtain a Conditional Use Permit in order to operate your family day home and/or day care. This permit is used to determine whether a particular activity or use can be conducted in a particular zoning district based on zone ordinances and a public hearing. The Planning & Community Development Department may ask you to complete a Conditional Use Permit application when you first apply for zoning approval. Below you will find the contact information of your local department. *Keep in mind that zoning and use permits can take some time to process. Inquire about wait times when you call.</p> | <p>Know your building codes and regulations. The Virginia Uniform Statewide Building Code (USBC) establishes regulations applicable to all dwellings and structures, existing and newly constructed, to protect the health and safety of all individuals. Regardless of your desire to select a licensed or unlicensed facility for child care, the USBC provides minimum standards for the structure which may require permitting and inspections by the city. Gather a Team

Gather a team of qualified professionals to assist you in your start-up process. Utilize your banker, accountant, attorney, insurance agent, and a Small Business Development Counselor to assist you in your planning needs. If you do not have an attorney or insurance agent, shop around and find someone whom you can connect with and inquire about their services.

Consider Finances

Arrange Financing

If you have set up your business plan you are in a good place for determining what costs you will need to get started. Project what you will need and why, as well as, how you plan to pay it back. Consult with your banker about financing opportunities.

Set Up a Business Checking Account

It is important to keep your personal finances and business related finances separate. Visit your banker and set up a business checking account. All of your business income and expenses should go through this account.

Choose your Business Structure

Your legal entity varies and should be based on the type of business, the goals of the business, and your personal finances. In this step it is important to arrange a meeting with your attorney and/or accountant to assist you in determining what business structure will work best for your company. Before attending the meeting you can familiarize yourself with the different business structures at the State Corporation Commission website (<http://www.scc.virginia.gov/clk/begin.aspx>).

Register and File your Business Name

First, find out if your business name of choice is available through the State Corporation Commission (SCC) via <https://sccefile.scc.virginia.gov/NameAvailability>. The name that you choose for your business must be available through the SCC. Your next step is to utilize the Virginia Online Business Registration at <https://bosapp.cyberdatainc.com/bos/> to register your Family Day Home or Childcare Center by viewing their resources and then clicking the Start button. It is recommended that you consult with a tax professional and/or attorney when determining your corporate structure.

Tax Registration

Federal Tax Registration

Gaining an Employer Identification Number (EIN) through the Federal Government is the first step in setting up your taxes. An EIN is used in connection with your business activities. You will provide this nine-digit EIN on all forms sent to IRS or Social Security Administration. Forms at the state and local level will also request your EIN number. Applying through the IRS is free for applicants. State Tax Registration

If you plan to conduct business in the State of Virginia, it is required that you register your business with the Virginia Department of Taxation (TAX). In order to fully complete the form you will need to know your company's business entity and EIN.

Also known as trade names, any name for a business being conducted by persons or corporations that is not their own must be registered with the city. If you are a Sole Proprietor who is not registered with the SCC it is extremely important to register with the City. To register your business name with your city/county, contact your local Commissioner of the Revenue office.			A Business License is a document obtained by an individual that allows them to conduct business in a particular city. To obtain a business license or gather more information, visit your city or county's Commissioner of the Revenue web page or contact their office.

Meet Employer Requirements

Before hiring your first employee you must be aware of the documents and requirements of employment. If you have never hired an employee before consider taking a few minutes to read the U.S. Small Business Administration’s (SBA) *10 Steps to Hiring Your First Employee*. Determine Insurance Needs

Be sure to consider insurance needs like workers’ compensation, unemployment, property, childcare, liability, automobile insurance, etc. Set up a meeting to connect with your insurance provider and discuss your risk potential and look into additional coverage options for your business. You can also learn more about insurance by visiting <http://www.sba.gov/content/business-insurance>.

Note that unemployment insurance tax and worker’s compensation insurance are extremely important if you have employees or plan on having them in the near future. Virginia Law requires every employer who regularly employs three or more full-time or part-time employees to purchase and maintain workers’ compensation insurance. If you have less than three employees, you may voluntarily come under the Workers Compensation Act.

Register to work with the Department of Social Services

Any Child Care business that would like to accept Department of Social Services Subsidy Funds should apply by visiting, http://www.dss.virginia.gov/family/cc/assistance_providers.cgi. Once your application has been received, it will be assigned to the appropriate agency for review and processing. The last steps include an on-site inspection and vendor approval.
