## Requirements for application:

- -Any girl who will be a sophomore, Junior, or Senior in a Gillespie County High School during the 2016-2017 school year.
- -Any girl who was enrolled in a Gillespie County High School during the 2015-2016 school year.
- -Any girl that is not/ nor has ever been married or have a child is eligible to run for Peach Queen.
- -You must provide written consent from your parents/guardians to participate in the contest and for possible photographs throughout the year.
- -To be eligible, applicants cannot have been charged with any misdemeanor/felony charges (excluding traffic violations).

## Requirements for year of reign:

- -You must reside with your parents/legal guardian during the year of your reign.
- -You will be required to ride the float in various parades around the Hill Country, **if you miss more than 3 parades (without consent from the board) you will be asked to resign and forfeit your title, crown, and scholarship**. A dress to be worn on the float will be provided for you by the Stonewall Chamber of Commerce.
- -You may be asked to help out with the county stock show and other various community events. You are expected to attend these events to represent the Stonewall Peach JAMboree.
- -If you become pregnant or get married during your year of reign you will be asked to resign and you forfeit your title, crown, and scholarship.
- -If a member of the court is not able to complete the year of reign you agree that you will forfeit your title, crown, and scholarship.
- -Scholarships must be accepted/awarded within 24 months of the end of reign in order to be honored. Proof of registration or receipts from the college of your choice must be presented to the Stonewall Chamber of Commerce before funds are released. The check will be made payable to you and the college.

- -You must stay in school during your year of reign and maintain a minimum grade average of 75. If you drop out of school you will be asked to resign and forfeit your title, crown, and scholarship. Home schooling will be considered on a case-by-case basis and is subject to a vote by the Board of Directors.
- -The Peach Court must agree not to enter any contests or activities that will interfere with your year of reign. (i.e. Fair Queen, Farm Bureau court etc.)
- -While you are wearing your sash and crown you are representing Stonewall and the peach industry, therefore the following behavior will not be tolerated:
- 1. M.I.P.-if you are charged with a MIP (minor in possession) regardless of the circumstance at **any** time during your reign you will be required to resign and forfeit your title, crown, and scholarship.
- 2. Foul language, rude behavior, disrespect to other organizations, and/or consumption of drugs/alcohol while on the float or while representing Stonewall is cause for resignation and you will be required to forfeit your title, crown, and scholarship.
