This form is designed to identify a wide range of behavior problems in children. Please complete this form by placing a check mark next to each statement.

- Is often easily distracted by extraneous stimuli
- Often does not seem to listen when spoken to directly
- Often fails to give close attention to details or makes careless mistakes in schoolwork, work, or other activities
- Often does not follow through on instructions and fails to finish schoolwork, chores, or duties, in the workplace (not due to oppositional behavior or failure to understand instruction)
- Often has difficulty sustaining in tasks or play activities
- Often loses things necessary for tasks or activities (e.g., toys, school assignments, pencils, books, or tools)
- Often avoids, dislikes, or is reluctant to engage in tasks that require sustained mental effort (such as schoolwork or homework)
- Often has difficulty organizing tasks and activities
- Is often forgetful in daily activities
- Often swears or uses obscene language
  
- Often interrupts or intrudes on other (e.g., butts into conversations or games)
- Often talks excessively
- Often fidgets with hands or feet or squirms in seat
- Often blurts out answers before question have been completed
- Often engages in physically dangerous activities without considering possible consequences (not for the purpose of thrill-seeking), e.g., runs into street without looking
- Often shifts from one uncompleted activity to another
- Often has difficulty playing or engaging in leisure activities quietly
- Often leaves seat in classroom or in other situation in which remaining seated is expected
- Often has difficulty awaiting turn
- Is often "on the go" or often acts as if "driven by a motor"
- Often runs about or climbs excessively in situation in which it is inappropriate (in adolescents adults, may be limited to subjective feeling or restlessness)

- Often argues with adults
- Is often spiteful or vindictive
- Often blames other for his or her mistakes or misbehavior
- Is often angry and resentful
- Is often touchy or easily annoyed by other
- Often loses temper
- Often deliberately annoys people
- Often appears sad or unhappy
- Often complains of headache or other physical symptoms
- Has shown self destructive tendencies
- Has trouble sleeping

Has run away from home overnight at least twice while living in parental or parental surrogate home (or once without returning for a lengthy period)

- Often lies to obtain goods for favors to avoid obligations (i.e. "cons" others)
- Often initiates physical fights with other members of his or her household
- Has been physically cruel to people

Has stolen items of nontrivial value without confronting a victim (e.g., shoplifting, but without the breaking and entering forgery)

- Often truant from school, beginning before age 13 years
- Has deliberately destroyed others property (others than by fire setting)
- Often initiates physical fight with others who do not live in his or her household (e.g., peers at school or in the neighborhood)

- Has forced someone into sexual activity
- Often bullies, threatens, or intimidates others
- Has been physically cruel to animals
- Often stays out at night despite parental prohibitions beginning before age of 13
- Has stolen while confronting a victim (e.g., mugging, purse snatching, extortion, armed robbery)

- Has deliberately engaged in fire setting with the intention of causing serious damage
- Has broken into someone else's house, building, or car
- Has used a weapon that can cause serious physical harm to others (e.g., a bat, brick, Broken, bottle, knife, gun)
