This year, 2016, I had the most amazing experience in my life with God and I have to recognize if I hadn't been in prison I wouldn't have this experience.

I was at MDC and during our "free-cell time" in the afternoon I was talking with another inmate about Jesus Christ and the mercy of our Lord when He sent Jesus to die for our sins. It was around 6 PM when I came back to my cell when my cellmate told me that someone had brought something for me. It was a Ramen soup for which I wanted to eat for two weeks. When I asked him who brought it he told me this way: "He was a guy taller than you,

dressed in orange (like us), long hair covering until his arms, white face, a peaceful face, hair between brown and black, and gave a message for you. Give it to Juan, tell him to have hope and keep believing in me." After this he just left the cell and I didn't see him anymore. I've never seen him before. I was in shock when he told me this, because only three persons knew my name, my cellmate, other friend who was locked down at that time and the inmate I was talking to. I knew immediately that I had received a visit of Jesus or his angel because nobody could know where I was, who I was and what I needed. I started to cry and thank the Lord for looking after me.

About one hour later I left my cell again for medication and looked for anyone with the features my cellmate told me about, the person who gave the message, but I didn't find anyone. I asked my cellmate if he had put the soup on my bed and he told me he didn't have money. That was true because I shared my food with him.

This experience is now the promise that God gave me, and I am sure He will give me the final victory solely because He has a great plan for my life and my family. Thank God for this amazing gift You gave me. Juan Torres, La Pasada

## Colorado Registration Statute Under Attack

This is great news for those that have hope that our courts will actually consider whether or not sex offender registration constitutes punishment. It appears that senior U.S. District Judge Richard Matsch may be just the judge for the situation. On July 7th Judge Matsch denied Colorado's effort to avoid a trial on the merits of the complaint.

Three plaintiffs initiated the case by filing a complaint with the assistance of an attorney located in Boulder, Colorado. The first plaintiff was convicted in 1999 and was sentenced to 74 days on work release followed by eight years' probation. The second plaintiff was convicted in 2007 for conduct that occurred in 2005 when he was eighteen years old. The third plaintiff was adjudicated as a juvenile offender for conduct that occurred when he was only thirteen years old. The plaintiffs assert in their complaint that "... continuing to register and complying with the restrictions applicable to them under the Act and regulations violate the protections afforded by the Eighth and Fourteenth Amendments to the United States Constitution."

The Defendant, Colorado Bureau of Investigation (CBI), moved for "Summary Judgment of Dismissal based on well-established case authority that statutes like Colorado SORA are not punitive." CBI, like most other defendants, cited other cases including *Smith v Doe*, 538 U.S. 84 (2003) for their assertion that sex offender registration is not punitive. Order Denying Defendant's Motion for Summary Judgment at pg. 2. CBI also contends, "Plaintiffs have not shown such adverse effects on themselves as to support a finding of punishment." *Id* at 7. Judge Matsch concluded that this is a mixed question of fact and law and that there are issues of fact that should be determined through a trial with the full opportunity to present evidence that may include more than has been explored in the discovery done thus far. One plaintiff presented evidence that he has experienced harassment and vigilantism as a result of being on the sex offender registry. One plaintiff showed that he has been prohibited from entering Denver Public Schools property because of his status on the registry. One plaintiff presented evidence that he was terminated from employment due to his status on the registry.

The plaintiff adjudicated for conduct that occurred when he was thirteen years old has petitioned twice for removal pursuant to C.R.S. 16-22-1113(1)(e). His petition was denied in 2006 and again in 2012. Judge Matsch's interest has focused on the process that resulted in the denial of the petition. Judge Matsch noted that the statute requires the court to consider "...whether the person is likely to commit a subsequent offense of or involving unlawful sexual behavior." Judge Matsch noted that neither magistrate made a finding that the plaintiff was likely to commit a subsequent offense involving sexual behavior. Rather, the magistrates put the burden on the plaintiff to show by a preponderance of the evidence that he was not likely to commit such an offense. This burden shifting placed an impossible burden on the plaintiff to prove a negative. Judge Matsch also noted that the magistrates had imposed additional conditions not contained in the statute, which may be a violation of due process.

RSOL is excited that this case is pending, and we are in communication with the attorney in terms of offering any assistance we can provide. It could be that RSOL agrees to raise funds if expert witnesses are needed for trial. We will keep you posted as the case progresses to trial and any subsequent appeals that are almost certain should Colorado lose.

## Alice's Editorial

We are five days into Don's recovery from bariatric surgery and he is doing well losing about 3 pounds a day. Before long he will be a shadow of his former self! He appreciates all the good blessings from friends. We appreciate all the backing we get from our friends for this ministry. We do need MORE FUNDING to keep on doing what we have been called to do. Let me recount a story my daughter sent me from the NEW YORK TIMES. His name is Matthew Grottalio and the tragic story of his life began when he and a brother decided to play a "touching game" with their 8-year-old sister. The sister's teacher found out, notified authorities, police handcuffed Matthew outside his 5<sup>th</sup> grade classroom. The result: 2 years probation, a foster home, listing on the Texas sex offender registry website, his parents' marriage was shattered. Matthew dropped out of school, "hated life and hated everybody."

He ran away, was homeless for two years, sank into drugs and served time for burglary and parole violations. He was barred from contacts with people under 17 including his sister, now an adult. He was barred from the children of the woman he married and until he passed an evaluation, even from his own baby. In conclusion there are 24,000 registered juvenile offenders and one third of those are under 14. Churches, you have a real challenge before you. Before you check the local SO registry to identify your new church attenders, keep these statistics in mind. The names you find could be the kids your kids grew up with. The names you find could be former inmates who found Christ in prison and who are looking for your encouragement. Some of these people could well be those responding to your church outreach. Keep in mind Jesus has been in prison with them. Matthew 25:35—40.
