The word desert it brings to mind lifeless blowing sand, extreme heat from a glaring sun, and harsh living conditions for any form of life. It is a place of exile, loneliness, and seclusion that nobody desires to experience. Yet, for me, it best describes where I found

myself after going through a personal crisis. I currently live in southwestern New Mexico on the Chihuahua Desert and it is here that I began realizing the similarity between what I see around me and what I have experienced in life. Disappointments have withered away my hopes along with the unforgiving winds of criticism that have

driven my dreams into dry lifeless sand. Then this spring I saw the cactus blooming and started to look for the times in my life that would bring back the inspiration to help me thrive among the harsh conditions of being a registered sex offender.

I grew up when hard work and diligent effort was rewarded with success. Slowly those ideals vanished as I entered the corporate world and experienced the reality of office politics. The harder I worked the less my efforts were recognized and the more management

expected from me. At one performance review I was told that my excellent work could not be replaced and I was denied a promotion. I changed jobs several times hoping to find a vocation that would live up to my expectations only to get older and



never advance past an entry level position. With the weight of providing for a wife and two girls I started working two jobs. I even tried to start a business but that failed, too.

There were other disappointments that undermined my sense of self worth. At a young age I began playing the guitar and singing. At first it was a past-time, but as I got older the desire to entertain became a passionate desire. I never considered myself good enough to become a rock star but

good enough to entertain a crowd. This obsessive-compulsive behavior became the focus of a divorce along with my failure to advance up the corporate ladder. Finally, I snapped at mid-life disillusioned with success in any profession and deprived of

fulfilling my inward yearnings.

That was when the desert of my life began. The landscape of employment yielded little to nothing. My dreams of a fulfilling career evaporated with the rise of the sun. I'd grasp at any relationship that might give me a drop of refreshment. Each glimmer of hope for achievement became an oasis in the distance that was al-

ways out of reach. I'd sacrifice the what I believed in for so many years to relieve my burning desire for pleasure. I developed a taste for unacceptable behavior as means to provide my needs. Places I had always considered disgusting and had avoided became my habitual den and hideaway. Through bad choices and unfortunate circumstances this path ended in a three-year prison sentence.

## **Enough For Today—by Greg Laurie**

"So don't worry about tomorrow, for tomorrow will bring its own worries. Today's trouble is enough for today."

- Matthew 6:34

Have you ever been gripped by fear? You know the feeling. Your blood goes cold. You get that shiver down your spine. Your hair stands on end. (In my case, that is singular, not plural.) Your stomach sinks. Your mouth goes dry.

Then there is the other emotion that is often coupled with fear, and that is worry. There are a lot of things people can worry about today. The state of our country. Our economy. Terrorism. The threat of a war. We are a nation filled with worry.

But there is nothing productive about it. In fact, the word worry comes from an old German word that means "to choke" or "to strangle." And that is exactly what worry does. It chokes you



spiritually. It creates an emotional and mental stranglehold on your life. It doesn't ever make anything better. In fact, it makes things worse. That is why Jesus said in the Sermon on the Mount, "Don't worry about tomorrow, for tomorrow will bring its own worries.

Today's trouble is enough for today" (Matthew 6:34).

Paul tackled this problem in Philippians 4 when he wrote, "Don't worry about anything; instead, pray about everything. Tell God what you need, and thank him for all he has done" (verse 6). Where was Paul when he wrote those words? He was incarcerated in Rome. He didn't know what was going to happen to him. So there was Paul in a difficult situation, and what did he say? "Don't worry about anything; instead, pray about everything."

What happens with worry is that our hopes pull us in one direction while our fears pull us in another. When you worry about the future, you cripple yourself in the present. Worrying does not empty tomorrow of its sorrow; it empties today of its strength.

### **Blossoms in the Desert**

Starting life after prison was no easy task and the landscape for survival was very hostile at best. The parole agreement required me to pay for housing, find a job, and stay alcohol and drug free for six months. I was court ordered to complete parole in the town where I was convicted. These circumstances created an environment so overwhelming and bleak it was almost impossible to exist. My mother and sister, along with a close friend of the family, gave the support I needed to endure the desolate terrain of parole. Within eight weeks I was working and after six months successfully completed all of the requirements.

Having survived the barren waste land of prison and parole I started a new life. I relocated to a different setting, started to perform professionally and eventually remarried. With the support of my wife I was able to return to a responsible life, develop my talents, and flourish as never before. Now, I believe in myself and have realized that life has more than hills and valleys in a desert... it has promise and hope.

This last spring my wife and I explored the Chihuahua Desert along the foothills of the Florida Mountains near our home. An early rain had given the area a rebirth from months of drought. When we stopped to take some pictures I began to smell the fragrance of the flowers blooming everywhere. The barrel cactus were glowing with bright yellow and orange. The normally lifeless drab ocotillo were now full of green leaves and topped with brilliant red blossoms. The yucca had

sprouted shafts eight feet into the sky and boasted clusters of white and yellow flowers at their tops. Everywhere there was life anew. Grass was growing amidst the dead remnants of winter. Rabbits sprang up ahead of us and dashed around creosote bushes releasing the sweet smell of colitas. Suddenly I realized that what I was witnessing was exactly what I was experiencing in life. Although the surroundings were bleak with despair, in the midst of hostile conditions there was the hope for new beginnings. The Lord who provided refreshing rain for the desert had provided the needed support and care for me to have a fulfilling life. My past life, as thorny as the barrel cactus, can now be as fragrant as the blossoms in the desert."

### SEX OFFENDING AND CHURCHES
