The following agreement is between _____, hereafter referred to as "Breeder" and _____, hereafter referred to as "Buyer" for the sale and purchase of one purebred dog of the FRENCH BULLDOG breed.

Will become the property of the Buyer in flesh as well as title upon the fulfillment of the following conditions:

Purchase price of \$ _____ paid by the Buyer to the Breeder. A deposit of \$400 (non-refundable) has been made on (date) _____, and the puppy will be held until (date) _____. At that time the balance of the purchase price \$ _____ must be paid in full in either a lump sum or through payments received before pickup date or the non-refundable deposit is forfeited and alternate arrangements will be made for the placement of the puppy.

* Breeder guarantees that the above puppy is a purebred and registered with the American Kennel Club (AKC)

* Breeder cannot guarantee adult size, color, hair coat, temperament or trainability of puppy.

HEALTH AND HEALTH GUARANTEE

All precautions have been made to insure that this puppy is in excellent health at the time of purchase. Buyer needs to be aware that a puppy is a baby and that sometimes he/she may get sick due to stress or other related reasons. He/She is leaving our home and entering a new environment and stress related sicknesses may occur. Breeder does not assume any liability for any injury, or neglect to this puppy after pickup. It is the Buyers responsibility to prevent illness and injury by providing necessary booster vaccinations, veterinary care, nutrition, fresh water, shelter and supervision. The breeder has made every effort to breed healthy dogs and has raised this puppy to the best of her ability.

*This puppy is guaranteed until 6 months of age against fatal genetic and fatal congenital defects. If medical attention is required, the buyer will be responsible for all costs. The Breeder will provide a

replacement puppy of equivalent value and sex as soon as availability permits within a year. The Breeder reserves the right to choose the replacement puppy. Buyer is responsible for the total transportation cost of the replacement puppy.

* If the puppy dies before 6 months of age, the buyer will pay to have it autopsied. If the cause of death is congenital, or genetic, the breeder will replace the puppy.

*This guarantee does not cover what in the bulldog breed is considered common: Cherry eye entropion, loose hips, skin allergies, elongated soft palate, and stenotic nares (collapsed nostrils)

* All items covered under this guarantee are by replacement only. *We do not give cash refunds.*

* The Breeder will not be responsible for any medical expenses incurred. Buyer is aware owning a puppy means trips to the veterinarian, and understands that he/she will be responsible for all payments.

* As of the date of delivery, the puppy has received proper vaccinations and deworming due appropriate for its age.

* This guarantee does not include Coccidia, Giardia, and Kennel cough, which can occur in puppies that are shipped and is usually caused by bacteria.

*A puppy that has any fatal genetic or fatal congenital defect will be replaced as follows: Animal must show the defect by 6 months of age. The Breeder must be notified of the problem within two business days of the first licensed veterinarian determination. You must have two reports from two unassociated veterinarians stating the same problem. The Breeder will provide a replacement puppy of equivalent value and sex as soon as availability permits within a year. It is understood that the puppy may not be from the Original Parents. The Breeder reserves the right to choose the replacement puppy. Buyer is responsible for the total transportation cost of the replacement puppy.

*A puppy with a defect must be returned or euthanized with the prior permission of the Breeder and at the cost of the buyer, to qualify for a replacement puppy.

* If a puppy must be returned to Breeder, it must be in good condition. Other than the specified problem, at the expense of the buyer. The owner will then qualify for a replacement puppy.

*There are certain disorders ie.. allergies, food allergies, thyroid dysfunction, demodectic mange, and other autoimmune disorders, intestinal bowel disease, irritable bowel syndrome not covered by this guarantee.

* Any physical problem which is or could be the result of injury and is not present in genetic lineage ie.. subluxation of a patella, subluxation of a hip, over exercise or an overweight dog is not covered by this guarantee.

* This contract is null and void if the terms and conditions are not fulfilled. This contract supersedes any previous agreements.

REGISTRATION

The Buyer agrees to register the puppy with AKC within 60 days of receiving the AKC registration papers via mail or online and that this transfer will be recorded in the name of the party listed on this contract. The buyer also agrees that this puppy will carry the kennel name "Gitane" somewhere in the puppy's registered name. The puppy will be sold with limited registration unless otherwise agreed upon. Limited registration means no breeding rights and the puppy must be spayed/neutered by 12 months of age.

"SHOW QUALITY" DOGS

The Breeders will use their best judgment and the advice of other fanciers in evaluating the puppies as to show or pet quality. There is no guarantee that a puppy evaluated as "Show Quality" will be successful in the show ring as an adult and no warranties are made to that effect.

OWNERSHIP RESPONSIBILITIES

The Buyer agrees to maintain the puppy in a humane environment and properly train and care (quality food, water, shelter and veterinarian care) for the entire life of the dog. Specifically, the dog will be properly licensed and inoculated against rabies, distemper, parvovirus, and other communicable diseases as recommended by a qualified veterinarian. The dog will not be allowed to roam or stay as an outside dog 100% of the time, and will be socialized and obedience trained appropriately

RIGHT OF RECOVERY/PLACEMENT

If, for whatever reason, the Buyer cannot or does not wish to maintain custody of the dog (at any time during its lifetime) the Breeder is to be notified immediately of such case. The dog is NOT to be sold or placed anywhere without written consent from the Breeder. The Breeder will help assist in any placements of said dog/puppy. The Breeder will always accept the dog/puppy back at no cost to the Buyer. The Breeder wishes to make sure that this dog is well cared for and placed in a proper environment for its whole lifespan.

VIOLATION OF CONTACT

Violations of the terms of this contract renders all guarantees stipulated in this contract to be null and void. In the event this contract and the parties involved have to be taken to court Buyer is responsible for all court costs.
