And if that's not enough intrigue for the morning, listen to **Bob Casey** (photo below), **Special Agent in Charge of the Federal**



**Bureau of Investigations**, talk about current efforts of the FBI—what is being done to make this country safe after 911? How real are the threats we keep hearing about—such as, "Officials think America could face another attack within the next six months"? How did the government divert the possible bombing of the Fountain Place building in downtown Dallas? What happened at Fort Hood that allowed a terrorist to infiltrate the ranks of the military? Ask these two outstanding Federal officials questions about things that have been on your mind.

**James L. Capra**, a native of New York, received his BS from Marist College and MA in Education from Seton Hall University. Prior to his law enforcement career, he served in the U. S. Navy, U. S. Navy Reserve, Air National Guard and as a Military Intelligence Officer with the U. S. Army Reserve.

Mr. Capra began his federal law enforcement career with the DEA in 1987. He held various field

## Legislative Update

One year into the first term of the Obama administration, and we find ourselves still waiting for the promised "Change." The only change we have seen so far has been an insurmountable increase to our national debt, closed door, non-transparent negotiations on radical changes to our health care system, and an attempt to bring to trial a known terrorist in a civilian federal court in the heart of New York City.

President Obama released the \$3.8 trillion budget for fiscal year 2011. Despite promises of a spending freeze, we see a \$1.56 trillion deficit. In addition, it raises taxes \$2 trillion per year across a wide spectrum, including small businesses and families making under \$250,000 per year. The budget also calls for a \$870 billion national energy tax. The health care reform bill passed both the House and Senate chambers, and reports say that House and Senate Democratic leadership will forge ahead. With the election of Massachusetts Senator Scott Brown, the Senate loses the Democratic majority and they must rework their strategy. The most likely scenario would be the House passing the Senate bill and both chambers then passing a separate budget reconciliation bill – requires only 51 votes to pass the Senate – then modifying the Senate bill to address House concerns with the legislation. The appointed conference committee has sent their version of the bill to the Congressional Budget Office (CBO) where they will measure the cost of the legislation. The current objective is to get the cost under the magic number of \$900 billion, but there has been no real movement from the scoring office.

On the state level, Lieutenant Governor David Dewhurst has issued the Senate Interim Charges for the Texas Senate in 2010. Key priorities are focused on job creation and health care reform within the state of Texas. Speaker Straus announced a House Select Committee on Federal Legislation on January 12. This special committee will be charged with improving communication and exchange of information between Washington D.C., and Texas. They will concentrate their efforts on reviewing pending legislation and evaluating the impact of such bills on the economy

and citizens of our state. A special emphasis will be put on the current health care reform legislation. Representative John Zerwas (R-Richmond) was appointed as chair of the committee and Representative Garnet Coleman (D-Houston) will serve as vice chair. Committee members include: **Dan Branch (R-Dallas)**, Warren Chisum (R-Pampa), Ellen Cohen (D-Houston), Donna Howard (D-Austin), Susan King (R-Abilene), Lois Kolkhorst (R-Brenham), Trey Martinez Fischer (D-San

## Five Ballot Propositions to be on March 2 Primary Ballot

At the December 5 General Meeting of the State Republican Executive Committee in Austin, five propositions were approved to be added to the March 2, 2010 Republican Primary ballot. They were approved by the State Resolutions Committee, then unanimously and individually by the SREC.

The propositions are non-binding; they **determine how the electorate feels on certain issues**. Overwhelming support for a proposition **may lead to legislation being introduced in the future**.

Please read the propositions below, and remember to vote on them on March 2. They will be at the end of the ballot following all the candidate races.

**Proposition #1: Photo ID:** The Texas Legislature should make it a priority to protect the integrity of our election process by enacting legislation that requires voters to provide valid photo identification in order to cast a ballot in any and all elections conducted in the State of Texas. ( ) YES ( ) NO

**Proposition #2: Controlling Government Growth** Every government body in Texas should be required to limit any annual increase in its budget and spending to the combined increase of population and inflation unless it first gets voter approval to exceed the allowed annual growth or in the case of an official emergency. ( ) YES ( ) NO

**Proposition #3: Cutting Federal Income Taxes** In addition to aggressively eliminating irresponsible federal spending, Congress should empower American citizens to stimulate the economy by Congress cutting federal income taxes for all federal taxpayers, rather than spending hundreds of billions of dollars on so-called "federal economic stimulus." ( ) YES ( ) NO

**Proposition #4: Public Acknowledgement of God** The use of the word "God," prayers, and the Ten Commandments should be allowed at public gatherings and public educational institutions, as well as be permitted on government buildings and property. ( ) YES ( ) NO

**Proposition #5: Sonograms:** The Texas Legislature should enact legislation requiring a sonogram to be performed and shown to each mother about to undergo a medically unnecessary, elective abortion. ( ) YES ( ) NO

## Report from Massachusetts

As a judicial candidate, I receive a myriad of emails each day concerning Republican and community meeting and events. One of those was very different. It was from **Jonathan Neerman**. The subject line: Urgent Attorney Help Needed in Mass. Senate Race. I opened it to learn that the Scott Brown Campaign would deploy lawyers to help with ballot security in key precincts. I volunteered to serve and began a journey of excitement and enlightenment. From the time of the initial email on Thursday, January 14, there was a steady stream of confirmations, updates and training materials. We received the Memorandum to Local Election Officials issued by William Francis Galvin, Secretary of the Commonwealth of Massachusetts. It contained an overview of the election process and laws. On Monday evening, we arrived in Boston and received our Election Day credentials. Next, we were briefed in a conference call about our assignments. The Lawyers for Scott Brown Election Day Operation had two stated goals: Assure that every vote is counted and that no voter is disenfranchised by error or fraud. My initial assignment was to a roving legal team:

Early Learning Center on Boston's south side. I arrived in the dark to find an illegally placed Martha Coakley sign. My challenge of the electioneering went unheard by the Warden, the presiding election official. Ultimately, it was the police officer assigned to the polling location who removed the sign. All over, similar challenges to illegal practices were made and for the first time in the state's history, the electioneering law was enforced.

The roving legal teams were dispatched to many instances of fraud to gather and document evidence. In one instance, a ballot marked for Scott Brown was

intentionally withheld from the ballot box by election officials and later spoiled after being found in a secrecy sleeve. Affidavits were drafted at the legal team headquarters and videographers were available to interview witnesses for any later recounts or court challenge.

The election laws and process in Massachusetts are rife with opportunities for error and fraud. Voters do not have to present a certificate to vote and can only be asked for identification in limited circumstances. My experience there taught me that election fraud exists for two reasons: complicity and complacency. The ballot box is our national birthright and treasure. We must guard it jealously or be ruled by those who would loot it.

assignments and later served at Headquarters as the Agency's liaison with Congress and as Executive Assistant to the Chief of Operations. He was later appointed to the U. S. Senior Executive Service and became its Chief of Domestic Operations, where he was principal advisor to the Chief of Operations and DEA's Administrator on all operational and enforcement matters throughout the continental U. S. and its territories.

**Robert E. Casey, Jr.**, is a native of Indianapolis, Indiana and earned a BS from Indiana State University. In 1981 he joined the Houston Police Department as a patrol officer and soon became an organized crime investigator in its Criminal Intelligence Division. He became an FBI special agent in 1986 and undertook numerous field assignments in Phoenix, Chicago and Miami investigating organized and violent crime. He also served at FBI Headquarters in the Criminal Investigative Division and directed a multi-agency task force in the Counterterrorism Division. He has since held numerous other executive positions, responsible for development and oversight of the FBI's intelligence capabilities, policies, and processes. He has represented the FBI on national intelligence and law enforcement boards and advisory groups. Mr. Casey was honored as a Distinguished Alumnus by Indiana State University and received a 2006 Presidential Rank Award for Meritorious Executive.
