EFFECTIVE POLITICAL RECRUITMENT AND PERSUASSION

Part Two

First of all, I hope you and yours had a wonderful, safe, productive, but relaxing summer, and that you are energized and ready to go to work in what I believe will be one of the most important election years for Dallas County, the State of Texas, and for the United States Congress.

Our Dallas County Republican Chairman, the incredible Wade Emmert, has been working tirelessly this summer visiting with potential candidates, working on organization, motivating volunteers, recruiting new volunteers, and preparing the Dallas GOP for what will be the year-long effort of conducting next spring's Republican Primary, raising money, attracting former and new Republican voters, and positioning our county party to be able to reclaim the administration of Dallas County government and restore fair, efficient, friendly, financially responsible and management to our county accountable organizations. I believe if anybody can do it, Wade Emmert is the one. It may initially have been for social reasons, or you may have been "inspired" to support a particular candidate for philosophical reasons. But, your investing your time in political pursuits, as opposed to some other interests, likely made you feel you were doing something very worthwhile that could enhance your own life, help others, and followed the principles of the Founding Fathers that selfgovernment needs all of the good selves it can get to stay humble and accountable to *We The People*.

There is one unalterable truth we all need to keep in mind: <u>The Dallas County Republican Party, and the Republican Party of Texas, cannot grow, prosper, and prevail at the ballot box without continuously attracting new voters and supporters!</u> And, that's where we come in.

Constitutional Amendment / Joint Election November 5, 2013

Gov. Perry has set November 5th as an Election for Voting on Proposed Constitutional Amendments

Pursuant to Sections 274.001 and 274.002 of the Texas Election Code, the propositions for the joint resolutions will appear as follows:

PROPOSITION 1

"The constitutional amendment authorizing the legislature to provide for an exemption from ad valorem taxation of all or part of the market value of the residence homestead of the surviving spouse of a member of the armed services of the United States who is killed in action."

PROPOSITION 2

"The constitutional amendment eliminating an obsolete requirement for a State Medical Education Board and a State Medical Education Fund, neither of which is operational."

PROPOSITION 3

"The constitutional amendment to authorize a political subdivision of this state to extend the number of days that aircraft parts that are exempt from ad valorem taxation due to their location in this state for a temporary period may be located in thi state for purposes of qualifying for the tax exemption."

PROPOSITION 4

"The constitutional amendment authorizing the legislature to provide for an exemption from ad valorem taxation of part of the market value of the residence homestead of a partially disabled veteran or the surviving spouse of a partially disabled veteran if the residence homestead was donated to the disabled veteran by a charitable organization."

PROPOSITION 5

"The constitutional amendment to authorize the making of a reverse mortgage loan for the purchase of homestead property and to amend lender disclosures and other requirements in connection with a reverse mortgage loan."

PROPOSITION 6

"The constitutional amendment providing for the creation of the State Water Implementation Fund for Texas and the State Water Implementation Revenue Fund for Texas to assist in the financing of priority projects in the state water plan to ensure the availability of adequate water resources."

PROPOSITION 7

"The constitutional amendment authorizing a homerule municipality to provide in its charter the procedure to fill a vacancy on its governing body for which the unexpired term is 12 months or less."

PROPOSITION 8

"The constitutional amendment repealing Section 7, Article IX, Texas Constitution, which relates to the creation of a hospital district in Hidalgo County."

PROPOSITION 9

"The constitutional amendment relating to expanding the types of sanctions that may be assessed against a judge or justice following a formal proceeding instituted by the State Commission on Judicial Conduct."

Last day to receive application for Ballot by Mail is Friday, October 25, 2013

Last day to receive FPCA application for Ballot by Mail is Tuesday, October 29, 2013


