

Legislative Update from DCCRW's Legislative Director, Ronda Moreland

End of Session is Monday, June 1st

Remember you can watch floor debates these final hours of the 84th Legislative Session at http://www.capitol.state.tx.us/

Border Security

HB11 passed both Chambers after months of not seeing eye to eye on the spending portions of this Border Security Bill, but in the end Texas Borders are strengthened

- Facilitate the hiring of additional troopers and paying them at a higher rate.
- Create a transnational intelligence center on the border to analyze crime data, and establish a reserve corps of retired DPS officers to assist with background checks and other duties.
- Create a new offense for smuggling if a person knowingly transports or harbors someone in the country illegally and does so for a profit.
- Require DPS to implement a strategy to establish southbound checkpoints on international bridges to search for weapons and bulk cash. The agency would work with federal authorities and share the costs of the operations.

Ethics

Ethics Bill Negotiations Focus on Dark Money. SB 19 passed out of the House with a 102-44 vote in favor of the Senate Bill. SB 19 - Author Van Taylor not pleased with the changes the proposed by the House so this bill could be one to keep your eye on these remaining days of the 84th.

Open Carry

House requested the appointment of a conference committee to address differences between the House and Senate versions of

the Open Carry Bill (HB910) (this update as of 5/28/15 – the word from Austin is that Open Carry will pass before Sine Die on Monday. Although reports that Sen Jose Rodriguez of El Paso is threatening to filibuster.

Veterans

HB 992 and HJR 75 passed addressing an unintended consequence of past legislation that deprived spouses of totally disabled veterans from receiving the benefit of a full exemption of their residential property taxes upon the veteran's death if it was prior to January 2010. This legislation corrects our laws to ensure ALL surviving spouses of our totally disabled veterans receive the support they so deserve for standing beside our greatest heroes.

Life Issues

- Further eroding of funds to Planned Parenthood as a state grant recipients;
- Increased funding by more than a third to abortion alternative providers to \$18 million over the biennium;
- Securing judicial bypass reform that closes many of the loopholes for minors to get abortions without parental involvement;
- End-of-life reform care laws to require provision of food and water to critically ill patients at the end of life.
