Next month we will again meet at Sonny Bryan's restaurant to hear Justice Mary Murphy speak on judicial temperance and activist judges.



Justice Mary Murphy was elected to the Fifth District Court of Appeals in November 2008 and she took the oath of office January 1, 2009. The Fifth District covers appeals from the counties of Collin, Dallas, Grayson, Hunt, Kaufman, and Rockwall. From 2001 through 2008, she presided in the 14th Civil District Court in Dallas County, Texas, including Presiding Judge for the Civil District Courts in Dallas County (2006) and Presiding Judge for Civil Jury Services (2002-03).

Prior to being elected to the 14th District Court, she was in private practice for almost 18 years. She was a name partner in the firm of Rochelle, Hutchison & Murphy from 1998 to 2000. Until 1997, she was a partner in the Litigation and Intellectual Property Sections of the firm of Jenkens & Gilchrist, and Hiring Partner in 1995-96. In 1997, she took a year's leave from practice to serve as the first Dallas County Civil Court Master, and was recognized for Outstanding Service to the Citizens of Dallas County. From 1983 to 1986, she was a litigation associate with Gorsuch Kirgis in Denver, Colorado.

She is a Fellow of the American Bar, Texas Bar, Dallas Bar, and Dallas Association of Young Lawyers Foundations. She currently serves as Chair of the Board of Trustees for the Dallas Bar Foundation, which administers grants, including the Sarah T. Hughes Diversity Scholarships to SMU Dedman School of Law. She has held numerous leadership positions with the American and Dallas Bar Associations, the State Bar of Texas, and currently serves as the President of The Patrick E. Higginbotham American Inn of Court, a mentoring group committed to legal excellence, civility, professionalism, and ethics.

In 2007, she received her Certification in Civil Jurisprudence from the Texas Center for the Judiciary and was recognized by the State Bar of Texas with a Presidential Commendation for individual leadership in improving justice in Texas. She is a 1983 graduate from SMU School of Law, where she has served as an Adjunct Professor in Trial Advocacy and as a visiting lecturer for various classes. She is a 1979 graduate from the University of Texas at Dallas, where she was recognized in 2006 as an Outstanding Alumna, and currently serves on the Pre-Law Council. Also in 2006, the Dallas Chapter of the American Board of Trial Advocates honored Judge Murphy as the 2006 Judge of the Year.

Justice Murphy is committed to volunteer projects and has been recognized by the Dallas Voluntary Attorney Program for pro bono services. Her volunteer activities include tutoring at Cesar Chavez Learning Center, mentoring through the Dallas Bar Association's E-Mentoring and Transition to Law programs, construction for Habitat for Humanity, and service projects through the Becomers Class at First United Methodist Church.

She has been married to Gregory Huffman, an antitrust attorney with Thompson & Knight, for over 23 years and they have two sons, Ted (finishing his junior year at Vanderbilt University) and Mark (a high school senior at Greenhill, who insists on going to college).

Key Election Dates for April & May

Below is a list of Key Election Dates as provided by Michael Li at txredistricting.org.

- April 9, 2012 Date by which candidates for state house or state senate must be residents of the district they seek to represent.
- April 14, 2012 Deadline for mailing military and overseas mail ballots for primary.
- April 15, 2012 Deadline for federal candidates to file their Q1 2012 campaign finance reports (date not extended because it is a Sunday).
- April 18, 2012 Deadline for candidates for state office to file personal financial statements with the Texas Ethics Commission.
- April 21, 2012 Democratic senate district and county conventions. Republican senate district and county conventions in some counties. SD 8 Convention 9 am at Richardson Civic Center.
- April 25, 2012 Date by which county election officials must issue new voter registration certificates to voters.
- April 30, 2012 Deadline for opposed state, county, and local candidates to file their '30-day before election' reports (covering contributions and expenses through April). Also date by which, voter registration or change of address cards must be postmarked in order to be effective for the primary.
- April 30 May 8, 2012 Early voting for May municipal and school board elections.
- May 12, 2012 Municipal and school board elections.
- May 14-25, 2012 Early voting for Texas primary.
- May 17, 2012 Deadline for congressional candidates to file their pre-primary reports (covering contributions and expenses through May 9).
- May 21, 2012 Deadline for opposed state, county, and local candidates to file their '8-day before election' reports (covering contributions and expenses through May 19).
- May 29, 2012 Texas primary day.

"Hi, this is Greg Abbott talking to you from Washington, D.C., just outside of the United States Supreme Court where I'm here fighting for your liberty and your freedom in the ObamaCare lawsuit. I just left the Supreme Court building after we had a day of oral argument where the issue before the court is going to be whether or not they infringe on your liberty and over-reach into your lives unlike ever before. You can tell this is history in the making for two reasons. One reason is because of the massive crowds outside of the court where people across the country are coming here to protest against this over-reaching law. You can also see the history in the court hearings themselves. I've argued a case before the U.S. Supreme Court defending the Ten Commandments monument. I've been here about second amendment cases as well as other cases that Texas has had before the High Court. Every Supreme Court argument lasts one hour. This case is not lasting one hour or even one day. This case is lasting three days in an historic moment before the U.S. Supreme Court as we work so hard to defend you, your lives, your pocketbooks, your taxpayer dollars and your liberty. I'll continue to report back every day to let you know what's going on."

Texas' primary election day is <u>less than two months away</u> and Secretary of State Hope Andrade has launched a voter education program aimed to increase turnout. Along with a very late primary date, voters have possible confusion over new district lines to contend with.

"We want to make sure that all our Texans start thinking about voting and hopefully will understand that it will be the day after Memorial Day," Andrade said. "We do have early voting May 14 through the 25 and we're hoping they'll start thinking about maybe including this in their plan for Memorial Day."

The state passed a law last year requiring most voters to show photo identification before casting their ballots, but it was <u>blocked by the Justice Department last month</u> and will not be enforced for next month's primaries.

Friends,

It is officially spring in North Texas! I hope everyone is staying safe as the changing weather can bring dangerous conditions. In Austin, we are gearing up for the next legislative session. If you have an issue or concern you feel could be addressed with legislation, now is the time to begin working on it so please contact me with your ideas. Additionally, we are currently accepting applications for interns in my capitol office. I am sending out this newsletter a few days early because of the Easter holiday. Our offices will be closed on Friday, April 6th and Monday the 9th so my staff may spend time with their families.

Technology Committee Interim Hearing

On Friday, I traveled to Austin to attend a Technology Committee hearing. It was a very productive hearing. We heard a great deal of testimony on the feasibility of public-private partnerships within the industry. Dr. Bruce Gnade, Vice President for Research at UT Dallas gave informative testimony. He updated the committee on the progress of UTD's Venture Development Center. It currently houses 11 companies that are based on technology developed at the University. Go Comets!

We heard testimony from Karen Robinson, Executive Director, Department of Information Resources and Jonathan Taylor, Director, Office of Governor Perry - Emerging Technology Fund. Jonathan testified that only 2% of early stage investment is spent in Texas. He went on to state, "If we don't compete, we will fail. Companies compete with companies, states compete with states and Texas competes with the world."

I couldn't agree more with Jonathan. During the hearing I commented that I believe strongly in the freemarket. I do not think the government should pick winners and losers. I also realize that we do not live in an ivory tower. Other countries and states are providing incentives and if we do not compete, we will lose.

Thanks to our pro-business environment and past investments in research and innovation, Texas is the number-two US state in hi-tech. We already have a good foot in the door. There are definitely questions about the optimal blend of public and private sector research, but I am glad we are having the conversation and I would love to hear your thoughts on the issue.

Supreme Court Hears Arguments on Constitutionality of Affordable Care Act

Last week, the United States Supreme Court heard arguments in the *Florida v. Health and Human Services* case that is challenging the constitutionality of the Patient Protection and Affordable Care Act. The Affordable Care Act, signed into law in March of 2010, was challenged due to the mandate requiring individuals to purchase health insurance or face penalties.

Last session, Texas legislators took action by passing the Interstate Health Care Compact. This compact, if approved by Congress, will give Texas and other member states the ability to develop health care policies, free of federal regulations and tax penalties, to allow the state to manage our own budget and health care needs. Medicaid as we now know it is unsustainable and will quickly consume an even larger percentage of the state budget.

If the U.S. Supreme Court rules the Affordable Care Act unconstitutional, we can reset the debate on health care and insurance policies. Developing a market driven system that focuses on quality health care outcomes and encourages competition among health care and insurance providers are key reforms to empowering individual consumers to make their own health care decisions without unnecessary government intrusion.

March has been a busy month around the district. The 58th Annual Meeting of the North Dallas Chamber of Commerce was very informative. I enjoyed attending the RISD Excellence in Education Foundation Stars & Spurs Reception this month. Mayor Todd Gottel gave an excellent speech at this month's Rowlett Chamber of Commerce luncheon.

It was wonderful catching up with old friends and meeting many new ones at the Richardson Chamber of Commerce's Annual Meeting and Awards Ceremony. Richardson City Manager Bill Keffler was selected as Citizen of the Year. Congratulations to all the fantastic individuals and businesses that were nominated for or won awards. The keynote speaker was Andrew Card, Dean of the Bush School of Government and Public Service at Texas A&M University. He delivered a moving speech including giving his personal insights serving as President George Bush's Chief of Staff during and after 9-11. Dean Card's first-hand account of those events was so touching to hear. He spoke of the courage of everyone involved from the first responders to that of our President.



The Hill Report Week of March 19 – 23, 2012 A Weekly Newsletter from Congressman Pete Sessions

Today marks the second anniversary of President Obama signing the government takeover of health care into law. Drafted behind closed doors and forced through Congress without revealing its full contents, ObamaCare leaves the American people with a long list of broken promises.

Over the past two years, much more has become known about the law's devastating effects. These have unfortunately left Americans with increased health care costs, fewer choices, government interference in the physician-patient relationship, and unsustainable cuts to Medicare. To make matters worse, the nonpartisan Congressional Budget Office (CBO) recently reported that the law will cost more than originally anticipated and force millions off of their preferred, employer-provided insurance.

This week, the House passed the Protecting Access to Healthcare Act, which, among other things, will repeal the Independent Payment Advisory Board (IPAB) created under the health care law. IPAB is a board of 15 unelected bureaucrats that will be empowered to make cuts to Medicare with no oversight or transparency to those it will impact or any branch of government. This unaccountable board will not only jeopardize access, choice and coverage of quality health care for our nation's seniors, but will also increase health costs and shift the burden onto the private sector.

House Republicans have now voted 26 times to defund, dismantle, or repeal the new health care law, and we will not give up the fight until it is repealed in full. I will continue to stand up for our nation's seniors, families and small businesses to address the challenges facing our health care system with solutions that empower patients – not Washington bureaucrats – and ensure access to affordable and quality health care.

Dent-Sessions Amendment to PATH Act

On Thursday, the House passed my amendment with Congressman Charlie Dent (R-PA) to the PATH Act, which addresses the ongoing crisis facing our emergency room departments and offers liability protection to physicians who perform the mandated crucial care to patients in the greatest need.

By law, emergency rooms must treat anyone who needs care regardless of if they have insurance or can afford it. During these increasingly tough economic times, emergency rooms have seen an increase in patients due to the number of unemployed and/or uninsured people needing care. Additionally, since patients are often sicker, have more serious complications and have no pre-existing relationship with the treating physician, hospitals have found it to be increasingly difficult to secure emergency physicians and on-call specialists due to the increased likelihood of litigation.

High quality health care in our nation's emergency rooms is currently being threatened by high costs, overcrowding, and the inherently risky nature of on-call and emergency physician care. Our amendment would deem hospitals, emergency rooms, physicians and physicians groups that provide emergency care to individuals to be employees of the Public Health Service for purposes of any civil action that may arise due to health care items and services provided under the Public Health Service Act.

I am pleased that the House voted to include this common-sense idea in the PATH Act to ensure that the American people receive the high quality care they deserve. The American College of Emergency Physicians (ACEP) released a

Congressional Art Competition

Each spring, students from the 32nd District submit their original artwork for consideration in the Congressional High School Art Competition. Known as "An Artistic Discovery," the contest is an annual, nationwide art competition initiated by Members of Congress as students from across the country compete in local art competitions held in their respective districts. More than 200 Congressional offices have participated in the program.

The competition is open to all high school students who live or attend school in the 32nd Congressional District. The Grand Prize Winner will received airline tickets for two to Washington, D.C. to see the unveiling of the artwork, a \$200 Savings Bond, and a tour of the Capitol. Additionally, the artwork will be showcased in the corridor leading to the U. S. Capitol building for the next year. Savings Bond awards worth \$100 will be awarded to the two Runners Up and the People's Choice Award selections and these works will hand in one of my Congressional offices.

I am pleased to once again host the Congressional High School Art Competition this year to provide an opportunity for our students to showcase their individual talents and receive national recognition. Artwork guidelines, entry forms, and artwork release notices may be accessed on <u>my website</u>, and interested applicants should note that all entry forms from the students' art teachers must be received in my Dallas District Office by Friday, March 30th. Health Reform in the Supreme Court: A Guide to the Issues

The U.S. Supreme Court has concluded oral arguments on the legal challenges to the Patient Protection and Affordable Care Act (PPACA), and will spend several months establishing majority positions and writing concurring and dissenting opinions. The allocation of time for oral arguments is instructive in understanding the interplay of issues at hand, say Mario Loyola, Josiah Neeley and Spencer Harris of the Texas Public Policy Foundation.

- A historically large total of six hours of oral arguments were allocated to the PPACA challenge.
- Ninety minutes were dedicated to arguments as to whether the Anti-Injunction Act (AIA) bars any challenge to the individual insurance mandate until 2014.
- One hundred and twenty minutes were assigned to discussion of the constitutionality of the individual mandate -- the most controversial portion of the law.
- Ninety minutes were allowed for the issue of "severability," namely what to do with the rest of the PPACA if the individual mandate is struck down.
- Sixty minutes were given to discussion as to whether or not the expansion of Medicaid amounted to effective federal coercion of the states.

The first issue, regarding the AIA, is essentially a question of timing. The AIA requires that taxation laws cannot be legally challenged until they are levied. Therefore, because the PPACA will not be fully implemented until 2014, a court decision to uphold the applicability of the AIA would delay making a decision for two years. Interestingly, neither the federal government on one side nor the state governments on the other are arguing that AIA should apply.

The second issue of the individual mandate will become the quintessential constitutional challenge to the true breadth of power afforded to Congress by its power over interstate commerce. State challengers argue rightly that if this power extends so far as to be able to regulate a lack of activity (not buying insurance), then very little is not within the scope of federal power.

Thirdly, the Court will assess whether the other provisions of the PPACA can continue as law if the mandate is found

unconstitutional. Crucial here is the fact that the PPACA would likely never have been approved by Congress in the absence of the mandate. Therefore, upholding the rest of the law would essentially be a judicial line-item veto.

Fourth and finally, the expansion of Medicaid will be scrutinized as being excessively coercive of states to the point that it violates the principles of federalism. The expansion would require greater budgetary outlays by the states to cover their share of the program, but opting out of the program is largely politically impossible.
