Civil rights groups appeal Alabama voter ID ruling

MONTGOMERY, Ala. (AP) — Civil rights groups are again challenging a federal judge's ruling that an Alabama law requiring a government-issued photo ID for voting is not discriminatory.

Legal counsel for the Alabama NAACP, Greater Birmingham Ministries and minority voters filed an appeal in the U.S. district court in northern Alabama on Wednesday.

Since 2014, Alabama has required voters to show government-issued photo identification when they vote. The civil rights groups sued over the law in 2015, calling it discriminatory and an infringement on voting rights. They contended Alabama politicians knew when they enacted it that black and Latino voters "disproportionately lack the required photo ID."

U.S. District Judge L. Scott Coogler ruled in favor of the state in January. He concluded that the state makes provisions to help voters get IDs, including a mobile service that will make home visits if needed. Natasha Merle, NAACP's Legal and Education Defense Fund assistant counsel, told The Associated Press that the court erred in depending on the mobile service to register all voters.

"The district court acknowledged our evidence that over 100,000 voters, disproportionately Black and Latino voters, lack the required photo ID to vote, but suggested the disparities are not significant," Merle said. "The disenfranchisement of several thousand voters is not trivial. We will continue to fight to ensure every eligible Alabama voter can make their voice heard at the ballot box."

Alabama Secretary of State John Merrill said the law was intended to combat voter fraud and increase turnout. He said voters could get the ID at any registrar during regular business hours or request the mobile service.

"If they will show me one person who does not have photo ID or who can't vote, I will send someone to their house today that will help them be registered to vote," Merrill said. "That's why we had the voter ID lawsuit dismissed."

Merrill said that the mobile service visited less than 10 homes since the lawsuit was filed. The appeal confirms it was five.

One of those visits followed court testimony by plaintiff Elizabeth Ware, a 60-year-old African-American voter from Mobile County. Her photo ID was stolen in 2014, but she was turned away when she tried to replace it. After her testimony, Merrill offered to send the mobile service to visit her home, where the state issued her an ID. She previously said she didn't know anything about the service, which is only advertised online.

The plaintiffs are asking for a trial, which Coogler canceled, to be rescheduled and the issue resolved before the state's primary elections in June.

Merle said problems with the photo IDs were already recorded at December's special Senate election. A report from legal fellow Jennifer Holmes, who was on the ground in Alabama, said some voters in Mobile County were turned away at the polls because their addresses on the photo IDs didn't match the addresses in the voting records.

This story has been corrected to reflect that the appeal was filed Wednesday, not Tuesday.

Gubernatorial Candidates

General election

Alabama will hold elections for governor in 2018. A primary election is taking place on June 5, 2018. The general election is on November 6, 2018. The filing deadline for candidates wishing to participate in the primary elections was February 9, 2018.



Kay Ivey is the <u>Republican Governor of Alabama</u>. Ivey is running for re-election in the primary on June 5, 2018. The general election will take place on November 6, 2018.

Ivey was sworn into office on April 10, 2017, following the resignation of Gov. Robert J. Bentley (R). His resignation came in the wake of an ethics investigation that led to impeachment hearings. She previously served as lieutenant governor from January 2011 to April 2017. She was elected to the position in 2010 and re-elected in 2014. Ivey was the first Republican in the state's history to serve two consecutive terms in the lieutenant governor's office.

Initially a candidate for <u>governor</u> in 2010, Ivey switched to the lieutenant governor's race on March 31, 2010. She went on to defeat incumbent <u>Jim Folsom</u>, <u>Jr.</u> (D) by a slim margin in the general election on <u>November 2, 2010</u>. The victory made Ivey the first Republican woman to be elected lieutenant governor in the state's history.

Ivey was first elected to statewide office in 2002, defeating <u>Democratic</u> opponent Stephen Foster Black in the general election to win election as <u>state treasurer</u> of Alabama. She served two terms in this office before becoming lieutenant governor in 2011.

Prior to entering public service, Ivey was director of government affairs for the Alabama Commission on Higher Education from 1985 to 1998, assistant director of the Alabama Development Office from 1982 to 1985 and a reading clerk for the Alabama House of Representatives from 1980 to 1982. Ivey was also assistant vice president of Merchants National Bank/Regions Bank from 1970 to 1979.

Ivey was raised in Camden, Alabama. She attended Auburn University, Duke University's Governor's Center for Public Policy, Alabama Banking School and the University of Colorado School of Banking. Her professional experience includes working as a high school teacher, a bank officer, and as assistant director of the Alabama Development Office.

In addition to her professional duties, Ivey is a member of the First Baptist Church of Montgomery, the Montgomery Rotary Club, the Board of Directors of the Montgomery YMCA and the Tukabatchee Council of the Boy Scouts of America.



Tommy Battle is a <u>Republican</u> candidate for <u>Governor of Alabama</u>. The primary election is being held on June 5, 2018. The general election will take place on November 6, 2018.

Battle is mayor of <u>Huntsville</u>, <u>Ala.</u> He was first elected in 2008 and won a second term in the 2012 municipal election.

Battle was born in <u>Birmingham, Ala.</u> in 1956 and moved to <u>Huntsville, Ala.</u>, in 1980 after earning a business degree from the University of Alabama. He was the manager of Britling's Buffet, a local restaurant that he later purchased. He sold Britling's Buffet in 1989.

Battle was elected to the City Council of Huntsville in 1984 and served as finance chair. He served as chairman of the board of Early Works, a Huntsville-based group of history museums. Battle also served on the boards of the Huntsville solid waste disposal authority and Huntsville Emergency Medical Services, Inc (HEMSI).

Battle became Mayor of Huntsville in 2008 after defeating three-term Mayor, Loretta Spencer, in the election. A former city councilman said that Battle "deserves credit for making the tough decisions needed to weather the economic crisis" that began during

his first term. For instance, Battle "declared a hiring freeze on all city government jobs, slashed spending on the public library and other agencies, and used some of the city's emergency savings" when sales tax receipts declined in 2009.

In 2012, Battle won re-election for another four-year term in what a local paper called the "most lopsided mayoral victory in modern Huntsville history." Battle had defeated Spencer a second time with 80.7 percent of the vote. That year he also participated in George Washington University's "GW Moving the Planet Forward Innovation Summit" where he discussed his environmental policies. Under his tenure as mayor, Standard & Poor's Rating Services and Moody's Investors Service assigned a "AAA" bond rating to the city of Huntsville.

In October 2013, Battle formed the Moving Alabama Forward PAC. He said the funds would be used to "focus on the future of Huntsville, and how Huntsville relates to the rest of the state" and not for any aspirations he might have about seeking a higher office. He announced in early 2014 that he would not run for <u>Governor of Alabama</u> that year.



Scott Dawson is a <u>Republican</u> candidate for <u>Governor of Alabama</u>. The primary election is being held on June 5, 2018. The general election will take place on November 6, 2018.

A native of <u>Birmingham</u>, <u>Alabama</u>, Dawson established the Scott Dawson Evangelistic Association in 1987, and was ordained in the Baptist church in 1993. Since that time, Dawson has worked as a preacher and evangelist, holding rallies and conferences and writing books on spreading Christianity.

Scott Dawson is a man of tremendous character, conviction and faith. He is a family man and an active leader in his community. Scott is an energetic visionary. He has worked hard all of his life, and in those years, Scott Dawson has inspired thousands upon thousands to live spiritually, joyfully and generously with great and lasting purpose.

Scott Dawson is a lifelong resident of Alabama, reared on the west side of Birmingham. The son of Paul and Ann Dawson, Scott grew up in a modest, blue-collar family with traditional values and a strong work ethic. As a teenager, Scott got his first job at Shoe City in Five Points West.

Bill Hightower is a Republican member of the Alabama State Senate, representing District 35. He was first elected to the chamber in a special election on March 12, 2013. He did not seek re-election in 2018.

Hightower is a <u>Republican</u> candidate for <u>Governor of Alabama</u>. The primary election is being held on June 5, 2018. The general election will take place on November 6, 2018.

Hightower's professional experience includes owning a corporate strategic consulting firm and working in international business.


