ARCHITECTURAL REVIEW REMINDERS

Our mid-July hail storm caused a lot of damage in the area, primarily to roofs. As a result, Cherry Creek Village North's Architectural Review Committee (ARC) has been busy processing new roof and other home exterior projects over the past few months.

Many homeowners have been inspecting their roofs, gutters, and siding to assess possible damage and contacting their insurance companies. ARC recommends that homeowners contact their insurance agents directly rather than having a roofing contractor do it for you. A homeowner has a relationship with their insurance company, not the contractor. If you do contact a roofing company to inspect your roof, we recommend you use only those companies who are "factory-certified." In addition, please check the Better Business Bureau report for your prospective factorycertified roofing contractor and avoid contractors who have less than an 'A-' rating.

When storms hit our neighborhood last year, the ARC developed updated HOA roofing guidelines as an aid for homeowners. Most homeowners don't install new roofs very often and it can be a challenging task to work with your insurance company, review your claim estimate, and select the right contractor for your project. You can find our roofing guidelines on the HOA website under the **Home Improvement** header. The document is dated 10-13-2015.

In the past eight weeks, we have processed over 15 re-roofing applications, with quite a few of them including new gutters and paint. Many contractors are booked up until mid-October, so we will continue to see roofing activity for at least another eight weeks.

As a reminder, if you are planning to do exterior work on your home or front yard, please feel free to contact Jeff Denchfield or Paul Oppegard, and they will be happy to help answer any questions you may have. Again, the ARC application and other useful information is available on our HOA website. Thank you to all the homeowners who have submitted their ARC approval forms over the summer. We appreciate your timeliness.

We are busy working on many things at City Hall. The Planning and Zoning Commission is completing an over 12-month long process to develop an addition to the Greenwood Village Comprehensive Plan for the areas around the Orchard Light Rail Station. This area is referred to as the Orchard Station Sub Area. Many of you know that Alberta Development is hoping to redevelop approximately 24 acres in the Orchard Station Sub Area, but there is not a development proposal filed with the City at this time, and

therefore, no specific discussions by the Planning and Zoning Commission regarding any specific development details.

On Friday, September 16th, the City Council completed an all-day retreat to finalize the 2017 budget for all city departments. As in recent years, the City is in a very favorable financial position allowing us to continue providing our high level of services for residents while continuing to invest in capital improvement projects and equipment.

If you have visited Village Greens Park recently, you may have noticed two current projects we have underway there. First is the installation of the synthetic turf field on the south end of the maintenance shed. The field should be completed this fall. Second, after many months of discussions with the Cherry Creek School District, it was decided that Field #8 would be the best location for the CCHS Varsity softball team. (Field #8 is where the team has been playing for many years on the northeast side of the restrooms.) The school district will be installing a new scoreboard, flag pole, and batting cage in time for the fall season and after this season, additional improvements will be made to the dugouts and fences to provide the team with a great new "Home Field." Finally, the Phase 4 improvements in Village Greens North are also slated to begin this fall. These improvements include an entrance to the disc golf and mountain bike courses, as well as picnic pavilions and restrooms near the pond.

Autumn Bird Migration Around Cherry Creek Village North

Before our trees change color, the annual autumn bird migration begins. Different species leave at different times and sometimes females leave before males. Youngsters recently hatched face daunting journeys as they follow their parents to join larger flocks that head south together. Migration may begin as early as August and most have left our neighborhood by mid-October.

How can we assist our wild neighbors and help assure they are well prepared for their odysseys to winter homes some of which may be as far away as South America? Birds' most crucial needs are food, water, and shelter from weather and for rest. Myriad websites, organizations, and wild bird supply stores can help you learn what common species in our area require for nutrition. Providing clean, accessible feeders and water sources is easy. Shelter and rest areas are plentiful in our mature landscaping, but you can augment these areas by planting appropriate trees, shrubs, and food-producing plants.

Want some fun? Buy a good set of binoculars and join the Audubon Society's bird counting events. Join a birdwatching group and go on regular excursions at Cherry Creek State Park. Go to the National Wildlife Federation's website (http://www.nwf.org/Garden-For-Wildlife/Create.aspx) and apply to have your yard certified as a Backyard Habitat. Enjoy watching our wild neighbors while your family helps them embark on their seasonal voyage.
