RESOLUTION NO. 42-S-2012

A RESOLUTION AUTHORIZING THE HON. AMELIA A. GAMILLA MUNICIPAL MAYOR TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA), BETWEEN THE PHILIPPINE HEALTH INSURANCE CORPORATION, A GOVERNMENT OWNED AND CONTROLLED CORPORATION DULY ORGANIZED AND EXISTING BY VIRTUE OF REPUBLIC ACT NO. 7875, (AS AMENDED BY REPUBLIC ACT NO. 9241), OTHERWISE KNOWN AS THE NATIONAL HEALTH INSURANCE ACT OF 1995, TO ENROLL THE 1,000 INDIGENT FAMILIES FOR THE PARTIAL SUBSIDY SCHEME UNDER THE TWO YEARS (2) LOCK IN PERIOD FROM JANUARY 2012 TO DECEMBER 2013.

NOW THEREFORE, this August Body the Municipal Council of Bongabon, Nueva Ecija now in session assembled on motion of Councilor Lodovico R. De Leon and duly seconded by Councilor Elpidio DG. Angeles, be it;

RESOLVED, as it is hereby resolved a resolution authorizing the Hon. Amelia A. Gamilla, Municipal Mayor to enter into Memorandum of Agreement (MOA), between the Philippine Health Insurance Corporation, a government owned and controlled corporation duly organized and existing by virtue of Republic Act. No. 7875, (as amended by Republic Act No. 9241), otherwise known as the National Health Insurance Act of 1995 to enroll the 1,000 indigent families for the partial subsidy scheme under the two years (2) lock in period from January 2012 to December 2013.
