MUNICIPAL ORDINANCE NO. 124-S-2013

**AN ORDINANCE ENACTING THE CODE OF GENERAL
ORDINANCES OF THE MUNICIPALITY OF BONGABON, PROVINCE
OF NUEVA ECIJA.**

**CHAPTER I
GENERAL PROVISIONS
Article A. Title and Scope**

Section 1.A.01. Title. This Ordinance shall be known as the “Code of General Ordinances of the “Municipality of Bongabon, Province of Nueva Ecija”.

Section 1.A.02. Scope. This Code covers all general ordinances of the Municipality of Bongabon, Province of Nueva Ecija.

Article B. Rules of Construction

Section 1.B.01. Words and Phrases. Words and phrases embodied in this Code shall have the same meaning as found in legal dictionaries as well as in existing laws.

Section 1.B.02. Construction of Codal Provisions. In construing the provisions of this Code, the following rules of construction shall be observed unless otherwise inconsistent with the manifest intent of the provisions or when applied they would lead to absurd or highly improbable results.

a. General Rule. All words and phrases shall be construed and understood according to the common and approved usage of the language; but technical words and phrases and such other words in this Code which may have acquired a peculiar or appropriate meaning shall be construed and understood according to such technical, peculiar or appropriate meaning.

b. Gender and Number. Every word in this Code importing the masculine gender shall extend to both male and female. Every word importing to singular number shall extend and apply to several persons or things as well; and every word importing the plural number shall extend and applied also to one person or thing.

c. Computation of Time. In computing any period of time, the day of the act or event from which the designated period begins to run out is to be excluded and the date of performance included. If the last day of the period, as thus computed, falls on Saturday, a Sunday or a legal holiday in the province, the time shall not run until the next working day.

d. Tenses. The use of any verb in the present tense shall include the future whenever applicable. The words “shall have been” shall include past and future cases. The use of the word “shall” in this Code means the act being required to be done is mandatory, whereas when the word “may” is used, it means permissive.

e. References. All references to the “Chapters”, “Articles” or “Sections” are to chapters, article in sections in this Code unless otherwise specified. Conflicting Provisions of Chapters. If the provisions of different Chapters conflict with or contravene each other, the provisions of each chapter shall prevail as to all specific matters and questions involved therein.

f. Conflicting Provisions of Sections. If the provisions of different Section in the same chapter conflict with each other, the provisions of the Section which is last in point of sequence shall prevail.

Section 1.B.03. Amendment and Integration of Additional Provisions. Any amendment on this Code may be introduced to the chapter, article or section concerned. All ordinances or provisions thereof enacted subsequent to the date of effectivity of this Code shall be complied in such a way as to bear the corresponding chapter, article or section to which ordinance shall be integrated into the corresponding chapter, article or section whenever a new printing or reproduction of this Code is undertaken upon authorization of the Sanggunian.

Section 1.B.04. Existing Rights. No right accrued, action or proceeding commenced before the effectivity of this Code shall be adversely affected by any provisions hereof. Thereafter, all procedures or actions to be taken shall conform to the provisions of this Code whenever possible.

Section 1.B.05. Reference to Code. Whenever reference is made to any portion of this Code, such reference shall apply to all amendments and additions now or may hereafter be introduced.

Section 1.B.06. Effect of Heading. The Chapter, Article and Section headings do not in any manner affect the scope, meaning or intent of the provisions contained in this Code.

Section 1.B.07. Relation to Prior Ordinance. The provisions of this code which are substantially the same as that of previous or existing ordinances particularly when dealing with the same subject matter shall be construed as “restatement” and not as a new enactment.

Section 1.B.08. Annexes. The text of all ordinances in this Code shall be a part of this Code and shall be known as “**ANNEXES**”.

Section II. 07. Ordinance No. 08-s-1996. Isang Kapasyahan/Kautusan na ang miembro ng Bongabon Butcher Association na may lisensiya ng 3 colonia lamang ang may karapatang magkatay ng mga hayop, para ipagbili sa Pamilihang Bayan ang maaring makapasok sa Municipal Abattoir ng Bongabon, Nueva Ecija at maaari lang dalhan ang 3 colonia sa oras ng pagkakatay, simula alas 12:00 ng hating gabi hanggang alas 12:00 ng tanghali ang mahulihan ng lampas sa itinakdang oras ay papatawan ng kaukulang multa.

Section II. 08. Ordinance No. 09-s-1996. Isang Kapasyahan/Kautusan na maglagay ng basurahan sa tapat ng paradaan at loob ng mga sasakyen pampubliko tulad ng A.L. Trans, Eugene Trans, Jeepney at mga Tricycle na pumapasada sa Bayan ng Bongabon, Nueva Ecija.

Section II. 09. Ordinance No. 10-s-1996. Isang Kapasyahan/Kautusan na bawal magkalat/magtapon ng basura (Anti-Littering) sa nasasakupan ng kapaligiran ng Pamilihang Bayan ng Bongabon, Nueva Ecija.

Section II. 10. Ordinance No. 01-s-1997. Isang Kapasyahan/Kautusan na Bawal mag-u-turn ang mga sasakyen sa harap ng Pamilihang Bayan (PUJ/PUB/Delivery Truck); Bawal ang mag double parking (sa harap ng Pamilihang Bayan kung magbubuhut sa Pamahalaang Bayan); Bawal magdiskarga ang mga delivery truck buhat sa ganap na ika 6:00 ng umaga hanggang ika 6:00 nang hapon araw-araw sa harap ng palengke; ang pagbaba ng pasahero ay sa harap ng bahay ni G. Section II. 11. Ordinance No. 13-s-1998. Section II. 12. Ordinance No. 17-s-1999. Isang Kapasyahan/Kautusan na nag-aatas ng pagpapanatili sa inilunsad na “OPLAN LINIS AT KALUNTIAN” sa Bayan ng Bongabon, Nueva Ecija.

Section II. 13. Ordinance No. 34-s-2000. Isang Kapasyahan/Kautusan nagtatakda ng libreng pagkuha ng tricycle legalization at plaka (Plate No.) para sa taong 2001 at 2002 sa unang tatlong buwan ng taon (Enero-Marso) na nilolooban ng mga alintuntunin na nakapaloob 3tyro.

Section II. 14. Ordinance No. 37-s-2001. Isang Kapasyahan/Kautusang nagbabawal sa mga driver sa lahat ng uri ng sasakyen, na nagdaraan sa Bayan ng Bongabon, na magtapon ng dala-dala nilang basura na mula sa ibang Bayan o Lugar.

Section II. 15. Ordinance No. 50-s-2003. Isang Kapasyahan/Kautusang nagtatakda ng panuntunan sa pangangalaga ng “Plastic Garbage Drum” na ilalagay sa tapat ng bahayan sa Bayan ng Bongabon, Nueva Ecija.

CHAPTER VII Final Provision Article A. General Penal Provision

Section VII. A. 01. Penalty. Any violation of the provisions of an ordinance in this Code shall be punished in accordance to the penalties to be imposed in the ordinance which was violated. If the violation is committed by any juridical entity, the President, General Manager, or any person entrusted with the administration thereof at the time of the commission of the offense shall be held responsible or liable thereof,

Article B. Separability, Applicability, Repealing and Effectivity Clauses

Section VII. B. 01. Separability Clause. If, for any reason, any provision, section or part of this Code is declared not valid by a Court of competent jurisdiction or suspended or resolved by the authorities concerned, such judgement shall not affect or impair the remaining provisions, sections or parts which shall continue to be in force and effect.

Section VII. B. 02. Applicability Clause. All other related matters not specifically provided in this Code shall be governed by the pertinent provisions of existing applicable laws or ordinances.

Section VII B. 03. Repealing Clause. All Ordinances, rules and regulations, or parts thereof, in conflict with, or inconsistent with any provision of this Code are hereby repealed or modified accordingly should there be existing general ordinances which were inadvertently excluded in the codification process during the formulation of this Code, they shall continue to be in full force and effect provided that they are not in conflict with, or contrary to, the provision of this Code.

Section VII. B. 04. Effectivity. This Code shall take effect after its published in the bulletin board and all public places of this municipality.
