The lessee of a space, stall, tiendas or booth fails to pay the monthly rental fee shall pay a surcharge of Fifty Percent (50%) of the total rent due. Failure to pay the rental fee for three (3) consecutive months shall cause automatic cancellation of the contract of lease of space or stall.
