RESOLUTION NO. 103-s-2012

A RESOLUTION AUTHORIZING HON. AMELIA A. GAMILLA, MUNICIPAL MAYOR, BONGABON, NUEVA ECIJA, TO BE CANCELLED AND CONSIDERED ABANDONED DUE TO VIOLATION OF CHAPTER IV RESTRICTION OF SECTION 5 MARKET CODE: **ABANDONED STALL/ARTICLES** – *Any stall/booth in the municipal market which has been closed for thirty (30) consecutive days shall be considered abandoned and the lease to such stall/booth shall be automatically revoked by the Municipal Mayor.*

Any Articles abandoned in the municipal market in violation of any provisions of this code shall be deemed a nuisance and it shall be the duty of the Market Master and his subordinates to take custody thereof, In case the articles are claimed within twenty four (24) hours thereafter, they shall be returned to their owners upon payment of actual expenses incurred in their safekeeping unless they have so deteriorated as to constitute a menace to the public health, in which case, they shall be disposed in the manner directed, by the Municipal Mayor, who may also, or his discretion, cause the criminal prosecution of the guilty party, or merely warn him against future violations. If the articles have not deteriorated and not claimed within five (5) days the time herein fixed, said articles shall be sold at the public auction, and the proceeds shall be disposed of in accordance with law.
