United States citizens, illegal or otherwise. The government will have access to your personal finances and a healthcare ID card will be issued. This is the part that really gets me. The government will have direct access to your bank accounts for "elective funds transfers." To clarify, the government can take money from your bank account(s) without you knowing about it.
