The history of Vietnam from 1954 to 1963 with the French being defeated, Vietnam being divided into the Communist North and democratic South, the overthrow of Diem set the stage for what followed. I cannot do justice to the depth of information Jack presented but will be happy to forward his power point presentation to anyone that is interested.

# **GUEST SPEAKER**

CAPT L.E. Reed, raised in Gambrills, Maryland, earned a Bachelor of Science degree from the United States Naval Academy in 1990, majoring in Political Science and Economics. He was designated a Naval Aviator in 1992 and patrol plane pilot in 1994.

In August 2016, CAPT Reed reported to the Naval Reserve Officer

Training Corps Hampton Roads to serve as the Commanding Officer and Professor of Naval Science for an NROTC consortium consisting of Old Dominion, Hampton and Norfolk State Universities.

CAPT Reed's operational assignments include Commanding Officer and Executive officer of the Amphibious Transport Dock (LPD) 25 USS Somerset, San Diego, CA; Commanding Officer and Executive Officer of Patrol Squadron 4, Kaneohe, HI; Patrol Squadron 23 Brunswick, Maine; Patrol Squadron 11 Brunswick, Maine, as maintenance officer; USS Kitty Hawk Yokosuka, Japan, as assistant operations officer; Patrol Squadron 5 Jacksonville, Florida, as operations officer; Task Force 57/72 (Patrol and Reconnaissance Forces 5th/7th Fleet), Misawa, Japan, as the operations, plans and requirements officer. Other assignments include Patrol and Reconnaissance Wing 5, Brunswick, Maine; the Joint Staff J3 reconnaissance operations division, Chief of

Naval Operations (CNO) staff warfare integration group (N00X) and the National War College earning a master's degree in national security strategy.

Roger Hirsh had a table next to PACMOAA with information per getting a Navy license plate in Virginia. This event was held to benefit END22 and Code 9 Project. Both are focused on PTSD/TBI and suicide - trying to increase awareness, educate and save lives. END 22 refers to 22Veterans and 1 active duty lost daily to the hidden wounds of war. Code 9 Project focuses on First Responders.

There were 15 to 20 vet friendly groups participating like DAV, VFW, USO, Homes for Heroes, Wreaths Across America, Navy Special Operations Foundation, Mutts with a Mission, Honor and Respect, etc. There were also quite a few groups whose focus was the same as END 22 and Code 9 Project - Hampton VA Medical Center Suicide Prevention coordinator, Mission Continues, Mission 22, Firstline, and Heroes to Heroes.

The event started with the END22 Memorial Ride from Waterside in Norfolk to the Bayside Harley Davidson dealership in Portsmouth and included military vehicles as well as motorcyclists. The event included food vendors, music and the vendors listed above. This provided a great opportunity for PACMOAA members to network and find out more about community efforts to combat this ongoing problem. #### SURVIVING SPOUSE CORNER: 4 Ways Surviving Spouses Can Contribute

Surviving spouses not only should be welcomed into chapters but also encouraged to become active members and leaders.

Surviving spouses of deceased military officers can serve MOAA chapters in many ways. Chapters should welcome these members and encourage them to become active in not only the chapter but also national MOAA. Here are four ways surviving spouses can contribute to MOAA chapters:

**Recruiting.** Having participated in activities on many military bases and within the community, surviving spouses might know others — both surviving spouses and couples — who have retired and are living in the chapter area and can help recruit them as new members. Welcoming these potential members and encouraging them to become active members serves national MOAA and local chapters as well as the new members themselves.

**Leadership roles.** Surviving spouses, formerly referred to as auxiliary members, are eligible to serve as chapter officers. Many chapters now have a surviving spouse in an office, sometimes even serving as president.

**Event planning.** Surviving spouses can help organize chapter luncheons or dinner meetings, a task for which they might be well prepared. Those who have been members of officers' wives' clubs wherever their spouses were stationed usually have helped with planning meetings and arranging for speakers or entertainment.

Social and personal affairs support. When a death occurs within the chapter membership, surviving spouses can assist the widow or widower with the sometimes complicated task of changing names on accounts, notifying insurance companies, stopping military retired pay, and applying for Social Security benefits as well as military survivor entitlements. Help with planning a funeral and burial arrangements also can be very useful. A surviving spouse who already has dealt with these tasks can offer support during a time when the recently bereaved member might be feeling overwhelmed and confused. The ability to provide the social support needed to accomplish the necessary adjustments can make the newly bereaved spouse feel more confident and comfortable. Surviving spouses also can help a new widow or widower regain a social life through friendships and organized social events. MOAA meetings and other occasions can provide this for those spouses. Becoming active in a local chapter is a good way to take advantage of this benefit. National membership is a wonderful source of help when questions arise about anything related to the military career of the deceased.

# 5 Defense Bill Issues to Watch from 30 May 2019 MOAA Newsletter

The Senate Armed Services Committee wrapped its annual defense authorization bill markup on May 22. The bill included a range of personnel and benefits issues. Here are five things on MOAA's radar:

**1. Active duty pay raise**: The Military Personnel Subcommittee supported the administration's request for a 3.1-percent pay increase. The proposal matches projected private-sector wage growth in 2019. The pay raise would be the largest in a decade.

TAKE ACTION: Ask Your Legislators to Protect Military Pay and Benefits

2. TRICARE: The subcommittee was silent on any new health care fees for TRICARE beneficiaries. The bill remained silent on the administration's proposal to eliminate up to 18,000 medical billet cuts, effectively providing tacit approval to the idea. Members of the House Appropriations Committee are skeptical of the proposal, and the issue will have to be resolved after the House Armed Services Committee begins work on its version of the defense bill later this month. We continue to engage both chambers throughout the bill's evolution.

TAKE ACTION: Do Not Raise TRICARE Fees

Do Not Dismantle Military Medicine

**3. Housing:** The bill includes a number of measure to address reports of substandard on-base housing as <u>reported by MOAA</u> earlier on.

TAKE ACTION: Ensure Safe Housing for Military Families

**4. Military Survivors**: The committee did not include language to eliminate the widows tax, the dollar-for-dollar deduction of DoD's Survivor Benefit Plan from the VA's Dependency and Indemnity Compensation. In April, MOAA members from across the country visited legislators on Capitol Hill to tell Congress to end the widows' tax. MOAA is looking for lawmakers to file an amendment to repeal the offset.

TAKE ACTION: Act Now to End the Widows Tax

**5. Concurrent Receipt**: The draft text of the defense bill currently does not contain language to expand concurrent receipt. MOAA will continue to press lawmakers to file an amendment to include language to expand concurrent receipt.

**TAKE ACTION:** Support Full Concurrent Receipt For Disabled Military Retirees

# **CONGRESSIONAL LUNCHEON 2019**

On Tuesday, 30 April, 2019, Karl Wilson, Dolly Cherrington, Hans Sachse, and I attended the VCOC's annual Congressional Luncheon at the Capitol Hill Club in Washington D.C. The day was partially subsidized by Patriot's Colony of Williamsburg, and was a fine affair. Karl won one of their two \$50 sign-in awards. We heard from eight of our Virginia Congress men:

- Rob Wittman (1st District) spoke of his 12 year commitment to eliminating the "Widow's Tax."
- Denver Riggleman (5<sup>th</sup> District/Freshman) is a retired AF EM and officer who was most interesting and humorous. He vowed to support military and veterans issues.
- Abigaile Spanberger (7<sup>th</sup>/Freshman of Louisa and Henrico Counties) A UVA grad, she thanked us for our advocacy.
- Elaine Luria (2<sup>nd</sup>) is a supporter of Chesapeake Bay clean-up as a social, health, and military issue. She is supportive of all three of VCOC's issues.
- Jennifer Wexton (10th) spoke of her interest in veterans homelessness.
- Ben Cline (6<sup>th</sup>) supports the "Widow's Tax" issue and reminded us of the shrinking pool of young people capable of serving.
- Don Beyer (8th/Northern Virginia) is a former "Army brat."
- Morgan Griffith (9th/ of the Salem area) was recognized as VCOC's Legislator of the Year.





We heard from eight of our eleven representatives. (No shows because of vote, and other issues, were our own Bobby Scott (3<sup>rd</sup>), Donald McEachin (54<sup>th</sup>) and Gerry Connolly (11<sup>th</sup>). Neither of our Senators attended.

Finally, we recognized Jim Carman as our MOAA staff person most helpful this past year. We then met Christina Ingram, Bobby Scott's assistant who had been in attendance. At the end Mary Lou Wassel, VCOC 1st VP, had her photo taken with Karl and me. She is always a warm and helpful person. All this was a most enjoyable day for the four of us.
