#### WILLAMETTE VALLEY STREET RODS – MEMBERSHIP MEETING

#### **NOVEMBER 1, 2016**

Meeting called to order at 7:15 pm by President Dave LaCompte followed by the Pledge of Allegiance.

#### **OFFICERS REPORTS**

**President:** Dave LaCompte acknowledged that there is quite a bit of business to take care of this evening along with nominations and election of new board members. He asked that each officer give a little information about the duties of their position.

**Vice President:** Mike Vickers stated his duties were to take over in the absence of the President, at meetings and to chair or oversee the various committees such as the Carousel Committee or any other established committee and to bring guidance and information from the committees to the Officers meeting.

**Secretary:** Sharon Crauder-Munz explained that the duties of the Secretary are to take the minutes of the board meetings and the general membership meetings and to pass the information on to the membership by way of newsletter.

**Treasurer:** Paul Geck was not present but the duties of the Treasurer are to keep a record of all incoming and outgoing monies of the club and to establish a proposed budget for the current year to present to the membership.

**Membership:** Jim Palmquist stated that he has been handling the membership for a few years and the duties of the Membership chair is to keep an accurate recording of the membership, prepare a roster of the membership and report on new memberships as they come in.

**Newsletter:** The duties of the Newsletter Editor are to put together information, pictures and items of interest into a newsletter format and send out by e-mail and print to the membership.

Website: Gary Pullen in the webmaster and is planning on continuing as Webmaster. Keeping the website up to date.

Social Chair: Duties are to provide interesting and fun activities for the members to attend.

**Member at Large**: To serve as a Liaison between the members and the officers. To bring questions or comments by members to the board for review, decision and all done anonymously.

**Member Care:** Duties are to send cards to members or their families when there is illness, death or other. Vickie sent cards this month to Charlie Wulfers, Jim & Carol Walz and Russ Strohmeyer.

Historian: Pam Foster announced all the November Birthday people, 27 of them, and wished them a Happy Birthday.

**A-Team Report:** Still meeting on Thursday evenings. Need more workers to work. He hopes to see everyone there. Jeff reminded everyone that The Ace of Spades movie will be shown in Aurora from 2 pm to 6 pm.

**A-Team Fundraiser:** No fundraising going on at present time.

**Scholarships:** Mark Scott reported that he has not heard back from the latest scholarship recipient but that he passed on information about coming to our membership meetings.

**Carousel Cruise:** Warren will no longer be that Carousel Cruise Chair and is asking for someone who would be interested in chairing for next year. He thanked everyone who helped with the cruise and commented that we always think it will be a disaster but we always come through to have a successful event. Warren raffled off a large laminated poster for the Carousel Cruise. Bids were received from \$10 to \$40 and the winning bidder at \$40 was Rod Beach.

There was a question regarding the amount of money that was taken in this year at the cruise after expenditures how much will be donated to our charities. According to the last print out from the Treasurer we took in 16,738.00 and paid out in expenses \$11,258 leaving us a balance of \$5,480. Warren noted that we had paid out \$6,000 approximately for expenses from last year's Carousel Cruise because of some of the bills coming in late. It was also discussed that we set \$1400 aside from the Carousel income to pay the City in case we get a bill from them. It was noted that we will be giving out the same percentage to the charities as last year.

**Christmas Dinner Report:** Make sure you get your reservations in with your food choice and money by next meeting. There will be a Holiday decoration contest, gift exchange with a \$10 limit (or more), "Who is it Game" and the menu is Prime Rib or stuffed Turkey Breast. The time is 6-9 pm. Dinner will be at 6:30 and will be held on Saturday, December 17th.

There was discussion on new officers not having to pay dues as an incentive to run for an office. Glen Rader opened the discussion by saying he feels that everyone including the officers should have to pay dues to be part of the club. Rob stated he agreed with Glen and said "simply put you're a member, pay your dues, it goes for club expenses." Mark stated he would be for it if it was for a hardship like a serious illness or something on that order for a member, but not just because you're an officer. After further discussion it was decided that no incentive necessary.

Member At Large: Glen Rader was nominated for Member-at-Large and Glen has accepted the nomination. With a show of hands, Glen Rader was voted in.

Newsletter Editor: No vote necessary but Rich Bailey expressed interest in doing the newsletter for the new year. Rich will be contacted to see if he is still interested.

Website: Gary Pullen will continue as Webmaster.

Social Chair: Greg Smith has volunteered to do the Social Chair position. With a show of hands a majority vote was cast for our new Social Chair Greg Smith.


