In signing this waiver, I or the parent/quardian assume, the inherent risks involved.

**WAIVER:** I, the undersigned, realize that there is a risk of bodily injury while participating in any sport. I understand that a horse can never be entirely predictable. I am aware that the sheer size and the weight of the animal as large as a horse make working around them a particularly risky sport to choose. As in any sport I choose the learn, I realize that it is my responsibility to learn safe practices within the sport and follow the directions and heed cautions whenever I participate in that sport. I am prepared now, and in the future, to accept responsibility for all of the risk of personal injury or death that is possible as I learn to handle and ride a horse. I would actively pursue horseback riding lessons elsewhere if I did not receive instruction here. I understand that I am waiving all my rights to a lawsuit resulting from any act, including but not limited to, negligence on the part of the instructor, the owners, or their employees, trustees or representatives, that results in my own injury or death. I also request that my heirs, representatives and dependents refrain from bringing forth a lawsuit on my behalf, or for themselves, for I choose to assume responsibility for my risk in this sport. I authorize the instructor to summon professional emergency medical transportation for the purpose of transporting me to a medical facility in the event of injury.

Safety Rules & Code of Conduct:
1. Stop, look and listen, no horseplay near horses. Always use safety around horses.
2. Never stand directly in front or behind a horse.
3. Never HAND FEED a horse. All treats should be put in their feed bucket.
4. Check tack before mounting.
5. Always use halter and lead rope to tie and lead horses.
6. Wear proper attire around horses, including boots and helmets.
7. Always close gates when in the paddocks.
8. No climbing on fences or gates.
9. All riders must wear helmets when participating in horseback riding.
10. NO SMOKING OR USE OF DRUGS ON PREMISES.
11. No profanity.
12. Proper respect to parents, stall and other equestrians is expected at all times.
13. Respect others property, including tack and equipment.
14. ALWAYS ASK, NEVER ASSUME.
15. Put all equipment away in its proper place.
16. Do not approach an unfamiliar horse.
17. CLEAN UP AFTER YOU AND YOUR HORSE, INCLUDING MANURE.
18. Please put all trash in garbage cans. AND RECYCLE.
