(applicable to reservations on pup from upcoming Litter) Buyer understands He/She is purchasing this dog as a Pet/Companion ONLY-Not for Breeding purposes. **All deposits are non-refundable** unless there is no pup of your desired color/gender on the upcoming Litter in which you are reserving a pup from. If Buyer chooses not to purchase Pup from said Litter that is available and fits gender/color criteria, the Buyer forfeits deposit. Seller reserves the right to cancel the Contract and sale of Dog at anytime prior to Dog leaving and Seller will issue refund immediately upon doing so.

Pups to be Shipped MUST be Paid in Full by 7 weeks, prior to Shipping .Buyers picking up in person @ 8wks of Age must bring Cash for Balance.. We will accept personal checks for Deposits and for pay-off Balance only if it is sent in a timely manner so that the check can clear before the dog is shipped.. Check sent by the 6th week allows time for it to arrive, be deposited and clear Sellers acct, enabling Seller to purchase crate, Health Cerf and pup can be shipped on time. Option to Wire or PayPal are available as is direct deposit. All Pay-Pal or wire fees are at the Buyers expense. We ship pups at 8wks of age, weather permitting and do not charge a airport trip fee unless Buyer cannot accept pup at that time. If we have to hold the pup past 9wks of age, there will be a kenneling fee of 25.00 per day.

Section 2. Hip/Health Guarantee

We guarantee the dog to be in good health, free of any life threatening diseases. Buyer has 72 hrs from the time of taking possession of pup in person or from the time Pup is dropped off at Cargo facility to certify such Health by a licensed DVM. We suggest scheduling the Vet appointment ahead of time so as not to miss the 72 hr window as claims after 72 hrs are void. This does not apply to hips, just overall health and communicable diseases. We do not guarantee against Panosteitis, umbilical hernias, ears to stand, correct dentition, testicles to drop, etc, on a Ltd Registration Dog/Pet Dog. We guarantee hips to OFA Excellent to Borderline. Hips must be X-rayed by a certified DVM between 24-28 mos and all findings must be sent to OFA for certification. The Dogs Registered name GIVEN BY THE BREEDER and AKC reg number must be present on the Xray, NO EXCEPTIONS! Should the OFA results not fall into the range of our guarantee, We do not require Dog to be returned but do require Buyer to send AKC papers back and proof of Spay/Neuter before a We will send a replacement dog of equal value. Buyer is responsible for all Shipping and Vet costs, including Crate and Health Certificate.

BUYER PLEASE NOTE- Things that void our Guarantee are as follows:

1. Pup is registered with AKC is not the name not given by Breeder and/or Pup is registered to person OTHER then who is listed as Buyer on Registration papers. (The Exception to this if pup is a gift within the Buyers family and this must be noted in the Contract)
2. Dog is bred
3. Dog is Sold or Given away
4. Dog is spayed or neutered under 10 months of age.
5. Dog is found to be overweight or Buyer has been allowing excessive jumping or strenuous exercise under 1 yr of age (such as training for Agility or jogging, running with pup) as these things can do damage to the joints of a growing pup.
6. If AKC registered name given by the Breeder/Seller and the registration number is not on the radiograph
7. If the dog was in or near Heat cycle when Radiograph was taken. For 6 and 7 we would require Buyer to retake Xrays with correct info and/or heat timing of 2 mos past beginning of last heat.
8. If Dog is found to be abused, mistreated or neglected. Negligence to include but not limited to allowing dog to run at large, not providing adequate shelter, fencing, etc.

Section 3. Care of the Dog The Buyer agrees to provide good care of this dog by providing proper nutrition, sanitary facilities, adequate shelter from the weather and a proper, safe enclosure to keep the dog safe from traffic, other animals, wandering, etc. Obedience and socialization are extremely important and highly recommended.

Section 4. Entire Agreement, Severability and Governing Law

This Contract is non-transferrable and between only the person listed on this contract as Buyer and person listed as Seller.
