National Guard arrives in Flint to help with water crisis

Last week, Governor Rick Snyder summoned the National Guard to assist with the Flint water crisis. Services will be rendered through an Executive Order, utilizing the force to distribute supplies at five different resource sites. The announcement comes a week after Snyder declared a national emergency to increase aid efforts throughout the city. "As we work to ensure that all Flint residents have access to

clean and safe drinking water, we are providing them with the direct assistance they need in order to stretch our resources further," he said in a press release. "The Michigan National Guard is trained and ready to assist the citizens of Flint." National Guard representatives arrived last Wednesday, and could soon be joined by various federal agencies like

Explosion at Ecorse restroom caused by gas leak

A public bathroom explosion at Dingell Park in Ecorse was caused by a gas leak, officials confirm. The explosion occurred around 7 AM last Thursday, causing a shutdown of surrounding roads until 3 PM.

According to Ecorse Sgt. Narda Bruno, police received a call from residents reporting a gas smell in the early morning hours of January 14th. The Ecorse Fire Department responded, in addition to DTE Energy, though the com-

pany reported that no issues had been found prior to the incident.

"[DTE] was called out at approximately 3 AM, but didn't find any issues. The leak was

LANSING, Mich. - Gov. Rick Snyder today released all emails he sent and received regarding Flint from Jan. 2014 through Dec. 2015.

On Tuesday evening, he said during his State of the State address:

"Tomorrow I will release my 2014 and 2015 emails regarding Flint to you, the citizens, so that you have answers to your questions about what we've done and what we're doing to make this right for the families of Flint. Anyone will be able to read this information for themselves at Michigan.gov/Snyder. Because the most important thing we can do right now is to work hard and work together for the people of Flint."

Asked if she believes Gov. Rick SNYDER should be prosecuted, as some activists have suggested, Robinson responded, "I don't give a damn about the Governor."

Robinson then continued that ultimately, "the buck stops there in the Governor's Office."

The second-term lawmaker said she's thought about writing a personal letter to the U.S. Department of Justice about Flint.

The department is already looking into the water crisis.

As for Oversight Committee hearings in the House, Oversight Chair Ed MCBROOM (R-Vulcan) has said his committee will hold a hearing on an upcoming audit of the state's Office of Drinking Water and Municipal Assistance (See "House Oversight Panel Planning Hearing On Audit Of Water Office," 12/30/15).

Michigan poisons poor to save a few bucks

Flint, Michigan is impoverished. The auto plants have closed. Forty percent of the city's 100,000 residents live below the poverty level. It is majority minority. It's been in fiscal crisis since 2011, with the state taking over budgetary control and a state-appointed "emergency manager" driving policy focused on cutting spending.

Flint residents are Americans, but like many impoverished Americans they are forgotten. And state officials led by Gov. Rick Snyder have shown that they consider the residents disposable.

In Flint, the water supply has been poisoned by lead. Police are now delivering bottled water from door to door. But it may be too late for hundreds of kids who are already suffering from elevated levels of lead in their blood. The damage done is irreversible with lifelong consequences, including lowered intelligence and long-term mental and emotional damage.

How did this happen? The emergency manager - accountable only to the governor and state officials — decided to save money by switching Flint's water supply from Lake Huron to a cheaper source, the Flint River. Only the river had been poisoned by waste from nearby factories for generations. The toxic wastes not only turned the water brown, it corroded the aged pipes of Flint's water system, unleashing lead into the water. Federal law required that the water be treated, but that would have cost \$100 a day, so it was not done.

Parents began to complain of rashes and hair loss. The state's environmental quality agency denied there was a problem. High-level state officials knew that the water supply was lead poisoned for six months before declaring an emergency. Finally, a Flint pediatrician tested the blood of children and discovered lead levels double and even triple the prior amounts. State officials denounced her work before realizing the truth could no longer be hidden.

Finally, Gov. Snyder ended the denial. He declared an official emergency, and four days later called for delivering bottled water. The head of his environmental agency resigned. Snyder apologized for the catastrophe, but calls for him to resign continue to build.

Flint is not alone. Across America, in ghettos and barrios, reservations and rural valleys, the poor are isolated and too often forgotten. Systems basic to civilization plumbing, water systems, school houses, garbage collection and treatment, roads and public transport — are in squalor, lacking even the investment to keep them up to minimum standards. Impoverished neighborhoods often lack hospitals, grocery stores, and decent public spaces. The poor are left to fend for themselves, rising to attention only when violence breaks out, when innocents are shot, when tragedies like Flint become public.

The cost of this callousness in lives lost, disease, mental damage, crime, drugs, hopelessness — are immense. This isn't about money. We pay more on the back end — in prisons and emergency rooms, cops and guards, prisons and addiction centers — than we would have to spend on the frontend investments that would give every child a chance.

Conservatives continue to call for dismantling environmental regulations. They slash budgets for policing violations by corporations or cities. They want to slash support for poverty programs and blockgrant them to the states and localities. The next time you hear that rap, think of Flint, its poorest children betrayed by state officials. Think of Flint deprived even of safe water in order to save a few bucks.

Think of Flint and investigate your own community - the horrors of Flint are not exclusive to that city.

Uniform

When you're playing a team sport or a part of an organization, people need to be able to identify you as a part of the team. It like a trademark that we integrated it into almost everything and it became a part of our identity.

In order for a game to be played effectively, teammates wear uniforms. This allows you to easily identify your teammates for support and you can easily spot your opponents. Without uniforms, there would be lots of confusion and probably pandemonium.

In society, we often assess people by their uniform. But since people generally don't wear uniforms as normal attire, we judge by outer appearances. Whether intentional or not, consciously or not, we tend to make some determinations about people based on what they are wearing.

We also assess according to behaviors and other obvious attributes. What kind of message are you conveying? According to your own persona and attire, whose team are you identifying with? What does it make people think about you? We often say we don't care what people think about us. But whether we care or not, some people notice, and sometimes it matters. This is why for the most part, you wouldn't wear dirty smelly clothes to a job interview or celebratory event. Generally, we try to dress for the occasion we are attending.

In the Bible, I imagine that soldiers who fought in armies wore similar amour designs and colors. This would have helped them to know who to kill and who not to kill. Other than that implication, the Bible does not speak on uniform wearing.

However, the Bible does tell us how we can recognize each other: "You can identify them by their fruit, that is, by the way they act. Can you pick grapes from thorn bushes, or figs from thistles? A good tree produces good fruit, and a bad tree produces bad fruit. A good tree can't produce bad fruit, and a bad tree can't produce good fruit (Matthew 7:16-18NLT). This was pointed out because 'false prophets were coming disguised as harmless sheep but are really vicious wolves.' They were told to beware (v.15).

With that in mind, mind your fruit. It's your uniform so to speak. Uniforms are a sign of solidarity and cohesion. Be mindful of who and what you are representing. What's your uniform?

SHELBY'S LITTLE KNOWN BLACK HISTORY FACT

Constance Baker Motley was the first black woman to be appointed as a federal judge?



Selected by President Lyndon B. Johnson at the advisement of Senator Robert Kennedy, Motley became head of the Southern District of New York in 1966. A child of Caribbean immigrants/community activists, Motley was drawn to civil rights issues at an early age –attending Fisk University and later the Columbia School of Law.

Serving as Thurgood Marshall's law clerk upon graduation, Motley eventually joined the NAACP's Legal Defense and Educational Fund where she drafted the original Brown v. Board of Education complaint. As the lead attorney in several civil rights cases, she became a key legal strategist who represented student activists, Freedom Riders and even Martin Luther King, Jr. In 1962, Motley became the first African American woman to argue before the U.S.

Supreme Court, gaining a victory in Meredith v. Fair which allowed James Meredith to become the first black student admitted to the University of Mississippi.

Four years later, Motley reached the historical highpoint of her career as a federal judge, ultimately becoming senior judge in 1986 – a position she held until her death in 2005. Most remembered as a chief legal voice during the Civil Rights Movement, Motley also championed for women's rights – demonstrated through her notorious 1978 ruling that allowed a female reporter to enter the New York Yankees' locker room.

In the end, Motley's life stands best summarized by her famous quotes: "Something which we think is impossible now is not impossible in another decade."

Former Police Officer Sentenced to **Over 260 Years For Raping Black Women**

A jury found former Oklahoma City police officer Daniel Holtzclaw guilty Thursday of some of the most serious charges against him, including sexual battery, forcible oral sodomy and rape.

Holtzclaw faced 36 counts. He was found guilty on 18.

The former officer cried openly in the courtroom and rocked in his chair as the verdict was being read. Jurors deliberated for more than 40 hours over four days.

The Oklahoma City Police Department welcomed the verdict. "We are satisfied with the jury's decision and firmly believe justice was served," it

Sentencing is set for next month.

His trial touched upon the explosive intersection of race, policing and justice in America.

These racial dimensions energized civil rights and women's activists to draw attention to the case. Before the verdict was read, Oklahoma City NAACP President Garland Pruitt was concerned about the jury in the case, he told CNN affiliate KOCO.

"We're very disappointed, very, very disappointed, that we don't have any minorities on there," Pruitt said. "We're not saying justice can't prevail, but we can be suspicious of it being (run) in a manner."

Benjamin Crump, president of the National Bar Association, was also monitoring the case. He represented the families of Trayvon Martin and Michael Brown. Martin, a black teenager, was fatally shot by George Zimmerman, who was acquitted of charges in 2013. Brown was killed by an officer in Ferguson, Missouri, in 2014.

"We will be here to make sure that this is not swept under the rug," Crump told reporters after attending a portion of the trial last month. "We come here to stand with these 13 victims of rape, who happen be African-American women, to say that their lives matter, too."

In the first pool of 24 potential jurors, there were three black men, but they were not picked for the jury. Two alternates have Spanish surnames. About 70 potential jurors were initially called in for the case, the affiliate reported. Prosecutors would not comment on the jury composition.

At the center of the case was how all victims, ages 17 to 50s, had criminal histories of drug use or prostitution, according to The Oklahoman newspaper.

Teachers are the glue holding the Detroit schools together, yet they took a 10 percent pay cut, have had no pay increases for a decade and have had constant cuts in their health care benefits."

the Department of Health and Human Services, the Environmental Protection Agency, the Department of Housing and Urban Development and the Army Corps of Engineers. American Red Cross volunteers also remain active throughout the city, venturing door-to-door to inform residents of where they can find free bottled water, filters, and home water testing kits.

In recent months, the Flint crisis gained national attention. with many activists calling for Snyder to resign or be removed from his position as governor. Nevertheless, the issue dates back as far as April 2014, when the city's water source was switched from the Lake Huron system in Detroit to the Flint River. Today, Synder remains under fire for initiating the changes despite knowing its potential dangers - actions that exposed Flint residents, mainly children, to toxic lead levels in the drinking water (some estimates report that quantities measure more than 900 times the EPA limit, leading to numerous cases of juvenile lead poisoning).

Adding fuel to the fire, the city and surrounding areas have reported a recent rise in Legionnaire's disease. 10 out of 87 cases have been fatal in Genesee County, though details on whether the outbreak can be linked to the water remain unconfirmed.

In a statement last week, Flint Mayor Karen Weaver approved state efforts to bring resources to the area, but maintains that more assistance will be needed "to cope with this man-made water disaster." U.S. Congressman

Dan Kildee - a Flint native echoes Weaver's thoughts, further expressing that Michigan has a "moral obligation" to immediately repair the crisis in Flint.

"The residents of Flint have suffered a terrible tragedy and I will tirelessly advocate to get them the resources to deal with this crisis," he said. "I was able to talk with President Obama after the State of the

Union...and reiterate my call for federal assistance. I encourage Governor Snyder to request additional resources from the federal government, and I stand ready and willing to work with him to get Flint the help it needs."

For the past 25 years, the All Saints Soup Kitchen and Food Pantry has worked to alleviate hunger in the community. The faith based organization is an extension of All Saints Catholic Church in Detroit, living by the motto: "In the interaction with our brothers and sisters, we are providers of nourishment to both body and soul."

Run by community members and volunteers from local parishes, the All Saints Food Pantry is open to the public Tuesdays 10 AM - Noon, and Wednesdays and Thursdays 1:30 PM - 3 PM. Clients will usually find fresh produce, canned goods, frozen and refrigerated foods — much of which is provided by Gleaners

Community Food Bank and Forgotten Harvest.

Overall, All Saints serves specific zip codes, but residents from outside zones will be serviced on a one time emergency basis (they will then be referred to a facility in their region where they can receive future food). Per pantry policy, no one is turned away; though patrons are required to bring proper documentation in order to receive food.

"Those who come in do need to provide proof of identification, as well as proof of residency," said All Saints member Kathy Katalina. "Kids can bring a birth certificate, their Medicaid card, etc. That's it, we don't require that they have a referral to come. Everyone is welcome."

Additionally, the All Saints Soup Kitchen is open every Monday, Wednesday and Thursday from 11:00 AM - 12:30 PM. Meals include a main meat, vegetable, salad, bread, fruit, dessert, and a choice of a hot or cold drink. The organization successfully feeds 100-200 people per day through their soup kitchen, and remains dedicated to answering "the call to feed Christ's lambs."



Tigers Transformation Continuing

The transformation is continuing for the Detroit Tigers as new Vice President and general manager Al Avila who replaced the fired Dave Dombrowski last season is working overtime to bring winning back to the states professional baseball team. As this past late Monday night, free agent outfielder Justin Upton has agreed to terms with the Detroit Tigers on a six-year deal worth \$132.75 million, per Bob Nightengale of USA Today. Upton hit .251 with 26 home runs, 26 doubles and 19 stolen bases in 150 games for the San Diego Padres in 2015. He also adds to a need in left field a position the Tigers finally fill before going to spring training in February.

Upton was ranked as the seventh-best free agent in baseball this offseason by many covering major league baseball including yours truly. The Tigers will be Upton's fourth team in the last five seasons, however, at 28 years old, Upton is one of the youngest free agents on the market. The No. 1 overall pick in 2005 has played in at least 149 games in each of the last five years. For the last seven seasons he has averaged 30 doubles, 25 home runs, 16 steals, 89 runs and 80 RBI in 148 games per year while hitting .275 during that span.

After a disappointing 74-88 campaign in 2015, owner Mike llitch has again opened up his wallet this offseason, having also signed pitcher Jordan Zimmermann to a five-vear. \$110 million contract. Upton and Zimmermann will join a Tigers team that will expect to have a bounce-back seasons and in the running for a Central Division title and a playoff spot as Miguel Cabrera, Victor Martinez and Justin Verlander, all who battled through injuries in 2015. Yes, the Tigers finished last in the AL Central in 2015, which was a disappointment as they'd won the previous four division titles in the seasons past.

Tigers have now added Upton, Cameron Maybin and Mike Aviles on the offensive side. They signed starters Jordan Zimmermann and Mike Pelfrey, and aided a chronically poor bullpen by acquiring Francisco Rodriguez, Mark Lowe and Justin Wilson. 



Romulus Mayor Burcroff gives look back at 2015 successes during State of the City Address



ROMULUS - Mayor LeRoy D. Burcroff gave his third State of the City presentation on Tuesday, January 12, 2016 at the Romulus Athletic Center in front of an audience comprised of residents, business people, City boards and commission members and other community leaders. The Mayor, making his entrance accompanied by Romulus High School varsity cheerleaders and football players, gave a football-themed/"halftime report"-style talk highlighting the accomplishments made over the first two years of his four year term in office.

Some of the most significant highlights of 2015 included:

Local Neighborhood Streets

Every quarter this year has included a component of addressing the issue of crumbling local streets. The Mayor reported that a committee made up of local residents have assessed the condition of the streets and are now holding town hall meetings for those that want to learn more about the issue and solution.

Enhanced Communication

Improving communication and Creation of US Ecology Dog Park awareness of City programs and events has been a consistent theme of the Burcroff Administration. Some communication highlights of 2015 have been the purchase of a new cable studio, news updates during the Mayor's Report at City Council meetings and implementation of a monthly enewsletter, as well as the creation of a mobile app for residents to be rolled out early this year.

BS & A Conversion

When Mayor Burcroff was elected in 2013, the City was using two different financial management software systems. In 2015, City programming was overhauled to use only one primary program called BS&A. Efficiencies were gained through this transition and residents are now able to access their water and tax bills online via a link under the "How Do I..." section on the City's website (www.romulusgov.com).

34th District Court Proposal

The City of Romulus is the host community for the 34th District Court. This group submitted their report and were able to spearhead the creation of a few new events in 2015 including theme nights at Sounds in Downtown, Free August Youth Days at local parks and the re-instating of an adult co-ed summer softball league at Elmer Johnson Park, as well as many other fun initiatives.

Re-Opening of St. John's Lodge Park (Formerly Park #1)

Park #1, located near the intersection of Beverly and Henry Ruff roads on the north side of the City, was reopened and re-named "St. John's Lodge No. 44 Park" in honor of the fraternal organization, St. John's Lodge No. 44 Free and Accepted Masons, Price Hall Affiliation. The Lodge has a long standing history of service in the community and assisted in the painting and reconditioning of the

This is the second dog park opening within the City, both during the Burcroff Administration. Romulus-based business, US Ecology sponsored the project that repurposed an old, closed and dilapidated tennis and roller hockey court by using City staff to remove the old surface and install new sod and canine exercise equipment which, along with top soil and a walking path, was all purchased by US

Paint the Town Project with Westside Beer Distributors

Another example of a public/private partnership is with Westside Distributors, who sponsored supplies and had employees volunteer to help repair and paint the home of a local resident and veteran. Rolling Thunder Chapter 5 members, city employees and members of local St. John's Lodge #44 were out for two weeks prior to the painting removing extensive and overgrown brush which covered most of the home's exterior, power washing to remove old paint, and repairing and replacing rotten wood on the structure. On the day of the final painting, Westside Distributors had over 40 employees volunteer on their own time to complete the project.

Also the implementation of a new rubbish and recycling contract with Waste Management that included a substantial long-term cost savings, improved services and has resulted in a 40% increase in residential recycling.

Many new community programs have been added during the last year including Brunch with the Bunny, Fall Family Fun Festival, the Downtown Scarecrow Contest, Dinner with Santa and a new location for the annual Tree Lighting Ceremony, Free Movies in the Park utilizing a newly purchased, state of the art, 30-foot inflatable movie screen, and enhancements to existing events such as a Black Month Bus Tour of the City and Eco-Fair and Farm Tour during Earth Day. The Senior Center held fundraisers to build a salon and they won a record number of medals at the Downriver Senior Olympics. Beautification Awards were given out to homeowners who had exemplary landscaping during the spring and

businesses and the Mayor also went summer and for outstanding light displays and decorations during the Christmas season.

Public Safety

The annual Hometown Heroes awards ceremony that was started by the Public Safety Department were expanded to include residents and community members. Public Safety officers partnered around the community on school projects and were out doing Random Acts of Kindness. Citizens Academy was started and graduated two cohorts of residents and business owners that now have a more inside look and appreciation at our Public Safety operations within the City. Crime statistics overall are down and 2015 also saw a large increase in neighborhood safety patrols. Cost savings were realized with creative purchasing for two rescue vehicles and one animal control vehi-

Financial Services

Successes for the City's finances included the approval of a long-term Teamsters labor contract with savings and improvements in customer service through the elimination of Furlough Days. Keeping a balanced budget with a modest fund balance, underspending what the City was budgeted for, and an increase in property values show a positive financial trend for the City.

City of Taylor host 'OPERATION FLINT'



Water donations are being collected for Flint residents

"Operation Flint" -- the City of Taylor's campaign to collect cases of donated bottled water and truck it to Flint -- is underway and moving along at break-neck speed.

According to Home Depot West, 11100 Telegraph Road, 14 pallets full of cases of bottled water have already been donated to the campaign. Mayor Rick Sollars announced this morning that Masco has agreed to donate 500 cases. A second tractor-trailer has already been requested from Load One, given the heavy interest in the program.

Fox 2's Roop Raj did a report live from Home Depot this morning.

The City, in cooperation with Home Depot West and Load One, is holding the bottled water drive (cases only) to benefit the beleaguered City of Flint through Friday, January 19-22. Home Depot is open from 6 a.m. to 10 p.m. daily.

President Barack Obama declared a state of emergency Saturday in response to the water crisis in Flint, where thousands of residents have been exposed to toxic amounts of lead. The action enables FEMA to provide up to \$5 million in federal aid to help provide water, filters and other items for up to 90 days to residents whose water has been contaminated since the city switched water supplies in 2014. But we know the FEMA help isn't going to be enough.

Taylor's campaign is simple: Residents can donate cases of bottled water by either dropping them off or buying them directly from the Home Depot West location near the corner of Goddard and Telegraph Roads. Anyone interested can purchase the water at Home Depot for \$3.74 per case and employees there will stack it in

a Load One truck located in the parking lot for transport to the Red Cross in Flint.

Businesses or organizations can want to contribute more can buy cases of water by the pallet for \$291.48. Load One estimates that one semi-tractor trailer can hold about 26 pallets. Interested residents can purchase cases of bottled water anywhere else and just drop them off at the location.

Taylor still plans on making a huge "final push" in this campaign on Friday (January 22) when elected officials and interested residents spend the entire day at Home Depot helping collect donations and load the truck. They will begin about 8 a.m.

The idea for the drive was started by a staff member at the City of Taylor's Department of Public Works and relayed to elected officials, who got on board and immediately started coordinating the details of the campaign.

"We just want to be a good neighbor," Mayor Sollars said. "This campaign isn't about blame. This is about helping someone who needs help. We want to challenge every resident, business and organization in Taylor to get involved. In fact, it would probably be a great idea if other communities got involved, too."

From celebrities like Cher and Michael Moore all the way down to a school in Detroit – all of whom sent donations to Flint – individuals and organizations have been attempting to help during this crisis. The Red Cross in Flint is coordinating the water distribution through the communities' local fire stations.

Too soon. As the opening credits start to roll, you wonder why the producers didn't' give moviegoers a real break between "Ride Along" (2014) and "Ride Along 2" (2016). Two years is not enough time to make audiences yearn for more, not enough time to take this franchise to the next level.

Bad Boys premiered in 1995. Eight years later in 2003, Will Smith and Martin Lawrence teamed up again and the vacation did everybody a world of good. Though this series is not nearly as slick as the aforementioned, the Hart and Cube duo have similarities. Awkward cop buddies. Haphazard, unorthodox crime-fighting. Oh, and there's the setting. Hart and Cube have taken their show to South Beach, where the sun shines on everything, except the script.

The goofy, annoying Ben Barber (Hart), who once patrolled the streets of Atlanta with his curmudgeon brother-in-law-to-be police detective James Payton (Cube), has been sidelined. Payton and his new partner (Tyrese), who are undercover, are on the verge of arresting a drug dealer. When the tables get turned on them, and James has the barrel of a gun stuck in his gut, it is the flighty, silly Ben who rescues him. And so it goes, time after time, James degrades Ben, but in the end the scamp comes through

James finds a flash drive with data that can't be unlocked. He tracks the encrypted drive to a geek/hacker in Miami, named AJ (Ken Jeong, of The Hangover series). As they hunt him down, they're helped by tough-as-nails Miami homicide detective Maya (Olivia Munn of "X-Men: Apocalypse"). Clues lead to a local, wealthy, well-respected entrepreneur, Antonio Pope (Benjamin Bratt of "Miss Congeniality"), who is secretly a crime lord moving lots of drugs and guns. Can the boys make him pay for his crime? We all know the answer.

There was something so fresh about the original Ride Along. The cocky, buffoonish, diminutive comedian Hart played against the dour bad-attitude ex-NWA member. The pairing was box office gold and vaguely reminiscent of Abbott and Costello.

Screenwriters Phil Hay (Clash Of The Titans) & Matt Manfredi (Clash of the Titans) have failed miserably at reinventing the comedy crime genre. Their script is feeble and formulaic. Plot pieces fit together too easily and subplots don't amount to much (Barber is in the midst of planning his wedding and Sheri Shepherd plays a wedding planner who is a bully.)

There isn't one memorable line of dialogue worth passing on. And that's a shock considering Hart is a master improviser. The screenplay's one engaging gimmick: Barber, who is a champ at playing Grand Theft Auto, uses his video game driving skill when he and Payton are being chased by hoods with guns. Barber commands the steering wheel, and speeds off like Mario Andretti. Some of these sequences are

shot in a digital mode, and that's about as inventive as the film gets.

Director Tim Story ("Barbershop," "Think Like a Man") brought verve to the first Ride Along. It was edgy, funny and outrageous at points. It's almost as if he has run out of fresh ideas, minus the chase scenes. Most of the time, Hart and Cube look flat, are poorly choreographed and staged, and they stare into the lens like they're hoping for direction. Once in a while, Cube sucker punches a guy, or Hart shoots the wrong person. You chuckle, maybe laugh for a hot second. But you want more, steady, hilarious humor.

Cube's performance is dry like the character. Sherri Shepherd, as a domineering and emasculating wedding planner is obnoxious, but not funny. Tika Sumpter is sweet as the impending bride and deserved more screen time. It's almost painful to watch an actor of Benjamin Bratt's caliber in a throwaway movie like this. Yes he brings gravitas to his villainous character, but it's clearly a waste of his talent. Maybe it's time to find a new agent?

Granted Hart is the comedian of the hour. He singlehandedly has made comedy buddy movies a cottage industry, and he's the common denominator. That said, it might behoove him to take a hiatus, work on his craft and bring his game up a notch. He has the potential to rise higher. Now, before he gets a reputation for being another Adam Sandler.

Count on this comedy to find a loyal audience. Hart has 21M followers on Facebook, 24.6M follow his Tweets. His fans will support him. But they deserve better

The "Bad Boys" and the "Beverly Hills Cop" series too gave their franchises room to breathe. Maybe the Ride Along team doesn't have to wait eight years for the next installment. But two years is cramping everyone's style.
