Much has been written recently about Donald Trump's refusal to disavow the KKK and its former Grand Wizard David Duke; about Trump's mocking of presidential candidate Marco Rubio, a son of Cuban immigrants, for quenching his thirst during a Republican rebuttal to the State of the Union speech three years ago; about Trump directing his followers to raise their right arms in a Hitlerlike salute and to vow to vote for him; and about how rich, powerful and smart Trump thinks he is.


One important story, though, has

drawn surprisingly little attention during this presidential campaign: Donald Trump's illegal sexual harassment of women.

On January 31, 2016, the Washington Post reported that a 26-year-old lowa campaign worker filed a complaint with the Davenport Civil Rights Commission claiming that when she and another female coworker met Trump last summer, he looked them over and said "You guys could do a lot of damage," implying that their

Marijuana arrests outnumber those for violent crimes, study finds

marijuana arrests outnumbered all those for violent crimes last year.

The study, released on Wednesday by the American Civil Liberties Union and Human Rights Watch, found that arrests for marijuana were up 13.6 percent as compared to all violent crimes, including rape and murder.

"Most people don't think drug possession is the No. 1 public safety concern, but that's what we're seeing," said Tess Borden, a fellow at Human Rights Watch and the ACLU. Borden also found that the drop in crime over the last few decades has occurred even as arrests for drug-related crimes continue to rise.

A new study has found that Most concerning is the fact that a disproportionate number of the arrests are African-American, and the study found that the disparity between white and black arrests for marijuana persists no matter the concentration of minorities in an area. African-Americans are also more likely to be prosecuted for small amounts of marijuana meant for personal use, according to the study, which can lead to overwhelmed courts.

> What's more, the high rates of marijuana arrests stand in stark contrast to shifting public perception of the drug, which has been legalized in several states, with support for legalization growing across the country.

Republicans Are Willing to Dance with the Devil to Win the White House

Speaker of the House Paul Ryan (R-Wis.) is anticipating a Trump win in November. Or, at least, he is preparing for it. He says that if Republicans hold sway in the White House, the House and the Senate, he plans to use budget reconciliation to repeal the Patient Protection and Affordable Care Act (also known as Obamacare) and give tax cuts to the wealthy. Ryan says he will not even attempt any bipartisanship, as he shoves his regressive agenda down the throats of our people. Instead, he says that he can make it work, especially if he has a Trump White House.

This is, perhaps, why Republicans who appear to have at least a little bit of good sense are going for Trump's nonsense. They know that Mr. Trump, with his head in the cloud and his rhetoric in the gutter, will let them get away with anything they want. He will agree to their tax cuts, because they coincide with his agenda to reward the wealthy. Trump will go along with cuts to Obamacare, because he wasn't loving it in the first place. He will let conservative Republicans hold sway, especially if they reward him with their votes in November.

Paul Ryan calls his plan a "Better Way" policy agenda. It is an aggressive move that assumes that Republicans will control both the House and the Senate. They might not - if people vote, and vote down ballot, there is a real chance that Democrats can control the Senate. The House is a much bigger challenge, and it is likely that Republicans will continue to hold sway in the house. But there are too many folks who say they won't vote, and their votes could make a real difference. In Ohio, Wisconsin, Michigan and Florida (among other states), those who choose to refrain from voting are really voting for a Trump-Ryan agenda.

The attack on Obamacare is especially problematic. While the President's Affordable Care Act is clearly flawed, it expanded health insurance for more than 20 million people. It isn't the desired single payer care, but it provides opportunity and takes the first step in expanding the social contract since the Roosevelt years. The Affordable Care Act (ACA) can

be used as a foundation to expand health insurance coverage and, in my mind, get us closer to the ultimate goal of a single-payer system. But legislators rejected the singlepayer plan that Senator Edward Kennedy (D-Ma) proposed for decades. The Affordable Care Act is a compromise. We need to move forward in improving the ACA, not backward in repealing it. Trump and Ryan would restrict access to health care instead of expanding it.

According to Politico, Paul Ryan thinks that a divided government contributes to gridlock. He'd be happy if the presidency, the House of Representatives, and the United States Senate were all controlled by Republicans. What about the rest of us? Does he see our voice in this? Not according to Ryan. He tells Politico "I'm tired of divided government. It doesn't work very well." He seems to ignore the fact that there are legitimate differences among legislators and that these differences need to be worked out. He is uninterested in compromise. Instead, he wants to shove his position down the throats of other people.

Paul Ryan has explicitly called Donald Trump a racist. He has eschewed many of his policies. Other Republicans have been openly repulsed by their bellicose standard bearer and disturbed by his racist bluster and his wacky rhetoric, but they have thrown their discernment to the wind, embracing the man they have described as a rabid racist, because they prefer him to an embrace of integrity.

As we count down to the November 8 election, people are coming forward to say they are either undecided, conflicted, or would rather vote for a third party candidate, because they can't tolerate Clinton Trump. The bottom line is that either Clinton or Trump will win the Presidency. Really. Those Republicans who support Trump are openly supporting evil. They will dance with the devil to their detriment.

African Americans, especially, need to look at what Trump has promised. He has promised discrimination. He has described our lives as hell. He has been a bully and a documented discriminator. He has been too much. He should be enough to repel us. Paul Ryan has called Trump a racist, but he is willing to dance with the devil because it serves his purposes. What about you?

Hispanic Day in Spain

Celebrate October 12





Hispanic Day (Día de la Hispanidad) or National Day (Fiesta Nacional de España) is an annual national public holiday in Spain on October 12. It commemorates when Christopher Columbus first set foot in the Americas in 1492.

Celebrate Hispanic Day

The king of Spain supervises the raising of the Spanish national flag in the center of Madrid on Hispanic Day. He and the prime minister lead a military parade after that. The parade includes representatives from most of Spain's military units and various military vehicles. Armed forces' planes perform aerobatics above the parade route and display yellow and red smoke to represent the Spanish flag. Radio, television and Internet news services broadcast live on these events.

Hispanic Day is a day off work and an opportunity to spend time quietly at home or in the company of family members and close friends. People in the Aragon region in the northeast of Spain also commemorate Our Lady of the Pillar, their patron saint, on October 12.

Public Life

Hispanic Day is a national public holiday in Spain on October 12. Public life is generally quiet and many businesses and other organizations are closed. Many stores are closed but some bakers and food stores may

be open. Public transport services generally run to a reduced schedule, although there may be no services in rural areas.

If October 12 falls on a Sunday, regional or local authorities can move the public holiday to a different date. If October 12 falls on a Tuesday or Thursday, many businesses and organizations are also closed on Monday, October 11, or Friday, October 13. Some people may use the long weekend to take a short vacation in Spain or abroad during these years.

About Hispanic Day

According to the Julian calendar, Christopher Columbus set sail from the port of Palos de la Frontera in South-West Spain on August 3, 1492. He landed on a island that is now part of the Bahamas in the Caribbean on October 12, 1492. The anniversary of this date is marked as Hispanic Day in Spain.

Events similar to Hispanic Day to mark the anniversary of the date Christopher Columbus first set foot in the Americas are also held in other countries. October 12 is known as Discovery Day in the Bahamas, Day of the Cultures in Costa Rica, Day of the Race in Argentina, Chile and Mexico and the Day of Indigenous Resistance in Venezuela. The second Monday of October is Columbus Day in the United States.

I am a prophetic dreamer. I love when I recall my dreams. When I have a prophetic dream, I have learned that it is noteworthy. I grab my dream journal and jot down what occurs and what I observe in the dream. I reflect and meditate on it and then attempt to interpret its meaning during prayer.

A few years ago, I had a dream. There were some children that were in need of rescue. I was across the way and decided to go rescue them. In order to get to the children, I had to walk across a snake pit. My concern for the children's safety became greater than the fear of what the snakes would do to me. So I forged on to rescue the children!

As soon as I set foot in the snake pit, the snakes began to bite at my ankles. I focused on the children and tried to ignore the snakes. I felt the nips and bites. It stung, but I didn't look down. I kept going. I knew the snakes couldn't kill me, but the constant nipping and biting was annoying.

I was reminded of Paul. God gave him immunity against deadly venom, so that others might believe (Acts 28:3-6). The more I refused to regard what the snakes were doing to my ankles, the more they nipped and bit at me. One by one, I carried each child to the other side. I pressed and finally all the children were rescued.

It reminded me of life and ministry. My interpretation is that the children represent God's people. The harvest of souls is plentiful (Luke 10:2). There are many hurting people who need their broken hearts mended. We are called to rescue them. Our attempts to rescue them will be accompanied by things that will try to hinder us or scare us off so that the people can remain in bondage. We have to focus on the people, not the things (snakes) that come to distract us.

Most people are scared off by snakes. They give up on rescue efforts because they don't want to deal with the hassle from the snakes. I guess that's why the laborers are few (Luke 10:2). There are not many who are willing to labor under difficult circumstances in order to reap the harvest. So, people continue to hurt without rescue.

I believe my dream was a call to go rescue God's people. Never mind the snakes that hassle you trying to stop you with intimidation and annoyance. The bites hurt, but they are not deadly. At some point, we have to get where we are willing to forsake our own comfort and desires for the salvation and wellbeing of others. Many are selfish and not enough are selfless. We need to work on that. "Can anyone really harm you for being eager to do good deeds? Even if you have to suffer for doing good things, God will bless you. So stop being afraid and don't worry about what people might do. Honor Christ and let him be the Lord of your life..." (I Peter 3:13-15 CEV). There is a huge rescue mission that needs to be taken on. We need to be unstoppable in our rescue efforts. God bless and empower you.

Although God did not deem it appropriate to imbue me with superhuman strength, super speed or the ability to fly, I still possess abilities bevond that of normal men. Supermen shouldn't go around telling people how many buildings they've stopped from falling on cats; you're Superman, it's what you do. So I won't tell you how awesome of a father I

No. I will tell you how I became one through trial and effort.

In the 2008 action-comedy "Hancock," Will Smith plays the epitome of an anti-hero. He is selfish, self-centered and more inclined to drink alcohol than save the lives of other people. So, in other words, Will Smith was a single man living on his own.

The obvious tragedy was that Hancock could actually fly, had superhuman speed and strength. To every single man reading this post: like Hancock, you may have superpowers that you are letting go to waste. Please do not continue to do so.

-I was no different than Hancock. Getting up at 7am on a Saturday morning to fix cereal? That was nowhere near heroic to me, nor was

changing diapers. I HATED it. Does that sound bad? I hope so, because it should also sound honest. Heroism is selfless, and up until the very moment you have a child your entire life has been focused on yourself. Shifting that focus to someone else entirely - becoming selfless — is difficult. Impossible for some.

During weekends my twin daughters would spend with me, I had to make conscious decisions to get to bed at a certain time to be up to go to the zoo. Grocery shopping had to consist of more than cereal and microwavable dinner trays. I had to change my views on women — real time — when my daughters were around, because they were watching. I had to live and breathe consistency.

Going to sleep at a certain time, grocery shopping and looking at women with a newfound respect were just some of the superpowers my twin daughters brought out of me. One of the most important and powerful abilities fatherhood has imbued me with has been imagination. Creativity is the only way to describe how you feed, clothe and entertain another human being when you don't have enough resources to accomplish those feats for yourself.

My daughters taught me how powerful I am and how many special abilities I truly possess. I knew they were always there, but I never thought about using them for the good of other people. In Hancock, Will Smith finally realizes who he is once he is introduced to Charlize Theron's character,

Mary. Why is Mary so significant? Because she shows Hancock what he is truly capable of when he is not thinking about just him-



physical appearances could be very helpful to his campaign.

Of course, Trump denies it. He claims he's never used the phrase complainant Elizabeth Davidson said he did. He further points out that he could have said much worse. "[Y]ou and I have both heard a lot worse phrases than that, but that one is not in my vocabulary," he told the Post reporter. Then he did what he always does when called out by the press: He attacked the media, calling the New York Times "a disgrace" for running the story the day before the lowa caucuses.

Regardless of his denials, you can be virtually certain he did it, because he has demeaned and sexually harassed women openly for years. These kinds of behaviors don't just end on their own nor has Trump suffered any consequences that might deter future sex offenses. Those two things combined almost guarantee that there are other victims of whom we are simply unaware.

"Sex harassment" is most readily defined in the Equal Employment Opportunity Commission's federal guidelines that were substantially updated in 1991. Those guidelines explain that "sex harassment" is

[u]nwelcome sexual advances, re-

quests for sexual favors, and other verbal or physical conduct of a sexual nature... when (1) submission to such conduct is made either explicitly or implicitly a term or condition of an individual's employment, (2) submission to or rejection of such conduct by an individual is used as a basis for employment decisions affecting such individual, or (3) such conduct has the purpose or effect of substantially interfering with an individual's work performance or creating an intimidating, hostile or offensive working environment. Simply, quid pro quo sex harassment is sexual conduct in the workplace that requires submission as a condition of employment or that is rewarded or punished. "Hostile work environment harassment" is the effect that same sexconduct has on other employees outside of the quid pro quo exchange. You don't have to look far to see that Donald Trump

Remember when Trump was nothing more than a self-proclaimed business mogul who became a reality-TV star? Back when The Apprentice first aired in the winter and spring of 2004, as a purported talent search for a person to head one of Trump's companies? The contestants

is guilty of both kinds.

were "hired" with a one-year contract, a starting annual salary of \$250,000 and paid living expenses to dwell in a Trump-style commune. Trump's greatest joy came when he was able to crush his contestants' hopes and dreams by uttering his fateful catch phrase "You're fired!" Hired. Fired. Salary. Expenses. Employer control over all aspects of their production. These contestants were by definition Donald Trump's employees.

In his 2004 book How to Get Rich, Trump wrote about the enormous success of The Apprentice. "All of the women on The Apprentice flirted with me - consciously or unconsciously. That's to be expected..." And "[i]t's certainly not groundbreaking news that the early victories by the women on The Apprentice were, to a very large extent, dependent on their sex appeal." In 2013, he even told a contestant on Celebrity Apprentice All Stars, after she kneeled in subjugation and begged not to be fired, "[i]t must be a pretty picture. You dropping to your knees."

But was Trump's introduction of sexual elements into the workplace "unwelcome?" Unless the actions are unwelcome or offensive, there is no sex harassment, even if there is sexual conduct. One can imagine that for some women who might want to get ahead using their physical attractiveness, it's possible that Trump's sexual innuendo and expectations were welcome. It played to those women's sexual power. For everyone else, not so much

It's extremely likely that, in order to be considered for the show, the contestants were required to sign legal waivers ensuring that Trump could treat them however illegally he wanted and they would be prohibited from suing. While those contractual waivers would eliminate the possibility of a monetary consequence for his illegal actions, the actions are illegal nonetheless. Trump created a work environment for his employees that made sexual conduct and expectations part of the job (quid pro quo harassment) and interfered with the contractual expectations of the employees who did not benefit from the sexual attention (hostile work environment harassment).

But for every victim Trump has sexually harassed openly — like on his TV shows and this lawsuit for sexual assault of a business colleague in 1992-there are probably dozens he has harassed behind the scenes who have not yet come out publicly.

One of many things I learned from personal experience after the forced resignation of San Diego Mayor Bob Filner for sexually harassing his employees was that there were many, many more women who suffered his loath-

some sexual pursuits but who never came forward publicly. Filner was elected mayor of America's seventh largest city in November 2012. By the time he resigned his office nine months later, almost 20 women-including three city employees and volunteers under his direct and indirect supervision-had publicly revealed Filner's offensive sexual behaviors. Ten women claimed he had touched them inappropriately, from lingering hands on the knee, pulling them too close and stroking a cheek to unabashedly groping their butts. Three women were isolated — one in the corner of a restaurant booth - so he could try to force kisses on them. Seven complained that he had repeatedly requested dates and made other inappropriate comments, telling one woman that he had fallen in love with her during their only meeting at a public

Despite those numbers, I found that virtually every woman I talked with had a "Bob Filner story" that continued to affect them and the men in their lives long after. These women included high-profile media personalities, elected officials and public leaders, among others. While Filner never harassed me, as his chief of staff, I endured a different nightmare fighting off his rageaholism and his sexual pursuit of his executive assistant virtually every day he came in the office. It has taken me years to put that experience into perspective, which then morphed into a book on sexual abuse of power in our highest political offices.

So where are the other Trump women? I'm referring to the women who work behind the scenes in Trump's organizations who are demeaned and sexually harassed every day. The women who don't come out and complain publicly about his regular misogyny in the workplace. And the women and men who feel that sexual tension in Trump's workplace, knowing that his "favorites" got where they are in some part as a result of traits and actions with which the other victims simply can't — or won't — compete.

If we learned anything from the Filner scandal in San Diego, it is this: Creeps like Trump and Filner are not worthy of our highest elected offices. They do not represent who we are as a people. Despite this, however, the voters cannot make it a voting issue unless the people who have been affected work up the courage to come forward.

Consider this an open invitation.

To the women who suffer at the hands of Trump the Demagogue, I urge you to come out and tell your truth. No woman or man deserves to be demeaned or objectified in her or his workplace. Even if you otherwise enjoy your job or the benefits it brings, you deserve better. The Constitution says you deserve to work in an environment free of discrimination and exploitative behavior.

Admitted, going public with your story is hard, but it is a decision you will not likely regret. Whereas I can assure you, based on per-

sonal experience, that if you continue working for Trump and hiding your truth, it will hurt you and you might never be the same.

I also learned that sometimes a victim is not willing to come out for his or her own benefit, but if a greater good can be served by it, they are more inclined to look beyond their personal risks toward the greater good. In that vein, the American people need to know

what you have experienced before they vote in the primaries and caucuses and certainly before they vote in November. Bob Filner's actions cost San Diego taxpayers \$4 million to hold a special election to replace him and exposed them to millions of dollars in potential liability for the injuries he inflicted on his victims, let alone the national and international ridicule the city suffered. As damaging as this was at the municipal mayoral level, imagine the impacts magnified if a similar story were to play out at the presidential level.








Trust in the ARC, and in foreign aid more widely, has been badly shaken by a 2015 report that found donations had been squandered.

Despite collecting nearly half a billion dollars to provide relief after the 2010 Haiti earthquake and pledging to build 700 permanent homes, the ARC has been accused of only building six.

"In the coming days, many of you are going to write and ask me how you can 'help Haiti'," one woman said on Twitter after the hurricane, "Do not give to the American Red Cross."

She asked people to give instead to Haitian organizations and requested people not send goods that could be sourced locally.

The joint investigation by ProPublica and NPR found rampant mismanagement at the heart of the ARC and charged it with consistent misrepresentation of the success of its projects, particularly in housing.

The group has also been implored to hire more Haitians in its highest ranks

After the earthquake, over \$9B was pledged to help the country in its recovery. Yet critics argue that the money was not used so Haiti could be "built back better," as officials had promised.

Instead, an estimated 55,000 Haitians are still living in tents or other makeshift shelters and few advances in disaster planning have been implemented.







Lions Clip the Eagles 24-23

With the home team trailing 23-21 in the fourth quarter, Matthew Stafford led a rally on a seven-play 28-yard drive to position the team for a gamewinning Matt Prater 29-yard field goal. The drive was Stafford's 22nd career gamewinning drive his second this year in the fourth quarter as the Detroit Lions' 24-23 win over the Philadelphia Eagles Sunday, October 9, 2016 at Ford Field. Overall, he completed 19-of-25 passes (76.0 pct.) for 180 yards with a 135.0 passer rating. This was Stafford's ninth career game with a 75.0+ completion percentage with at least 25 attempts. All three of Stafford's touchdowns against the Eagles (1, 17 and 1 yards) occurred in the first half. His performance against Philadelphia was the sixth time he has thrown at least three touchdown passes in the first half of a game. The last time was against New Orleans in Week 15 of the 2015 season.

Running back Theo

Riddick caught two touchdown passes (1, 17 yards) in the Lions' 24-23 win over Philadelphia and became the first Lions running back to register two receiving touchdowns in a game since running back Horace King vs. Minnesota December 9, 1978. Against the Eagles, Riddick caught six passes for 33 yards. Riddick also carried the ball 11 times for 49 yards.

The Lions sluggish in the second half gained just 19 yards on the first four possessions, fumbling once and punting three times. Philadelphia, meanwhile, opened the second half with Wentz capping a nine-play, 75-yard drive with a 1-vard TD pass to Josh Huff. The Eagles Nigel Bradham, who was arrested last Sunday on a misdemeanor concealed weapons charge, recovered Stafford's unforced fumble on the ensuing drive at the Lions 16. The Lions held Philadelphia to a field goal, allowing them to cling to a 21-20 lead. Caleb Sturgis' 49-yard field goal, his third, put the Eagles ahead for the first time 23-21 with 6:45 left, in the fourth quarter.

Nevertheless, cornerback Darius Slay forced an Eagles fumble on 3rd-and-2 at the Eagles 45-yard line that was recovered by DT Tyrunn Walker. The turnover gave the Lions the ball back with 2:34 to play in the fourth quarter and led to the game-winning field goal. The forced fumble was the first of Slay's career. In addition, with less than 2:00 to play in the fourth quarter, Slay picked off an Eagles pass (11yard return) to seal the Lions' 24-23 win against Philadelphia. It was Slay's first interception of the season and fifth of his career.

Head Coach Jim Caldwell made this statement after the game, "The guys played so hard there down the stretch, and we needed a couple plays. That turnover was huge for us. Slay got a part of that thing and the guys scrambling to get it recovered because it was bouncing around. Thought initially that it was going to trickle out of bounds, but the guys did a very nice job, and then Slay's play at the end. Overall, it was just a heck of a team effort. I think our guys started the game well. Ran into a little bit of a lull in the third quarter. They were playing well, that's a good football team. We were able to pull it out at the end."

The Lions will try to make it two wins in a row at home as they welcome the Los Angeles Rams at Ford Field this upcoming Sunday.





Film Review:

The Birth of a Nation



Finally, a filmmaker unearths one of the biggest secrets in American history: slave revolts. It's a lesson rarely mentioned in history books, though it's common knowledge to anyone who has taken a Black History course. Kudos to actorturned-director Nate Parker for shepherding this ambitious project from the kernel of an idea to the completion of an inspiring and evocative film that is nothing less than a masterpiece. There are many facets of this movie that are groundbreaking, historic, monumental and unique.

In the evolution of the American film industry few films have ventured into the subject of slavery. Some have misleadingly romanticized the era (Gone With the Wind). Some have made fun of it and belittled its tragic consequences (Django Unchained). Some have eloquently captured the suffering (12 Years a Slave). Some have revealed rebellions from a White man's perspective (Free State of Jones). None have captured the spirit and emotion of the time, the courage and bravery of resistance and the calculated planning and execution of a rebellion from the viewpoint of African American culture. Until now.

Southampton County, Va., is filled with cotton plantations. A young slave boy named Nat (Tony Espinosa) and his family work on a farm run by the Turner family. Nat is thought to be a chosen child by friends and family: "This boy has the holy markings of our ancestors." He is friendly with the slave owner's son Samuel (Griffin Freeman). That boy's mom Elizabeth (Penelope Ann Miller) notices that Nat has a knack for words and she helps him learn how to read, using the Bible as a learning tool.

Years later, Nat (Nate Parker) is a young Reverend. His stature among the slaves is high. The Turner family seems to not be too apprehensive about their slave who seems to be intelligent and a leader. Samuel (Armie Hammer), now a young man too, is in charge of a farm that is failing to make money. As talk of rebellious slaves sweeps through the county, Samuel gets Nat to become a traveling pastor who "tames" the nerves of slaves on other plantations, for a fee that is paid to the Turner Family.

Traveling around to other farms gives Nat a general of sense of other slaves' wretched conditions. Several intensely brutal incidences, involving him, friends and a vicious assault on his wife Cherry (Aja Naomi King) by white men, bring things to a head. The time to act has come. Nat: "We'll destroy them all." How will it be done? Who will join him? How will this insurrection end?

Throughout the film, the script by Parker and Jean McGianni Celestin establishes and maintains a spiritual destiny that never wanes. There are moments that the Nat Turner they have created has Christ-like, martyr-like attributes. How much of this is based on fact or is manufactured to produce a character that audiences will root for is up for debate. One thing for sure is that the real Nat Turner was a courageous man who gave his life for freedom, and the one onscreen takes over that mantle very well.

For a first-time filmmaker, Parker makes no huge gaffes. He finds and keeps a tone, pulls Oscarworthy performances from his cast and sets everything in motion in a thoroughly engaging manner that is sustained for 118 minutes. With the skill of directors with ten times his experience, he blends drama, psychodrama, romance, spirituality and action into a relentless, uncompromising classic.

By most epics' standards, this is concise storytelling (editor Steven Rosenblum) that is perfectly set in the 19th century (Jim Ferrell, set decorator; Geoffrey Kirkland, production designer). The characters wear clothes that looked lived in (Francine Jamison-Tanchuck, costume designer) and when they are injured their cuts and bruises look scarily real (Randi Owens Arroyo, makeup artist). And every element is captured by a very perceptive lens (Elliot Davis, cinematographer).

It is a miracle that Parker can write the script, produce the movie, direct the proceedings and still turn in what has to be one of the most difficult and emotionally complex performances of the year. His character evolves from jovial, young man, to preacher with guilt, to loving protective husband and father, to angry rebel seamlessly. Every feeling he exhibits seems

authentic.

Parker's portrayal peaks in a pivotal scene when Cherry lies on a bed of white sheets, bludgeoned, and he assures her that everything will be all right, even though life couldn't be worse. The two actors cry and hold each other in a way that creates an indelible moment. Before, and more now, the audience is waiting and ready for Turner to take matters into his own hands. And so is Cherry: "If the Lord has called you to fight, you fight for me. You fight for all of us."

Ensemble acting is rarely this flawless. Usually one actor overdoes it, or one is not up to snuff. Not here. Hammer as the friendly, then cold, Samuel makes you never question his motivation. Colman Domingo as Nat's cohort gives depth to his role in ways that deserve acclaim. Aunjanue Ellis as the mother and Esther Scott as the grandmother, are stoic. Penelope Ann Miller, through the character of Elizabeth Turner, aptly conveys a sense of nurturing, confusion, shock and fear. Villains come and villains go, but Jackie Earle Haley's interpretation of Raymond Cobb, a "paddy roller," a White man who monitored and enforced discipline upon Black slaves, is one of the most vile you will ever see.

A rebellion and a subsequent massacre happened in the backwoods of Southampton County, Va. on August 21, 1831. Those events foreshadowed the Civil War. And now millions have the chance to learn a part of Black history that few know.

It is so fitting that the brilliant Nate Parker has called his great opus "The Birth of a Nation." If there is justice in this world and the afterlife, D.W. Griffith, the racist director of the 1915 propaganda film of the same title, is turning over in his grave.

This is a story that had to be told. And must be retold again and again.

made it out to today's rally where Clinton also touched on her commitment to every demographic and citizen of the country,


