

Why We Must Continue to Fight Efforts to Suppress Black Votes

In all democracies, the right to vote is fundamental to the legit-imacy of an elected government chosen by the participatory action and will of the people eligible to vote. For 47 million Black Americans, the right to vote is a sacred responsibility without the fear of reprisal, retribution or repression.

It's 2016 and this year's national elections in the United States are only a few days away. Yet in many states early voting has already begun. Keep in mind in the last national presidential race in 2012, Black Americans went to the polls in record numbers with over 17.8 million casting their ballots even in face of voter suppression tactics mainly by Republican officials in various states in the Midwest, Southwest and in the South.

Black America had a higher percentage turnout of voters than White voters across the nation in 2012. The Black percentage turnout was 66.2 percent versus 64.1 percent for White voters. The election results in November will ultimately be determined by the percentage of overall voter turnout.

If the Black vote was not so strategically important and determinative today, you would not see the current manifestations of blatantly racist acts designed to suppress the Black vote. Such is the case today especially in Indiana, North Carolina and in other states where Black voter turnout is key to winning the election.

Indiana Governor Mike Pence who is now aggressively campaigning to be Vice President of the United States of America, has permitted and encouraged the Indiana State Police to target and shut down the most successful voter registration organization that has registered Blacks to vote in Indiana. The dastardly use of state police to intimidate and prevent Black people from registering to vote demands public outcry and challenge.

On October 4, 2016 Indiana State Police raided the headquarters of the Indiana Voter Registration Project, coordinated by a group named Patriot Majority USA in Indianapolis, Ind. The Indiana State Police shut down this voter-registration program that was helping to register tens of thousands of law-abiding, eligible Black Americans in Indiana.

According to Craig Varoga, the president of Patriot Majority USA, "Mike Pence has a well-oiled political machine that is using the Indiana State Police to suppress African American votes and violate the Constitutional rights of of thousands Hoosiers. This is not only voter suppression at its worst, it is an insult to all of the honest troopers in the state police, and to law-enforcement officials across the country, who disapprove of wasting precious crime-fighting resources on partisan witch hunts that further harm relations between police officers and minority communities."

In North Carolina, even after the 4th Circuit U.S. Court of Appeals recently overturned the state's severe voter suppression law, many Republican county officials across the state have established policies to limit early voting and Sunday voting that will, again, target those counties in N.C., where Black Americans are concentrated.

But Black leaders and organizations are fighting back. Reverend Dr. William Barber, President of the N.C. NAACP, affirmed, "We're fighting and staying strong. Tomorrow early voting starts in North Carolina. They can register and vote the same day. We're leading a march on the campus of North Carolina Central University and going all over the state and other HBCUs."

The ultimate antidote to Black voter suppression is to ensure a massive Black voter turnout across the nation between now and Tuesday, November 8, 2016. Let's all work to stop racist voter suppression. We vote for freedom, justice, equality and empowerment.

LETTER TO THE EDITOR: Should the New Inkster Charter be adopted?

(In response to last week's article with same title)

Voters of Inkster should vote no on charter revision. Although it would be nice to clean up outdated language and obsolete sections in the city charter. (State law will always supersede obsolete language in the charter). Unfortunately, personal interest has used this excuse in the past and now (2016) to change the form of city government in Inkster to one of gaining more mayoral powers. The honest truth is that this is not the argument brought forth when bringing the proposal to voters of Inkster, so the attempt to clean up obsolete sections are lost on the overwhelming issue of changing the form of government with more mayoral powers.

In the past, charter revisions have been brought to the voters of Inkster and have failed mainly on the issue of giving more powers to the mayoral position. The sections in previous proposed charters, giving more powers to the mayor, have tied up other outdated sections from being corrected and revised because the charter is voted on as a total document. It should be realized that the last charter revision attempt was during economic good times and the form of city government was not tied to economic conditions as it is today. It should also be of note that the newly proposed charter revision uses large portions of the 2006 proposed charter and this why the present day charter commission was able to submit a draft so soon (6 weeks) after convening. This short time frame has negative effect on citizen input. Most charter revisions take up to 3 years to review, research and revise. There was a definite rush to get this done during the term of the present elected body. No charter revision should be made for the purpose of any particular individual. The Charter commissioners also included that changes in the revised charter shall take effect immediately without elections.

The 9 member charter commissioners were chosen by the voters of Inkster on the same ballot as the question to whether the Charter should be revised. It should be known that all 9 members chosen on the ballot were also part of the same political slate that was endorsed by some of the present elected officials.

The present day Charter was enacted in 1964 it calls for a council manager form of government where a 7 member City Council (including the Mayor) is elected by voters as the legislative body to enact policy and to appoint a City manager. The City Manager shall be selected solely on the basis of his executive and administrative qualifications with special reference to his training and experience. Whereas the 2016 revised charter qualifies the Mayor, who is selected by popular vote, to run the administrative offices where no qualifications are required other than living in the city 1 year before elections. Also, the mayor is a member of the legislative body and gets to vote on resolutions in cases of a tie. Which in turn requires a two-thirds dissenting vote, or 4 out of the remaining 6 council members to override any proposal presented by the mayor. So, the mayor presents policy, financial budgets, selects the city clerk, administrative employees and corporate services without

necessarily having any experience in management. The dual role in legislation and administration gives vast powers to the mayor and are very rare in any form of local, state or federal government.

The changes that make council members more accountable are positive. Most. If not all council members have in the past and are now meeting constituents through block club meetings and town hall's. We applaud this initiative, but it does not need to be in the city charter to accomplish this. It can be done at the council policy level. Also, the requirement of candidates having to acquire not less than 100 signatures to qualify for ballot is excessive.

Publishing the proposed charter changes in the Telegram News and televising the charter meetings are great. The residents must read information for themselves to make a decision. But, let's not fool ourselves, the charter commissioners are also trying to sell a "yes vote" to the voters on this proposal. It is also clear that there is a large campaign by special interest to get the revised charter approved by voters. The State governor's office has only approved the language in the revised charter and does not endorse on whether voters of Inkster should vote yes or no on its adoption.

Yes, many cities put charter revision on the ballot. The City of Taylor voters defeated charter revision in the 2016 August primary. Many times charter revision is initiated by special interest that has hidden agendas as in this case. The process needs to be more transparent as to the true purpose of charter revision and not hide behind minor imperfections to make major changes.

Granted, the present city charter

has imperfections which need to be corrected. They should be corrected without the threat of takeover by individuals or special interest that wants to changed our form of government. Those wanting a change should be willing to face the Inkster residents in a transparent way to explain why giving one person so much power is in the best interest of our community. The existing city charter has worked fine since 1964. We have had many experienced and qualified city managers over the last 52 years with many accomplishments with the city manager form of government. The notion that the city of Inkster's financial condition, lack of services and high fees are the reason for a takeover by an all powerful mayor is wrong. Every city in this state, including the County suffered in this economic downturn and now cities and counties are slowly recovering. Other communities are not using this as a reason to change forms of government or use it as an excuse to give more power to one person. One thing we have learned in our history over the centuries is giving power to an individual is more susceptible to misuse. Let's work together to make Inkster better. Learn from our mistakes keep the elected legislative body separate from the administrative, with existing checks and balances.

How should Christian values impact business ethics in the office?

I remember having a discussion a few years ago in the boardroom of one of the Fortune 500 corporations here in the United States. I was speaking to the chairman of the board, the president, and several vice presidents of this corporation on the issue of the relationship between theology, philosophy, and ethics. At the end of the discussion the chairman of the board looked at me and said, "Do I understand you to be saying that ethical issues-that is, policies that we have in our business organization—touch the whole question of ethics, and in turn those ethics touch the question of philosophy, and in turn philosophy touches theology? Are you saying to us that how we run our business ultimately has theological significance?"

I said, "Yes, that's what I'm trying to say." And it was like the lights came on in this man's head for the first time in his life. It astonished me that he thought this principle to be so obscure.

When we use the term ethics, we're talking about doing what is right. From a Christian perspective, we believe that the ultimate norm and ultimate standard of rightness is the character of God and his perfect righteousness. So biblical principles of ethics have great relevance for the business world. I'm talking about simple things like God telling us it's wrong to steal. You don't have to be a Christian to appreciate honesty and respect for private property in the business community.

I once talked to someone who was astonished because they gave \$5,000 to an automobile salesman in Orlando, Florida, to have some work done and the guy took off with the \$5,000 and never did the work. His wife was really upset, saying, "How can people do that? That's crooked business." One doesn't have to be a Christian to feel violated when a businessman steals one's money. The Bible tells us to honor contracts, to pay our bills on time. What businessman doesn't appreciate it when his customers pay him what they owe him? The Bible has much to say about false weights and measures. How do you like it if you are buying "short measure" in perfume or in ketchup? That's a business consideration. All of these are very practical, concrete principles of ethics that touch the very heart of doing business.

Honesty, industry, integrity—we know that the Christian has no corner on these particular virtues. These virtues are significant in every realm of business and, most important, how we treat people in the realm of business. Do we treat them with dignity? That is a top priority of Christian ethics, that we treat our customers, our employees, our personnel with dignity.

A Message From Our Detroit City Clerk



Convicted Felons Do Have Voting Rights

There have been several hearsays concerning convicted felons and their right to vote. There has been misinformation or lack of information surrounding this issue. As a result, research was done with the aid of the City of Detroit Law Department. The purpose is to help our readers understand or have first-hand knowledge of how Michigan election law addressed this burning question.

The question is: Is there a provision in Michigan Election Law that allows those who have past criminal convictions and served time in prisons, their right to vote in elections? In Michigan, convicted felons are restricted from "voting only while confined in prison" (Michigan const. 1963. Art. 2 Sec 2" 1954 PA 116, Sec. 758b; MCL 168.758b; MSA 6.1758(2). Election laws are different in many states. Therefore, it may be true in some states that a criminal conviction of a felonious nature, may automatically terminate an individual's right to vote. Here in Michigan your voting right as a citizen is still intact for those who served time in prison after felonious convictions. Even if the convicted person is on probation (meaning that he or she is not confined in prison) that person can vote in an election.

Those in jail awaiting arraignment or trial also have the right to vote by absentee ballot, in compliance with the Michigan election law: O'Brien v Skinner, 414 US 524;94S Ct 740,38LEd2D702 (1974) and Arlee v Wayne County Sheriff55Mich. App340;222NW2d233 (1974) both to the effect that persons confined in jail awaiting trial cannot be deprived of the right to vote by absentee. See also section 492a and 758 of the Michigan Law supra, respectively MCLA 168, 472a; MSA 6.1492(1) and MCLA 168.758; MSA.1758.

You are now aware and knowledgeable of the law. As City Clerk and Chief Election Official, I am soliciting your involvement to help disseminate this information and end misinformation that past criminal convictions have shut the doors to a person's right to vote. Again, here in Michigan, your voting cannot be denied because of past criminal convictions as long as you are not confined in prison.

I will continue to do my best in providing you with important facts and valuable pieces of information regarding elections administration, voting and the election laws because your voting rights is my business.



Treva Gordon formerly Treva Sanders is from River Rouge, MI. Her grandfather name is Steve Sanders also from River Rouge and many aunts, cousins and more are from the downriver area. Both parents couldn't be more pleased more with their daughter Robyn, "I am very proud of Robyn for becoming a great author and the work she is doing. She is blessed with many ideas and the best is yet to come," said her mother.

'Stop Bullying' in the past few months has been accepted as part of an anti-bullying curriculum at Power & Grace Christian Preparatory Academy in Clarksville, TN. with plans of expanding the book being included in the Clarksville Montgomery Country Public School System Curriculum. 





Stafford Deserves Praise

Lions win in final seconds

Well this past Sunday was again a knock down drag out affair as in his 100th game of his career Detroit Lions quarterback Matthew Stafford completed 18-of-26 passes (62.1 percent) for 266 yards and one touchdown. He finished with a passer rating of 103.5. Stafford, who holds the franchise record for starts by a quarterback, now has become the first quarterback in team history with 100 career starts. In addition with 16 seconds left to play and trailing by four points against Washington, Stafford led the Lions to victory by throwing an 18-yard touchdown pass to wide receiver Anquan Boldin to win the game. Stafford led this comeback drive with 1:05 left to play in regulation time. Stafford now has 24 career game-winning drives in the 4th quarter or overtime. He has accomplished this in each

of the past three games and during all four Lions wins in 2016.

After the game head coach Jim Caldwell was ask, on why QB Matthew Stafford has been clutch in late-game situations: Caldwell said "I attribute to the fact number one, he does not back down from tough situations. He relishes in them, he doesn't get nervous and he's got a real clear and focused mind during the time when it's sometimes a little bit of chaos all around you. But he rises to the occasion time and time again. He's certainly delivered for us."

This past Monday before the Lions began their preparation for the Houston Texans at the team's headquarters and training facility in Allen Park, Caldwell was ask, on what has impressed him about Stafford's recent streak: He reply by saying, "I think that he's performing well. I think through the years he's been maligned a little bit, and it hasn't been warranted. I think I've told you from the first time when I came here, this guy is a really good player. He's come from behind a lot; I don't know how many he's had. There were a lot more before we got here. I think overall, he's playing well, he's confident; the guys are catching the ball for him. But, the thing he's interested in most, more than anything else is winning. I'm sure he'd take far less fewer stats and more wins, that's really his goal and aim. He's a consummate team guy, doing everything he can to win."

Dear Home Alone Wife,



Dating violence often begins in adolescence and can have devastating short- and long-term consequences, yet only 1 in 3 teens in a violent relationship tells anyone about the abuse. psychological consequences are clear: adolescent victims are at higher risk for depression, substance abuse, suicide attempts, eating disorders, poor school performance, pregnancy, sexually transmitted infections, and further victimization.

What should you tell your teen? While both females and males can be victims of dating violence, the highest rates are seen among girls and young women between the ages of 16 and 24.

Youth in same-sex relationships are at even higher risk of experiencing dating violence: A study released by the Urban Institute showed significantly higher rates of dating violence among lesbian, gay, and bisexual youth than among non-LGB youth.

So what can parents do? First, start the conversation early, even if you don't think your tween or teen is dating yet. Ask your sons and daughters about their perception of healthy and unhealthy - relationships, correct any misperceptions, and display healthy adult relation-

Let your children know that any type of violence or abuses of power are never ok in a relationship, and discuss the options available if they witnesses dating abuse or experience it themselves.

Remember to tell your teens that they can come to you if they are in a relationship that makes them nervous or scared. and that you will support them as they make the best decisions for their well-being.
