Four more charged in Flint water crisis By Sara Ganim and Sarah Jorgensen, CNN



(CNN)Four officials in charge of Flint's water, including two who reported directly to Governor Rick Snyder, have been named in the fourth round of charges announced by the Michigan attorney general's office as it investigates the city's water crisis.

Two of Flint's former emergency managers and two water plant officials were charged Tuesday for felonies of false pretenses and conspiracy -- the allegations are that they misled the Michigan Department of Treasury into getting millions in bonds, and then misused the money to finance the construction of a new pipeline and force Flint's drinking water source to be switched to the Flint River.

Jerry Ambrose and Darnell Earley, both emergency managers put in charge of Flint during a years-long financial crisis, reported directly to the governor and are the highest level officials to be charged so far. They also face misdemeanors of misconduct in office and willful neglect of duty.

The other two men, Howard Croft and Daugherty Johnson, were city water plant officials involved in making the switch from purchasing drinking water from the city of Detroit, to treating water from the Flint River.

The charges today mark the 13th since the water crisis began.

"All too prevalent and very evident during the course of this investigation has been a fixation on finances and balance sheets," said Michigan Attorney General Bill Schuette. "This fixation has cost lives. This fixation came with the expense of protecting the health and safety of Flint. It's all about numbers over people, money over health."

The charges lead Congressman Elijah E. Cummings to renew his call for Snyder to be subpoenaed once again before the House Oversight Committee.

Electoral College belongs in 1787: John Conyers Jr. Under the right circumstances, the political will for reform can exist.

With the Electoral College meeting Monday to formally elect Donald Trump as our 45th president, it is time that we reconsider whether a political compromise approved in 1787 bears any principled or practical reason for being today.

Several serious concerns were raised at a forum I organized earlier this month featuring leading experts in history, constitutional law and political science. Most obviously, we learned that the Electoral College is anti-democratic. Democratic presidential nominee Hillary Clinton has so far received over 2.8 million more votes nationwide than Trump - the largest divergence between the popular and electoral votes in history. This is the second time there has been a divergence between

the popular vote and the Electoral College in the last five elections, and the fifth time that a popular-vote loser won the White House.

We also learned that the Electoral College is rooted in slavery. At our forum, Yale law professor Akhil Amar explained that slave states opposed direct elections for president because "in a direct election system, the North would outnumber the South, whose many slaves . . . could not vote. But the Electoral College . . . instead let each Southern state count its slaves, albeit with a two-fifths discount, in computing its share of the overall count."

Our forum also made clear that many of the arguments in defense of the Electoral College are anachronistic. Electoral College defenders argue that it serves to check the passions of ordinary voters, pointing to Alexander Hamilton's view in The Federalist Papers that the Electoral College would help ensure "that the office of President will never fall to the lot of any man who is not in an eminent degree endowed with the requisite qualifications."

However, the Electoral College does not meet to deliberate about who should be president. The general public does not even know the electors' identities, and the Electoral College's choice for president has largely been reduced to mere formality. Members of the Electoral College are party loyalists who are subject to various state laws, some of which prohibit them from even exercising independent judgment. This is why over time there have been very few faithless electors, and none that have decided an election's outcome.

Rather than protect small-population states and rural areas from domination by large-population states and urban areas, the current system encourages candidates to overlook a majority of states and focus nearly all their campaign efforts on the small number of so-called swing states. In 2016, for instance, both major party candidates largely bypassed three of the four largest states by population during the campaign. They also skipped 12 of the 13 smallest states, from "Blue" Rhode Island to "Red" Wyoming.

Finally, some Electoral College defenders argue that direct elections for president could lead to messy nationwide vote recounts. Our experience in Florida in 2000, and Michigan, Pennsylvania and

NC NAACP to Consider Economic Boycott

by the extremist Republican controlled legislature over the past two weeks, that follow a pattern over the last 3 years during which they have passed unconstitutional laws that were overturned in the courts 13 times, we say enough is enough! Their actions are in violation of and are antithesis to the values of our Constitution, our civil rights commitments, and the deep moral values of justice we share as a state and nation. The extremist Republican leadership in the NC General Assembly has engaged in a modern day political and policy coup d'état, by passing regressive laws such as SB4 and HB17. The legislative overreach into our access to the court system takes away the political power of the people by undermining our vote. It violates the separation of powers between the legislative and judicial branch. These actions were taken after an African American won the Supreme Court race by nearly 350,000 votes thereby changing the ideological makeup of the courts by having two African Americans.

Rev. Dr. William J. Barber II, NC NAACP President said, "In fact, according to the Electoral Integrity Project at Harvard University, the University of North Carolina at Chapel Hill, and the University of Aarhus in Denmark, legislative power in our state no longer depends on the ballot; instead, one party has won roughly half of the votes but gotten one hundred percent of the power. A recent article by one authors is entitled, "North Carolina Is No

the legislative extremists' voter suppression law that "targeted African Americans with almost surgical precision," according to a ruling by the U.S. Circuit Court of Appeals for the 4th District. They remind many North Carolinians of how the all-white Republican caucus has abused power with their secret efforts and refusal to hold public hearings. We have always stood against extremism whether perpetrated historically by Democrats or Republicans. Our lawyers are pursuing every legal option for challenging these unconstitutional laws.'

Therefore, after the Christmas holiday, the NC NAACP Executive Committee will convene and engage in some serious deliberations and develop a formal request to the National Board of Directors of the NAACP calling for an economic boycott of North Carolina until the NC General Assembly:

1. Restores the People's full and immediate access to the Supreme Court that does not allow the legislature to choose which courts hear actions against their decisions based on their partisan bias.

2. Repeals the hijacking of the State Board of Elections that seeks to guarantee Republican control even after they lost the Governor's seat.

3. Pass fair redistricting laws that give the people of this state a fair chance to elect legislators of their own choice.

4. HB2 and all of its provisions, including the provisions against raising the minimum wage, limiting the timeframe to take employment discrimination cases before the state's courts, and the provision that undermines the ability of local municipalities to write progressive anti-discrimination laws, have been repealed in total.

Not only are these policies unjust, but also the prior actions of this legislature have hurt the poor and working people of our state. They repealed the Earned Income Tax Credit, increasing taxes for 900,000 working poor people, and have denied 500,000 working poor people Medicaid expansion. This decision has cost NC 25,000 new jobs and \$2 billion in federal funding each year. We are calling for a Mass Moral March of Raleigh & HKonJ People's Assembly on February 11, 2017. We must stop this kind of political overreach here in North Carolina or it will spread to other states. We cannot stand for it now and we will not stand for it tomorrow because our fore parents did not stand for it yesterday!

Wisconsin this year, have taught us that statewide recounts under differing and confusing rules bring neither clarity nor finality to our electoral process. By contrast, a national popular vote is historically far more likely to establish a clear winner, avoiding the necessity of recounts altogether.

Many voters have told me that the political obstacles to reform are insurmountable, with a constitutional amendment requiring a two-thirds vote in the House and Senate and ratification by three-quarters of the states. Yet in 1969 I was one of 338 members of the House of Representatives who voted on a bipartisan basis to amend the Constitution to eliminate the Electoral College. As that shows, under the right circumstances the political will for reform can exist.

However, other options are available, with 11 states accounting for 165 electoral votes having already entered an interstate compact to cast their electoral votes for the national popular vote winner. Legislation to enter the compact has been recently passed by at least one legislative chamber in four more states, potentially bringing us even closer to the 270-vote threshold needed for the interstate agreement to kick in.

The Supreme Court has long held that the "conception of political equality from the Declaration of Independence, to Lincoln's Gettysburg Address, to the 15th, 17th, and 19th Amendments can only mean one thing — one person, one vote."

It is time that the election of our nation's president and vice president reflect those principles as well. The greatest democracy on Earth deserves no less.

Rev Jackson: Real Christmas story remains relevant today –

Last week, the Electoral College met to cast their ballots for the new president after a bitterly contested election in a deeply polarized nation. On Sunday, the vast majority of Americans will celebrate Christmas, literally the mass of Christ, marking the birth of Jesus.

Christmas is not simply a day for exchanging presents and cards. It is not simply a holiday; it is a holy day. Each year, I use this column to remind us of the real meaning of Christmas.

Jesus was born under occupation to a couple ordered to go far from home to register with authorities. The innkeeper told Joseph that there was no room at the inn. Jesus was born in a stable, lying in a manger, an "at-risk baby."

He came at a time of great expectation among the poor and the oppressed. Prophets had predicted that a mighty Messiah would be born - a king of kings - to defeat the occupiers and free the people. They expected a powerful warrior, one who would lead them against Rome's legions. But Jesus rallied no army. Jesus was a liberator, but He was a Prince of Peace. He gathered disciples, not soldiers. He converted rather than conquered. He accumulated no worldly wealth. He threw the moneylenders from the temple.

We cannot speak of Jesus in the past tense. He is the Prince of Peace today. Peace, He showed us, is not the absence of noise; it is the presence of justice and righteousness.

We will be judged, He told us, by how we treat "the least of these," by how we treat the stranger on the Jericho Road. poor, to care for the sick, to reach out to the refugee.

Now. of course. Christmas has become a holiday, more secular than sacred. Too many of us stretch our budgets not to lift those in need but to buy baubles for families and friends. Christmas often means more debt until Easter. It has become a marketing scheme, a time of malls and sales, of come-ons and discounts. But we should not allow Jesus the Christ, the redeemer, the emancipator to be displaced by Santa the Claus, and more debt and unaffordable things.

Let us use this holy day to reassess where we are. We are spending trillions in wars without end. Inequality has reached extremes not witnessed since the eve of the Great Depression. We continue to lock up more people than any nation in the world. On an average day, 27 people die from gun violence in the United States; in Canada and other western nations, the average is fewer than five per day.

The good news is that since last year, unemployment is down, poverty is down and incomes have begun to rise. But we've lost ground this century, with more people and more children in poverty than in 2000. There are 45 million Americans living in poverty, a number that would be far worse without Social Security (which lifts 26.5 million out of poverty), refundable income tax credits and SNAP or food stamps. Last year, the life expectancy of Americans began to decline.

The rich, on the other hand, have more money and pocket a greater percentage of the nation's income than ever. So why would an incoming administration focus on more tax cuts for the wealthy and more cuts in basic services for the poor and working people?

You don't need to be a Christian to understand the relevance of the real Christmas story today. Jesus taught us the overwhelming power of faith, hope and charity, the importance of love. He taught us that people of conscience can make a difference, even against the most powerful oppressor. He showed leaders the power of summoning our better angels, rather than rousing our fears or our divisions. This Christmas, this surely is a message to remember. Merry Christmas, everybody. The Rev. "Try to see it from their point of view; they have a lot of anticipation about it," she said. "Then, planning a few things, don't over plan, but have a couple of kind of 'milestones.' So, that kind of thing helps us make the most of the days, because actually by the end of it, it's over faster than you knew."

She said 'milestones' may be a plan to see a movie one day, and baking cookies the next.

Gray added that it's also important as an adult to know when to take a moment for yourself if patience runs thin. She said holiday traditions, no matter how small, are valued by children, so don't underestimate their importance.

While the build-up to the holidays often makes parents feel like every event should look like a scene from "It's a Wonderful Life," Gray said you can look for ways to make it easier on you, and offers an example:

"You create these high expectations, and saying, 'This year we're just going to do readymade hors d'oeuvres for Christmas Eve. We're not going to go all-out and make every single thing from scratch."

Other ways to spend quality time with kids include a family game night, going for a walk, having a movie night or cooking together.

All of the astronauts picked by NASA to participate in its maiden manned space programs, Mercury and Gemini, were white males. However, behind the scenes, there was a dedicated team of African-American, female mathematicians who played a pivotal role in ensuring that they launched and returned safely, whether from orbiting the Earth or a mission to the moon.

Equipped only with pencils and slide rules, these socalled "human computers" were among the best and the brightest minds recruited by NASA to do the critical calculations needed to win the space race with Russia. Author Margot Lee Shetterly gave these unsung heroines their due in "Hidden Figures," a best seller belatedly crediting their quantitative contributions to the cause.

Besides chronicling their considerable accomplishments, the book also recounted the indignities these brilliant black



women simultaneously suffered, simply because they had the misfortune to be living in Virginia during the dark days of Jim Crow. Back then, African-American brainiacs employed by NASA were automatically assigned to work in its segregated West Computing Group.

Hidden Figures

Directed by Theodore Melfi (St. Vincent), the overlooked icons' story has now been adapted to the big screen as an uplifting, overcoming-the-odds docudrama. The picture recounts the trials and tribulations of three members of the unit Katherine G. Johnson (Taraji P. Henson), Dorothy Vaughan (Octavia Spencer) and Mary Jackson (Janelle Monae).

We are flies on the wall when, without complaining, Katherine routinely has to run to a distant "Colored" ladies room despite the presence of one for whites right nearby. On another occasion, we witness Mary's frustration in furthering her education on account of the fact that blacks aren't allowed to matriculate at the local college offering the courses she needs.

By film's end, both the bathroom and school are indeed integrated, albeit after an emotional intervention by NASA administrator Al Harrison (Kevin Costner). A worthwhile, teachable moment correcting a shameful chapter in American history.

President Obama Signs 'Emmett Till Bill' To Reopen Civil Rights Cold Cases

The new legislation will allow civil rights cold cases that happened prior to 1970 to be reopened Written By Brandee Sanders

n 1955, the death of Emmett Till, a 14year-old African-American teenager who was lynched after allegedly flirting with a White woman in rural Mississippi, sparked controversy across America.

The two White men responsible for brutally murdering Till were let off by an all-White jury. The case brought attention to how racism is intertwined with America's justice system. Sixty-one years after his death, Till's horrific experience may carve a path for others hoping to find justice. According to PBS, President Obama recently signed a bill that would give the FBI the chance to reopen more cold cases from the Civil Rights Era.

The legislation, titled the Emmett Till Unsolved Civil Rights Crimes bill, was initially introduced by activist Alvin Sykes in 2005. He named the proposed bill after Till because he vowed to his mother, Mamie Elizabeth Till-Mobley, he would fight to reopen the case. The Department of Justice did reopen the case in 2004; it was closed three years later after a jury decided not to indict Carolyn Bryant, the woman who accused Till of whistling at her. Two years after the case was reopened, the FBI started to look into over 100 civil rights cases. In 2008, the bill was placed into law.

The upgraded legislation, which President Obama signed on December 16, will now get rid of the limitations on cases that occurred prior to 1970 and will allow ongoing investigations conducted by the FBI surrounding civil rights cases. This will create an avenue for cases that occurred during the height of the Jim Crow Era to be reopened. Under the revised bill, dubbed Till Bill 2, groups including Emory University's Georgia Civil Rights Cold Cases Project and the Cold Case Justice Initiative at Syracuse University would receive funding to help solve civil rights cases.

Many politicians believe the updated law will allow more cases to be opened and solved. Senators Claire McCaskill and Richard Burr backed the bill at the Senate level. In the House, it was reviewed by Rep. John Conyers, Rep. John Lewis, and Rep. Jim Sensenbrenner.

"As we work to address current questions about racial violence and civil rights, we should be mindful of our history and why so many in the African-American community raise the issue of whether black lives matter," Rep. John Conyers Jr. told USA Today. "Passage of the original Emmett Till Act represented a commitment to resolving the unanswered questions from one of the darkest periods in modern American history."

Over the past 27 years, the reopening of civil rights cold cases has resulted in 24 convictions. The first person to be convicted was Byron De La Beckwith, who was responsible for killing civil rights activist Medgar Evers in 1963.

Safe Winter Driving Tips



(StatePoint) While winter can be a beautiful time of year, it can also be a treacherous season on the roads. Winter driving conditions require increased attention and an ability to adapt quickly.

In 2015, 8,010 people nationwide were killed in car crashes between December and March, resulting in an average seven percent per month increase from 2014, according to the National Safety Council (NSC). "Winter looks more idyllic outside our house windows than outside our windshield," said Deborah A.P. Hersman, president and CEO of the National Safety Council. In an effort to prevent crashes on the road this winter, MyCar-DoesWhat, an NSC and University of Iowa initiative, is offering some major pieces of advice for driving in winter conditions.

• Slow down. Drivers frequently underestimate how long it takes to brake and how difficult it can be to steer on slippery roads.

• Don't use cruise control on slippery surfaces like ice and snow. It will diminish your control and reduce your reaction time in the event of a skid.

• Remember, bridges and overpasses freeze before roadways, so be alert in cold weather when approaching one.

• Many new safety technologies (like back-up cameras) have outside sensors that can freeze or fog up. Always make sure they are clear so they work their best.

MyCarDoesWhat also reminds drivers of the safety technologies that can help vehicles adapt in slippery and changing conditions. • Adaptive headlights adjust to changing roadway conditions -such as curves -- to provide optimum illumination along the roadway during long winter nights and periods of low daytime visibility.

 The temperature warning feature provides updates about upcoming roadway conditions such as black ice.

"When there is snow and ice on the road, antilock brakes can improve the stability of your braking so you can steer better," said Dan McGehee, director of the University of Iowa National Advanced Driver Simulator. "Remember to hold the brakes down even when they pulse and vibrate."
