

The president has fired FBI Director James Comey, who was overseeing an investigation into Russian meddling in the 2016 elections and possible ties to the Trump campaign and top aides.

The White House pointed to Comey's handling of the probe into Democratic presidential nominee Hillary Clinton's private email server while secretary of state as the reason for his dismissal. But Democrats were quick to call the move "Nixonian," saying that the decision by Trump was part of an effort to impede the Justice Department's Russia investigation which, in the view of many leading Capitol Hill Democrats, could now only be managed by a special prosecutor going forward.

"Today, President Donald J. Trump informed FBI Director James Comey that he has been terminated and removed from office. President Trump

acted based on the clear recommendations of both Deputy Attorney General Rod Rosenstein and Attorney General Jeff Sessions," White House press secretary Sean Spicer said in a statement.

"The FBI is one of our Nation's most cherished and respected institutions and today will mark a new beginning for our crown jewel of law enforcement," the president said in the statement.

Russia probe looms over surprise dismissal

The abrupt decision by the White House brings to an end a tumultuous tenure for the career prosecutor who found himself at the center of controversy about the 2016 election, taking heat from both sides.

But it also raised questions about the ongoing Russia probe, with Democrats saying the firing was an effort by the White House to derail the investigation.

'Nothing Less Than Nixonian': Democrats React To Comey Firing

"The first question the administration has to answer is, why now?" said Senate Democratic Leader Chuck Schumer, D-N.Y. "If the administration had objections to the way Director Comey handled the Clinton investigation, they had those objections the minute the president got into office. But they didn't fire him then. Why did it happen today?"

"If Deputy Attorney General Rosenstein does not appoint an independent special prosecutor, every American will rightly suspect that the decision to fire Director Comey was part of a cover-up," Schumer continued.

FBI director became a flashpoint in 2016 election

Comey first made waves in July 2016 when he announced that the FBI was not recommending any charges against Democratic presidential nominee Hillary Clinton over her handling of her controversial private email server while she was secretary of state during the Obama administration.

Comey had repeatedly reiterated he planned to remain at the FBI, saying in March, "You're stuck with me for about 6 1/2 years."

The "100 Day" Presidential Milestone Is Meaningless

Cecilia Marshall never imagined that the battle for equal rights in schools and elsewhere would still be as vital today as it was six decades ago when her husband, United States Supreme Court Justice Thurgood Marshall, fought to end legal segregation as a civil rights lawyer with the NAACP Legal Defense Fund.

"We haven't made too much progress," said Cecilia Marshall, 88. "Sixty-three years later, we're still fighting in the courts for equal treatment and that's not what my husband, nor I would have imagined would be going on today."

There's little argument that one of the greatest achievements in the long and illustrious career of the late-Justice Thurgood Marshall, who died in 1993 at the age of 84, was the landmark decision in the 1954 Supreme Court case Brown v. Board of Education.

According to the NAACP Legal Defense Fund, in 1940, "Marshall became the key strategist in the effort to end racial segregation, in particular, meticulously challenging Plessy v. Ferguson, the Courtsanctioned legal doctrine that called for 'separate but equal' structures for Whites and Blacks."

The Brown v. Board of Education lawsuit began as five separate cases filed in South Carolina, Delaware, Virginia, Washington, D.C. and Kansas. The plaintiffs in all of the cases alleged that the civil rights of their children under the 14th Amendment had been violated.

A biography about Justice Mar-

spiring the Civil Rights Movement that unfolded over the next decade and it also led to Marshall being recognized as one of the most successful lawyers in America.

"He accomplished so much and worked so hard, but I thought by now we would have come so much further. He would have thought that, too," said Marshall, whom loved ones and others affectionately call "Cissy."

Her work continues in her husband's memory.

On the 63rd anniversary of Brown v. Board of Education, Marshall and the Thurgood Marshall Center Trust plan to host a fundraising gala to observe the historic decision and to announce a call to action, which she's titled, "Equal Education for All Based on the Brown Decision."

The event will be held at the Thurgood Marshall Center for Service and Heritage in Northwest, Washington, D.C.

"The problems remain and this event, this anniversary, comes against the backdrop of a significantly troubling retrenchment of access to education for African-Americans, Latinos and other children," Marshall said.

She cited a Leadership Conference on Civil and Human Rights report that said there are numerous factors that appear to have combined to cause the rapid resegregation of schools since 1991, the year her husband retired from the bench.

The courts began turning against desegregation plans in the 1980s—denying new petitions to desegregate schools, ending previous court imposed plans and even striking down voluntary plans created by local school districts, according to the Leadership Conference on Civil and Human Rights, a diverse collective of more than 200 national civil and human rights groups.

panic and African-American populations and growing income disparities have increased the concentration of minorities living in high poverty districts.

Leaders from the National Newspaper Publishers Association (NNPA) and others plan to join Marshall at the historic event to celebrate the life and legacy of Justice Thurgood Marshall.

"The NNPA reaffirms the living legacy of U.S. Supreme Court Justice Thurgood Marshall," said Dr. Benjamin F. Chavis, Jr., the president and CEO of the NNPA. "We note this month the 63rd anniversary of the landmark 1954 Supreme Court decision. Marshall utilized his legal genius and courage to win that case."

Chavis continued: "Today, it's important to reassert the critical importance of continuing to demand equal, high-quality education for Black American students and all students across the nation."

Marshall, she said that, she still gathers with the wives of former and current Supreme Court Justices.

"We're a big family, we call ourselves 'sisters," she said.

Those get-togethers, as well as the success of her two sons— Thurgood, Jr., and John W. serve to further validate her husband's legacy.

"Seeing his sons grow up to become adults—Thurgood, Jr. a lawyer; and John serving in civil service—has been a great joy," said Marshall. "My husband gave me and all of us a great life and his favorite slogan was something we've always lived by and I still live by today, especially when I think of the state of things in this country."

She said that slogan is, "Never give up."



Representatives Ask for Attorney General Opinion on AK Steel Michigan Strategic Fund board approved controversial tax credits

-State Reps. LANSING Stephanie Chang (D-Detroit), Abdullah Hammoud (D-Dearborn), Pete Lucido (R-Shelby Township) and Martin Howrylak (R-Troy) announced today that they are asking Michigan Attorney General Bill Schuette for an opinion about the legality of the Michigan Strategic Fund board's approval transferring Severstal North America's tax credits to AK Steel. The legislators said that by going around the Legislature, the company may avoid answering questions about environmental protections for surrounding neighborhoods and could be violating Michigan's Income Tax Act. Last session, Senate Bills 1162 and 1163 would have allowed AK Steel to claim MEGA tax credits that were awarded to the previous operator of the facility, but those bills did not receive a vote on the House floor. At their Tuesday, April 25 meeting, the MSF awarded both MEGA and brownfield credits without legislative approval.

"AK Steel has received several air quality violations from the Department of Environmental Quality since acquiring the Dearborn site - as recently as this February and last October," Rep. Chang said. "The fact that this corporate tax break comes without any environmental protections or accountability adds even greater insult to the rushed, non-transparent process MEDC used to push through a proposal with questionable legality. This should have gone through legislative vetting and greater public scrutiny. We are hopeful that the Attorney General will weigh in on the legal issues at hand."

"Dearborn residents are concerned about this plant and its effect on air quality, and yet they've been deprived of having their say in this process just as the Legislature has," said Rep. Hammoud. "Citizens and the Legislature should have had a say in this, but the MSF went around us and granted the tax credit agreement to AK Steel. I hope Attorney General Schuette will weigh in on this and argue for greater transparency so that residents and their elected representatives can have a say in these matters."

"This whole process has been very convoluted," said Rep. Lucido, "First, AK Steel wanted legislative approval, which is the proper venue for this request. However, when they couldn't get it done through the legislature they go around us and get a dubious approval from the MEDC. With the implications in the business tax filings, and the jumping around the state government looking for what they wanted, it is proper for the Attorney General to review this matter to see if the law was broken."

"The Michigan Strategic Fund Board's decision sets a dangerous precedent by allowing a specific company to acquire a tax loophole without going through the legislative process to amend the Tax Code," said Rep. Howrylak. "In light of the precedent set forth by this decision, it is appropriate to request the Attorney General's legal insight to ensure transparency and equal accountability under the law."

The representatives are basing their request for an attorney general's opinion on AK Steel's filing for the credit. AK Steel filed its first tax return after Dec. 31, 2011, under the corporate income tax. Nothing in the documents provided by the MEDC to the Michigan Strategic Fund Board indicates what authority is being used to reauthorize AK Steel to file under the Michigan Business Tax Act. This would appear to be a requirement for receiving the MEGA and brownfield credits they intend to receive under the agreement.

shall that appears on The Legal Defense Fund's website said that, "Marshall won a series of court decisions that gradually struck down ['separate, but equal'], ultimately leading to Brown v. Board of Education, which he argued before the Supreme Court in 1952 and 1953," finally overturning the doctrine and acknowledging that segregation greatly diminished students' selfesteem."

On May 17, 1954, the Supreme Court unanimously ruled that separate educational facilities were "inherently unequal" and that racial segregation of public schools violated the equal protection clause of the 14th Amendment of the U.S. Constitution.

The Brown v. Board of Education decision came more than a decade before Marshall's appointment to the Supreme Court. The decision has been credited with in-

Further, executive branch agencies topped the aggressive campaign to enforce the Brown decision and the Civil Rights Act that proved successful in the 1960s and 1970s, the Leadership Conference reported.

Kroger to get some groceries. I did the self checkout as I often do. I usually decline the cash back option, but on this day, I decided that \$40 cash would be good to have on hand. Almost at my next stop, to pick up my son at the barber shop, I reached for my cash and it was not there.

I thought about my cash back request and did not recall removing my cash from the dispenser. I hurried and called the location and headed over there. While on hold and driving, I was hoping that someone was honest enough to turn in my cash.

That thought prompted me to ask myself, "what would you do?" I like to think if I had found \$40 in the cash dispenser, I'd turn it in to be given back. But I also thought that whoever picked it up probably thought it was their lucky day to find \$40 and pocket it.

West Virginia Police Officer Fired for Not Shooting Files Suit Against Municipality



Officer Stephen Mader lost his job on June 7, 2016, a month after another police officer fatally

shot Ronald "RJ" Williams. WEIRTON, W.Va. – The American Civil Liberties Union of West Virginia and the Law Offices of Timothy P. O'Brien, Esq. (lead counsel) have filed a wrongful termination lawsuit against the city of Weirton, West Virginia, on behalf of Stephen Mader, who was fired from the Weirton Police Department because he chose not to shoot and kill R.J. Williams, an African-American male, during a domestic disturbance call in May 2016.

Williams' girlfriend had called 911

or aggressive," says Stephen Mader. "He seemed depressed. As a marine vet that served in Afghanistan and as an active member of the National Guard, all my training told me he was not a threat to others or me. Because of that I attempted to deescalate the situation. I was just doing my job."

After the shooting, police confirmed that the gun held by R.J. Williams — as had been reported by Williams's girlfriend and as Mader suspected — wasn't loaded.

"The city of Weirton's decision to fire officer Mader because he chose not to shoot and kill a fellow citizen - when he believed that he should not use such force, not only violates the Constitution, common sense and public policy - but incredibly punishes restraint - when given the tragic, and, far too frequent unnecessary use of deadly force," says lead counsel, Timothy P. O'Brien. "Such restraint should be praised, not penalized. To tell a police officer - when in doubt - either shoot to kill, or get fired, is a choice that no police officer should ever have to make and is a message that is wrong and should never be sent."

May 3rd, 2017

At 1130hrs, an officer was dispatched to the police station lobby on a report of Assault & Battery. A 25 year old female stated she broke up with her boyfriend and went to his home in Melvindale to pick up her belongings. She stated while she was there she was looking through the residence when she came across some of her old cellular phones that the boyfriend had taken from her. So she took her phones and her other property while her 23 year old boyfriend stood by. At 1030hr, the boyfriend and another female enter in the 100 Block of Haltiner Street without her permission, while she was lying in bed. They entered her room and grabbed her by her hair and pulled her out of bed. The boyfriend asked her where the cell phones were and she told him she didn't have them and that they were hers. The boyfriend told the female that was with him to hit her and she told him no and agreed that the phones belonged to his girlfriend. The boyfriend began moving things around in the bedroom until he located one of them under her mattress and he broke it. The girlfriend states she didn't have any injuries and the female that accompanied him was unknown and lived in Woodhaven.

May 2nd, 2017

At 1946hrs, officers were dispatched to the 500 Block of Beechwood Street on a Threats complaints. A 41 year old female states at 1730hrs her 18 year old daughter and her 19 year old boyfriend got into an altercation on 18th & Hyacinth Avenue in the City of Ecorse. When she was leaving he took out a semi-automatic handgun and shot off several rounds. She states she fled with her month old daughter and fled back to her home. The boyfriend came to her home in the alleyway and threatened to shoot her because of their previous altercation. He told her to quit playing with him or he would shoot at her. He is known to ride on a bicycle and carry a weapon.

May 1st, 2107

At 1157hrs, officers were dispatched to the 200 Block of Goodell Street on a disturbance. A 19 year old female stated that a 19 year old female entered her home and pepper sprayed her residence. The officers smelled a strong odor of pepper and began coughing and choking on the fumes. The female told her daughter to stay outside and get fresh air. The daughter's eyes began to burn and she couldn't see out of them so Rapid Response was notified. The mother states the incident began at 1150hrs, when she heard a knock at the front door, and when she opened the door the suspect female was standing there and began making threats towards the mother stating she was going to beat her up for an incident that occurred with her daughter and the suspect. The mother told the female to get off her property while she walked back inside. Then suddenly the suspect female open her door and entered her living room and pulled out the pepper spray and began spraying. The suspect female left and went home in the 300 Block of Goodell Street.

because he was threatening to hurt himself with a knife. When Mader reached the house, he found Williams outside with his hands behind his back. After several orders from Mader, Williams showed his hands, and he was holding a gun. He said to Mader repeatedly, "Just shoot me," and Mader kept replying calmly, "I'm not going to shoot you. Just put the gun down." Williams appeared to be choked up; Mader was certain he was suicidal. Two other officers arrived at the scene, and within seconds, one shot Williams in the head, killing him. The Weirton Police Department placed Mader on administrative leave and then fired him for supposedly putting other officers at risk by failing to shoot and kill Williams.

"When I arrived at the scene, Mr. Williams was pleading for me to shoot him. He didn't appear angry After the city of Weirton fired Mader, he spoke to a newspaper about the death of Williams and his termination. In response, the city and its agents engaged in a campaign to harass Mader and tarnish his reputation by holding a press conference making false allegations against Mader, sending profanity-laced text messages and spreading misinformation about him at his job training program.

"Officer Mader did exactly what we want our police officers to do. He attempted to deescalate a tense situation. He attempted to save R.J. Williams' life. The Weirton Police Department so deeply misunderstands Stephen Mader's sensible attempt to prevent violence and death that it kicked him





off the force and then publicly attacked his character when he spoke out," said Joseph Cohen, Executive Director of the ACLU of West Virginia. "The Weirton Police Department, like so many others in West Virginia, needs training to appropriately engage with people, to fight the implicit biases that infect our society, and to make deescalation a primary goal."

"I lost a job I loved," says Mader.

"As a police officer, I took an oath to protect and serve my community. I feel like I was fired for trying to uphold that. Even still, I would have done the same thing."



"However. I tell female entrepreneurs, all the time, not to beat themselves up about it; understand it and move on," said Dunn. "Once you fully understand the way capital and funding works, it then becomes easier to access it and that's what 'Keys to Success' is all about: providing a platform to solve the number one issue facing women minority business owners-access to capital."

NAACP CALLS FOR ACCOUNTABILITY, ARREST, AND PROSECUTION IN THE FACE OF PERSISTENT POLICE VIOLENCE



Jordan Edwards, the 15 year old killed by a police officer

BALTIMORE---We join families and communities in mourning and action as our nation is again confronted with the depth and consequences of our national policing crisis.

This is a time of immense grief for those who have lost loved ones to police violence. Jordan Edwards's family is dealing with fresh pain due to his senseless murder, which robbed him of his future, deprived his family of their son, and traumatized his siblings. Although the successful prosecution of Walter Scott's killer was an unusual ray of hope in the fight to hold police accountable, pleas for justice for Alton Sterling went unheard when the Department of Justice failed to prosecute those who killed Alton Sterling.

These individual cases raise deep concerns. Another Black child has been senselessly gunned down by police. A false scenario was initially used to justify Jordan's death, and it was only retracted when contradictory video evidence came to light. Without the video, the police narrative would have been taken without question and Jordan would have been depicted as the aggressor. Although we applaud the firing and murder charges brought against one of the police officers involved, this alone is not enough. A murder has been committed, and the person who committed it has been caught on tape. Yet, a week later, the perpetrator was left to turn himself in and is now walking free until trial. This situation is a grim reminder of a fundamental lack of accountability and the unequal justice often received by victims of police violence.

on statements by police officers that were not confirmed by the video evidence. The DOJ did not give a federal jury the opportunity to determine whether it would believe the officers' narrative. Justice for Alton Sterling has not been provided, and we will work to ensure that the State of Louisiana properly investigates and prosecutes this case. We will also continue to push for the DOJ to live up to its legacy as a frontline defender of civil rights.

We are also concerned about the treatment of the families of victims of police violence. After watching Jordan die, one of his brothers was handcuffed and held by police. Mr. Sterling's family was kept in the dark. Instead of being informed about the progress of the investigation, they had to learn about the DOJ's decision from the news media. This disrespect of grieving families cannot be justified and cannot be tolerated in future cases.

We cannot let Jordan Edwards become just another hashtag. We will stand with his family and others who have been victims of police violence. We will pursue justice for Jordan, for Alton Sterling, and for Walter Scott. But we must do more than that. We must work to ensure this story is not repeated. We need to pursue structural changes to ensure that police officers will not threaten our children and our community but will instead fulfill their charge to protect and preserve our lives.

What a legacy they leave for their beautiful families. These guys are doing things they never use to do (as per the varied division of labour that occurs in any given family), and they are doing some of the things that Mom only once did. 
