DAY | MARCH 8

International Women's Day celebrates the social, cultural, economic and political achievements of women across the globe. But far from singling out women, the day focuses on unity, equality and advocacy - especially in a world where the differences and injustices between women and men are as great as ever. Over 20 countries – particularly in Asia – celebrate it with a day off work for all, while another three (including China) allow all women to take a day off. Although many people who seem to have a problem with the concept of International Women's Day may think it's a modern invention, it's anything but; its first official acknowledgement was back in 1911, and became a cornerstone holiday in the Soviet Union from 1917 (even being a day off

from work from 1965 onwards). Since 1977, the United Nations has made it a focus day for both women's rights and world peace.

The theme for International Women's Day, 8 March, is "Time is Now: Rural and urban activists transforming women's lives".

This year, International Women's Day comes on the heels of unprecedented global movement for women's rights, equality and justice. This has taken the form of global marches and campaigns, including #MeToo and #TimesUp in the United States of America and our counterparts in other countries, on issues ranging from sexual harassment and femicide to equal pay and women's political representation.

SPRING BREAK IS A TIME TO SERVE Howard University Students Help, not Party

WASHINGTON—When Oluwakanyinsola Adebola signed up to do community service as part of Howard University's Alternative Spring Break, she knew she wouldn't be joining her classmates and thousands of other college students who use their week off to party and play in the sun and surf of Jamaica or Aruba or any of a half dozen other Caribbean locations.

Instead, Adebola would be part of the hundreds of Howard students who, each year for more than 20 years, have given up their traditional spring breaks to serve in communities in need in places like Atlanta, Chicago, Detroit, Baltimore, Memphis and New Orleans. Ironically, Adebola will travel to

a Caribbean island after all. She will be in Puerto Rico aiding the millions of U.S. citizens still struggling to recover from Hurricane Maria, which hit the island on September 20.

The storm, which had 155 mph winds, caused at least \$90 billion in damage, destroying thousands of homes, killing at

least 60 people and decimating the island's already deteriorating power grid. Currently, about 1,200 generators power some of homes, hospitals and schools while seven larger, more powerful energy centers, called microgrids, provide energy to key areas near important buildings like hospitals and schools.

Electricity, however remains a challenge. Recurring blackouts plague the island, and about 340,000 people, are still with-

Officials brainstorm on Economic and **Social Justice**

On Saturday, March 3rd, officials from Lincoln Park,. Detroit, Inkster and Wayne County, met to hear a presentation from Dr. Norman Kurland, President of the Center for Economic and Social Justice.

In attendance were Chris Dardzinski, Councilman, Lincoln Park; Matthew Coppler, City Manager, Lincoln Park; Leslie Lynch-Wilson, DDA board member, Lincoln Park; Brenda Jones, Council President, Detroi; Linda Wesley, Aide to Council President Jones; Connie Mitchell, Councilwoman, Inkster; and Phil Cavanagh, Wayne County Treasurer's Office

The subject was The Capital Homestead Act. Dr. Kurland will be coming to Lincoln Park on April 28, to give a presentation, to a much larger group of public officials and special guest, at the Kennedy Memorial Building.

The 'core-group' meeting this past Saturday, was an effort to build support, with a small group of Wayne County and municipal leaders, to help promote involvement, for the April 28 conference.

Councilman Dardzinski sees

this as a positive-proactive way to move forward, by putting together the proper leaders, to support a progressive big solution, to a big problem.

Direct individual ownership of capital and all aspects of economic development, is the crucible of the Capital Homestead Act. Councilman Dardzinski further sees this as a way, to change the economic dynamic of Wayne county, as a pilot

model for the whole country. Dr. Kurland has been working on these ideas since the mid-1960s. The Center for Economic and Social Justice is an all volunteer policy center and think tank; whose goal is citizen-ownership and social justice for every Child, Woman and Man.

Politicians Need to be Reminded They are Public Servants

In their determination to be elected to public office, candidates tend to focus all their attention on running a successful campaign and are slip-shod and neglectful at comprehensively addressing issues that impact the people they seek to represent.

The people are not an afterthought or a rubber stamp to further a politician's personal and private agenda; the people are the purpose behind the design and establishment of elective government. Or, at least, this is how it should be.

The record shows that our representatives in government have a sad, sorry and outrageous tradition of failing their constituency. Yet the dog and pony show of political grandstanding continues, with campaigns reduced from platforms where candidates reveal their abilities and plans to serve the people, to arenas where mudslinging and personal attacks against opponents are the central theme.

Once candidates are elected to office, the situation goes from bad to worse, for now they carry themselves with the smug air of arrogance and entitlement; attitudes that are more suited for entertainment and sports stars than for the denizens of public office.

In these dire economic times, it is especially obscene for elected officials (who are nothing more than public servants) to pass legislation

that raise their own salaries, to ride around in luxury vehicles at public expense, and to accept kick-backs and "gifts" from special interest groups and corporate sponsors, while talking down to John Q Citizen and telling him to tighten his belt and to pull himself up by his bootstraps.

If nothing else the campaign and election of Donald Trump

to the highest political pedestal should have alerted us to the importance of a careful vetting of those that seek public office and the necessity of holding their feet to the fire along the way. And the realization that they are just as fallible as the rest of us-or even more so.

The haughty attitude of some politicians is nothing less than amazing. Public meetings are announced for specific times and elected officials show up unapologetically late accompanied by a phalanx of bodyguards that cordon them off from the very people that voted them into office. Don't get me wrong. I'm not suggesting that the president of the nation or even some governors don't need protection. But it has gotten out of hand when you see mayors of cities parading around with 24-hour security teams and fleets of limousines.


The people are not blameless in all off this because they often display a sycophantic, fawning attitude toward politicians and neglect to demand more when the could have and failed to hold them accountable when they should have.

There was a time in American history when people were reluctant to seek public office because of the huge commitment involved in safeguarding the good and the relatively meager monetary rewards of an elective government job. But now things have changed with candidates scurrying for public office like lizards and clawing and scratching and seeming ready to do almost anything to win the coveted prize.

It is apparent that most of them have forgotten that being an elected official is not a golden opportunity for self-promotion and self-aggrandizement; but is one of self-sacrifice and of serving the people to the best of one's ability.

CITY OF INKSTER & CITY OF WESTLAND ANNAPOLIS ROAD RECONSTRUCTION

Project Description

The City of Inkster and City of Westland are joining forces to undertake a pavement reconstruction project along Annapolis Road between Middlebelt Road and Inkster Road. Traffic will be restricted to a single lane eastbound one way, and single lane westbound, depending on phasing, with intermittent stoppages of traffic by flaggers during certain construction activities. The project will be completed in two phases; Phase 1 includes concrete slab replacements and repairs on the South side (City of Westland) and Phase 2 includes the reconstruction of the North side (City of Inkster).

Access

Repair work will be scheduled to maintain a minimum of one driveway open to those properties with multiple driveway entrances. There will be a few individual residences that will have their driveway access temporarily restricted. The contractor will work with those particular residences to find alternate parking while driveway access is restricted.

<u>Tentative Key Construction Dates – these are project and weather dependent</u>

Phase 1 – Tentative start April 9, 2018 – complete April 28, 2018

Phase 2 – Tentative start April 30, 2018 – complete July 6, 2018

Phase 1 South Side of Road Repair (City of Westland)

The eastbound lane will be closed to traffic to perform intermittent concrete removal and replacement. During this phase it is advised for eastbound traffic to travel to Van Born Road to the south or Carlysle Street to the north to bypass construction. Once repairs are complete, and the concrete has cured, eastbound traffic will be open throughout construction.

Phase 2 North Side of Road Repair (City of Inkster)

The westbound lane will be closed to traffic to perform concrete removal and



replacement. During this phase it is advised for westbound traffic to travel to Van Born Road to the south or Carlysle Street to the north to bypass construction. Once the repairs are complete, and the concrete has cured, traffic will be restored in both directions.

Project Detours

The phase 2 detour route while Annapolis Rd is reduced to one-way traffic, will be along Inkster Road south to Van Born Road, right at Middlebelt Road. The detour route will not be signed.

Frequently Asked Questions

- How will access to homes be maintained?
 During construction access to homes will be maintained. However, at times residents will be required to park elsewhere while the concrete cures.
- Will trees be removed as part of the construction project?
 Some trees are scheduled to be removed as part of the construction project, and will only be removed as necessary. Trees scheduled for removal will not be replaced.
- What about lawn restoration?
 Disturbed lawn areas will be fully restored to preconstruction condition with topsoil, fertilizer, seed, and mulch, or sod. If necessary, the contractor will return in Fall 2018 to ensure grass growth.



Boarding the Bus and Making a Decision

Many people know of Rosa Parks, but do you know Claudette Colvin




Claudette Colvin

After school on March 2, 1955, Claudette Colvin walked to downtown Montgomery with three of her classmates. She and her friends were going to take the city bus home from school that day. When they boarded the bus, they sat behind the first five rows, which were reserved for white pas-A young white sengers. woman boarded the bus after Colvin and her friends and found nowhere to sit because the white section was full. Bus drivers had the authority to make black passengers move for white passengers, even if they were sitting in the black section. The bus driver asked Colvin and her friends to get up, which her friends immediately did. She refused to move. On her mind were the lessons she had learned throughout her life, especially during Negro History Month at her school just days before. Though her friends' seats (one next to Colvin and two across the aisle) were now vacant, the white woman refused to sit in them because, according to Jim Crow laws, black people could not sit next to next to white people. They had to sit behind white people to show their inferiority. When asked again, Colvin refused to get up. The bus driver alerted the traffic police, and three stops later, a traffic officer came onto the bus and asked her why she was sitting there and why she would not get up. She replied, "because it's my constitutional right," and told him she was not breaking the segregation law by sitting there. The traffic officer told the bus driver that the police needed to get involved. A stop or two later, two police officers came onto the bus and instructed Colvin to get up. She refused. She later said, "I could not move because history had me glued to the seat...Sojourner Truth's hands were pushing me down on one shoulder and Harriet Tubman's hands were pushing me down on another shoulder." The police officers each grabbed one of her arms, kicked her, threw her books from her lap, and "manhandled" her off the bus. She was arrested and her minister bailed her out later that day.

This was one major factor that led to the Montgomery Boycott. Nine months later, Rosa Parks refused to give up her set on a Montgomery City bus.

A few years later, Colvin moved to New York and worked in the medical field.

Kimberly Hill Knott has big plans for the 13th District



Kimberly Hill Knott was born in Milwaukee, Wisconsin and has the desire to represent the people of the 13th District in Washington DC.

She acquired a bachelor's in education from the University of Wisconsin-Milwaukee, and then a master's in educational administration from Temple University in Philadelphia.

While working on Capitol Hill as an intern, under the leadership of Bill Goodling, former Chairman, House Committee on Education and Labor, Kimberly became intrigued with the political process.

After graduating from Temple

University, she wrote Congressman John Conyers office to see if there were any job opportunities available, and they asked her to come in for an interview. She took a train from Milwaukee, Wisconsin to Detroit, interviewed with the congressman, and was then hired on the spot. This began Kimberly's love of working in public

As a legislative assistant to Congressman John Conyers, Kimberly was able to help prisoners transition back into society, much like her father did with his business. She helped craft legislation that supported ex-offenders, and prevented them from falling into conditions of homelessness. She also convened federal and state probation officers and workforce development specialists to develop a pilot job training program for ex-offenders, Additionally, she co-led With Ownership Wealth (WOW)-an initiative of the Congressional Black Caucus Foundation, with former Congresswoman Carolyn CheeksKilpatrick's office. WOW was a homeownership program, housing over 500 first-time homebuyers and reducing the home foreclosure rate in Michigan's 13th and 14th Congressional Districts. However, one of her most memorable moments was receiving a call from a constituent that needed help rescuing a loved one trapped in a dorm at New Orleans's Xavier University dur-Hurricane Katrina. Kimberly worked closely with the National Guard to facilitate the rescue of 300 students.

After spending over a decade working under the leadership of Congressman John Conyers, Kimberly was inspired to involve herself in the emerging fight of environmental justice. She furthered her interest in the political arena by joining the staff of Detroiters Working for Environmental Justice (DWEJ), as Policy Director. DWEJ is an award winning social enterprise, dedicated to Detroit becoming the global model of a vibrant urban center, with an emphasis on prosustainable moting redevelopment and environmental justice.

She felt it was essential to make regulators at the Environmental Protection Agency (EPA) aware of the environmental degradation occurring in Detroit.







Detroit Bail Bondswoman Provides Info on Judicial Awareness

America is a nation that is supposed to function by the rule of law. However, if a person does not know or understand the laws that govern the nation (or the locality where a person resides) then it is very easy to be victimized by the legal system and its enforcers- the police.

Years ago, renowned attorney F. Lee Bailey, wrote a book in which he surmised that the American judicial system is not based on whether a person is innocent or guilty of a crime; it is based on whether legal procedures or legal precedents were followed properly.

Krystal Banks is doing her part in ensuring that people will know some of these laws and procedures.

Banks has the distinction of being the only property bail bondswoman in Michigan. She is the owner of Banks Bail Bonds, with offices in Detroit, Port Huron, and Lapeer. And she has taken her 18 years of experience in the field and written two books to help people to understand their rights and their options when (or if) they are in contact with police or the courts.

Her publication entitled, 'Don't be a Dumb Criminal' and the companion work book of the same name, are powerful yet easy to read works on how to avoid the common and not so common traps that the unwary and unaware can fall into.

Banks books are timely and needed, especially in view of the many Black and poor people that have suffered in recent years and had their ordeals video-taped and broadcast on social and mainstream media sites. She understands that it is not only important to know your rights, but to know what to do and what not to do when you are stopped by the police, arrested, or ensnared in the criminal justice system.

"When you are arrested, you're being recorded," warned Banks. "And when you go to jail, it's being recorded; or the inmate that you're in the cell with can be called as a witness against you. When you're talking to your family members from jail; talking about the circumstances of your arrest, it's being recorded. And they are going to use it against you."

Her book was released last summer and has sold thousands of copies and will likely sell thousands more once it becomes better known. She also provides learning sessions and workshops to empower young people and adults to be knowledgeable about the law, court rules and judicial procedures. The workshops are conducted not only as educational events, but as social settings where meals and the opportunity networking and exchange of ideas is provided. The workshop she held on March 2nd featured a former law enforcement official as well as a criminal attorney as part of the discussion. Some of the topics included: knowing your rights, knowing minors' rights, knowing how the court system works, understanding warrants, understanding profiling, understanding

human trafficking, and understanding activities that seem harmless but are criminal. Her book goes into more detail about how to find the right attorney; how to prepare for your defense, understanding the sentencing process and much more.


She also gives insight into the potentially dangerous tendency of young people to reveal their activities on social media. "On Facebook and social media, you've got money in your pictures, but you don't have a job. Guess what, don't be surprised if there's a task force watching."

Banks wrote her books and holds her seminars and workshops because she wants people to understand the system. And she wants to correct the assumption that just because you are not a criminal and may not have broken any laws, you have nothing to be concerned about in the court system. She emphasizes that there are plenty of innocent, naïve, and unaware people who were convicted of crimes and are doing long jail and prison terms.

"I hear people complaining about how they didn't get a fair trial, and they don't know why," she writes in her book. "It's because the system is stacked against them. That's why it's important to understand what the heck is going on. I wrote the book with the help from attorneys, judges, police officers, and several friends. I got tired of seeing people not understand the system. Crime is not just 'in the hood.' Crime is happening everywhere."



Spring is on its way and it will soon be time to get out and enjoy the warm weather. Fortunately, for those of us who love the outdoors, we have Hines Park Trail. Southeastern Michigan is loaded with all sorts of gorgeous parks and recreation areas, some of which are managed locally and others which are managed by the state. Hines Park Trail, also known as Edward Hines Drive is managed by the Wayne County Parks Department.

Hines Park Trail is a meandering trail which runs over 17 miles in length from Dearborn, west through Livonia and Plymouth, all the way to Northville. Along the way there are numerous recreations areas which allow for softball, soccer, picnicking, and even fishing. The trail is a haven for joggers and bicyclists and even those who take advantage of the many miles of nature trails. Hines Park Trail is also home to the Wayne County Dog Park. The dog park is located within the Hawthorn Ridge Recreation Area, west of Merriman Road. All dogs must be registered with at the Wayne County Parks Office and be up to date on vaccinations. You can find out more at www.waynecounty.com.

The setting is nature, nature and more nature as visitors can observe raccoons, skunks,

follows along the Rouge River, which connects to Newburgh Lake, Wilcox Lake and Waterford Pond. Ducks, swans and other varieties of waterfowl are both residents and frequent visitors, particularly at migration times.

Prior to European settlement, the Rouge River was a travel way for both Native Americans and fur trappers. Hines Drive as we know it today was built in 1949 on land which was donated by Henry Ford. It is named after Edward Hines, who was at that time the head of the Wayne County Road Commission.

In November and December, Hines Drive is home of the Wayne County Lightfest, an annual holiday light show. Since 2011, the area has been host to Crusisin' Hines, one of many area classic car shows and cruises. This year the event will be held on August Find out more at www.cruisinhines.com.

out power. The blackouts have upset traffic and interrupted water service to dozens of neighborhoods, including the historic Old San Juan in the nation's capital.

The Federal Emergency Management Administration has been providing relief and rescue efforts, providing meals and water to residents.

Adebola and 47 other students, accompanied by two faculty advisors, land in Puerto Rico Friday, March 9, and begin a week of work on Monday, March 12. The ASB participants will paint schools and fix homes and churches in and around San Juan, the island's capital.

Howard students will also visit and assist in the daily activities at two Boys and Girls clubs in Las Margaritas and Bayamón about 20 minutes outside of San Juan. Students and faculty will be staying about an hour west of San Juan at a campsite in Arecibo, six people to a room.

This year, no students applying for ASB knew where they would be placed when they signed up for the annual service missions. Applicants selected a service preference ranging from "children/orphanages" to "prison rehabilitation." The luck of the draw would determine at which of this year's 15 service sites they would be placed.

Adebola, an ASB first-timer, said when she checked "recovery" on her application, she thought she would be going to Houston or Belle Glade, Fla., two U.S. cities that also were hit hard by hurricanes last fall. She said she never expected to be placed in Puerto Rico.

"I'm really excited," she said.

A native of Nigeria, Adebola moved to the United States to learn mechanical engineering to further technological advancement in her country, which she said lacks proper waste disposal systems, consistent electricity and access to clean drinking water in many parts of the country.

She said old medical equipment failed to save her 13-year-old sister's diminishing eyesight, leaving her completely blind.

Adebola, who created a nonprofit organization at 13 to help Nigerian children, said that the goals of ASB align perfectly with hers.

"The purpose of ASB is to help people, and it gives me something productive to do," she said.

More than 700 students will participate in ASB service missions to 14 other underserved areas and regions devastated by natural disaster this year, including St. Thomas, St. Croix, St. Martin, Anguilla, Haiti and Ghana. Groups will also go to Chicago, New Orleans, Port Arthur and Beaumont in Texas, the Florida Keys and Flint, Mich.

"We decided to go to places hit hardest by the hurricane," said Puerto Rico site coordinator Kyliah Hughes, 20.

According to Hughes, ASB planners wanted to "make a statement" about their commitment to service by visiting places further than the usual domestic sites. Dijon Stokes, 20, a team leader for Puerto Rico, agreed.

"We have to help beyond borders," Stokes, said. "We go where we're needed, and we will visit those places devastated by the hurricane until we see real recovery."

lanta and Terri Sewell of Birmingham delivered emotional messages to those in the audience, many of whom were not alive when the Voting Rights Act was approved by Congress decades ago.

Lewis and Sewell come from different age groups, but each stressed the importance what the Voting Rights Act of 1965 means to America.

"We've made some progress but we still have a distance to travel," said Lewis, who suffered a skull fracture on the Edmund Pettus Bridge on March 7, 1965, when state troopers scattered 600 peaceful protesters, using clubs, tear gas and horses.

It's a story that Lewis has told over and over through the years, but one that never seems to tire him out or bore listeners.

Speaking at the church on Martin Luther King Jr. Street, Lewis recounted what he was wearing and what he brought along to eat and read as he began to walk toward the bridge.

"I was wearing a backpack and took along two books, an apple, an orange, a toothbrush and toothpaste," he said.

He said he expected to be arrested and wanted to be ready in case that happened and he wound up behind bars once again for demonstrating.

Some female church members wore high-heel shoes during services, and spectators who watched them join the marchers didn't feel they could go very far in a proposed 54-mile trek form Selma to Montgomery.

The bridge beating sent dozens of marchers, including Lewis, to the hospital for treatment. The violence angered the nation when it was shown on television later in the day. Some of that anger was generated by the marchers, including Lewis as he recovered from his injuries.

During his Sunday morning church address, Lewis recalled having said: "I don't understand how President (Lyndon) Johnson can send troops to Vietnam but can't send troops to Selma, Alabama, to protect people who only desired to register to vote."

Sewell grew up in Selma, and although she has since moved to Birmingham, she has always considered Brown Chapel to be her home church and she mentioned that Sunday morning.

As has been the case in past Bridge Crossing Jubilees, dozens of U.S. House and Senate members joined a large crowd for the annual event.


