# Romulus cop loses badge over road rage incident



ROMULUS - A road rage incident cost a Romulus police officer his job. David Brooks had been placed on suspension since June.

That's when he was accused of unlawfully pointing a firearm at a motorist during an off-duty incident in the area of Belleville and I-94.

Following Brooks' arraignment on two felony criminal charges of felonious assault

and felony firearm, an internal review took place to determine his fate.

The Romulus Police Department decided Brooks' actions violated departmental policies and procedures.

In fact, the department felt it had no choice but to terminate the officer.

Brooks had been with the department for two years.


During a press conference held at the Ecorse Police







basement/structure to remove health hazards from possible flood water mud. Shovel out as much mud as possible. Quickly remove the water you use during this cleaning.

\*Clean and dry out basement or structure thoroughly within 24 to 48 hours after flooding to help prevent the growth of mold

\*Help the drying process by using fans, air conditioning units and dehumidifiers.

\*If flood water did not get behind the structure's walls, you can reduce the chances of mold and mildew formation in basements and homes by wiping down all flood wateraffected surfaces. Use a solution of one cup of liquid household bleach to a gallon of water.

\*Never turn power on or off or use an electrical tool or appliance while standing in water.

\*Throw away any food that has come in contact with flood waters and dented or damaged canned goods that may have become contaminated. \*Replace any drywall and insulation that has been soaked by flood waters.

\*Remove and discard carpeting, rugs, drywall, mattresses, furniture and other items that cannot be washed and disinfected if it is believed that they came in contact with flood water mixed with raw sewage.

\*When cleaning, never mix bleach with ammonia or other household cleaners. Mixing bleach or ammonia or other cleaning products can produce dangerous, toxic fumes causing serious injury or even death. Keep windows and doors open to provide fresh air for ventilation during the cleaning process.

Keep children and pets out of work area. Do not eat, drink, chew gum, or smoke while cleaning.

\*Wash cleaning clothes in hot water and detergent separately from family laundry.

\*In the weeks and months following clean-up, watch for the growth of mold, which can cause illness. Mold appears as spots that can be many different colors and gives off a musty odor. Mold should be removed immediately with a mixture of one cup bleach (8 oz.) to every gallon of water.

\*After clean-up, make sure electrical outlets are safe to use before restoring electrical power.

\*Service damaged septic tanks, cesspools, pits and leaching systems as soon as possible. Damaged sewage systems are health hazards.

\*Wells providing drinking water to homes and businesses that were infiltrated by flood waters should be pumped out and the water should be tested for purity before drinking. Drinking water contaminated with bacteria and germs can cause illness

\*Stay away from downed power lines and anything that the power lines might be touching. Alert authorities immediately if you see downed power lines, and keep children and pets away from them.

# **Overdraft Fees Drain Consumer Dollars**

Consumers who maintain low and no cushions in their checking accounts may have thought that the overdraft "banking service" was a big help against bouncing checks. But as the use of debit cards have replaced most cash purchases, this "service" has become a drain of available cash for consumers and a major source of revenue for banks.

A new research report by the Financial Consumer Protection Bureau (CFPB) found that the majority of debit card overdraft fees are incurred on transactions of \$24 or less. Further, as the majority of overdrafts are repaid within three days when the bank repays itself from the consumer's next deposit, the median overdraft fee of \$34 carries the equivalent of 17,000 percent annual percentage rate (APR).

Earlier research by the Center for Responsible Lending (CRL) similarly found that consumers using debit cards paid \$1.75 for every \$1 overdrawn.

"With the advent of debit cards, consumers started using them rather than cash for more and more small or impulse purchases. And, as banks and credit unions covered more and more of the transactions, they have assessed higher fees for doing so," said CFPB Director Richard Cordray. "Today, more than half of consumer checking account income is from overdraft fees."

An overdraft occurs when a consumer does not have enough money in his or her checking account to cover a transaction, but the bank or credit union pays the transaction anyway in exchange for a fee. Consumers can be charged overdraft fees on checks, debit cards, ATM transactions, automatic bill payments or direct debits from lenders or other billers.

CFPB's new study both reinforces and heightens ongoing concerns that overdraft fees on debit card transactions in particular are harmful to consumers. CFPB also found that a 2010 rule from the Federal Reserve did not solve the overdraft problem. That rule required financial institutions

to get consumers' opt-in to overdraft fees on debit cards; but it failed to address how large and frequent these fees can be. Additionally, many banks used heavy-handed and deceptive marketing tactics to lure consumers to 'opt-

CFPB found that consumers subjected to overdraft fees on debit cards, pay an average of nearly \$260 per year in overdraft and nonsufficient funds (NSF) fees. Nearly one of five consumers overdrew their checking accounts more than 10 times a year.

Every dollar charged for overdraft translates into fewer available dollars once a deposit is made into the account. Even worse, many consumers are unaware of the deficiency in their funds or how often these fees were charged until after the fact. As a result, many consumers can be blindsided by a barrage of fees resulting in a devastating financial impact. The hardesthit of consumers in these scenarios are those with low- to moderate-income.

Some banks - such as Citibank, Bank of America. HBSC and a significant number of community banks have chosen not to charge overdraft fees on debit card purchases at all. Even so, most banks continue to use overdraft fees as a lucrative revenue stream.

In recent years, civil rights leaders have spoken loudly and clearly against overdraft practices, noting that harmful overdraft increases the ranks of the unbanked. Two major banks, JP Morgan Chase and Wells Fargo were directly asked to end charging overdraft fees on debit card transactions.

Reacting to the new CFPB findings, Mike Calhoun, CRL president said, "Adding insult to injury, consumers get hit even harder when banks reorder transactions to trip consumers into paying higher fees and charge additional fees each day an account is overdrawn."

"Thankfully some banks have begun stepping away from these abusive practices. . . The CFPB should use its authority to ban or limit overdraft fees on debit card and ATM transactions and rein in excessive bank fees on all checking account transactions," concluded Calhoun.

### **Death of Michael Brown**



**Michael Brown** August 11,2014

Dear Attorney General Holder:

The facts that have begun to emerge surrounding the August 9, 2014 killing of 18year old Michael Brown by a police officer in Ferguson, Missouri raise potentially serious concerns, particularly because it may be part of a continuing pattern of the use of deadly force by police against unarmed African-Americans. While we appreciate that the facts are still coming to light in this case and we do not prejudge the incident, we believe that the seriousness of the incident requires intervention by federal law enforcement agencies and we are heartened to learn of the parallel federal investigation that announced today.

According to press reports, Mr. Brown, who was unarmed, was fatally shot by a member of the Ferguson Police Department this past Saturday afternoon. I The St. Louis County Police Department, which is currently investigating the shooting, claims that the shooting

occurred after Mr. Brown assaulted the officer and the two men struggled for the officer's gun, but local community members have expressed strong skepticism and outrage about this explanation.

According to one eyewitness account, several shots hit Mr. Brown as he attempted to flee with his hands in the air, suggesting discrepancies with the St. Louis County Police account. More broadly, press reports suggest that Mr. Brown's shooting may be symptomatic oflarger racial tensions in Ferguson

We further appreciate the fact that the Community Relations Service is already present in Ferguson to help calm tensions in the community following the shooting of Mr. Brown. A full federal investigation, however, is needed and we ask that the full resources of the Department of Justice be brought to bear in this matter.

# Consumer Reporting Agencies Follow Your Moves

By now, you've probably heard about the Big Three credit bureaus (Equifax, Experian and TransUnion), which monitor your financial history and issue credit reports and credit scores to potential lenders. But did you know that there are dozens of other specialty consumer reporting agencies that track your history for activities that may not appear on your regular credit reports - things like bounced checks, late utility payments, insurance claims and prescription orders?

Most people never hear about these companies until they're suddenly turned down for an apartment, checking account, insurance policy or even a job or promotion. But you need to know that potential landlords, banks, insurance companies and employers are very likely ordering specialty reports to help them assess the risk of doing business with you.

That's fine if you've got a squeaky-clean track record. But what if their files contain mistakes; or worse, what if someone has hijacked your identity and is poisoning your record with their own bad behavior?

Fortunately, you do have recourse. Under federal law, you can request a copy of your report once a year from each agency, generally for free. You're also entitled to a free copy whenever an "adverse action" is taken against you because of something in the report. (For example, if you're turned down for a checking account.)

Unfortunately, there's no central clearinghouse for these specialty agencies so you need to contact each individually. However, the Consumer Financial Protection Bureau has taken some of the legwork out by compiling a list of the most commonly used agencies, along with instructions and contact information for ordering your reports. (Search "Specialty Consumer Agencies" at www.cfpb.gov.) Another great resource is the Privacy Riahts Clearinghouse's fact sheet on specialty reports at www.privacyrights.org.

Specialty consumer reporting agencies collect information

about you from various sources and share it with creditors and other businesses, including:

- \*Public records of criminal and civil cases
- \*Credit history
- \*Bankruptcy filings
- \*Companies with which you have an existing or prior relationship
- \*Medical information
- \*Driving records

Typical inquiries might include:

\*Check-writing history – for banks, credit unions and businesses that accept payments by check. They'll look for things like bounced or returned checks and fraud.

\*Medical conditions and prescription drug history — if you're applying for an individual life, long-term care or disability insurance policy. (Note: Health insurers can't deny coverage or charge higher premiums because of preexisting conditions.)

\*Residential – landlords checking your tenant history, credit, criminal background, etc.

\*Auto or homeowner/renter's insurance — insurers will screen your records for things like traffic violations, claims and property losses.

\*Payday lending – creditors investigating people who don't use traditional financial services (banking, credit cards, etc.) might evaluate payday loans, check-cashing services, prepaid cards, etc.

\*Utilities – If you're trying to open a new utility, phone, cable or Internet account.

\*Employment background – By law, employers must obtain your permission to run a background check. Unfortunately, they're generally not required to identify which company they're using unless they decide not to hire you – it doesn't hurt to ask ahead of time, though.

Note that when you dispute information in your reports, agencies are legally obligated to investigate and correct any inaccurate or outdated information. Also, they must give you an update on the status of your request to view your report. However, there is no time limit on when your request must be processed.

Bottom line: You might not realize there's false or potentially damaging information being reported about you, so get in the habit of ordering specialty consumer reports along with your credit reports.

# BACK TO SCHOOL SHOE SHOPPING Tips from the MPMA



During the back-to-school time frame and throughout the year, one of the most important purchases on any parent's shopping list should be a pair of proper fitting shoes for their child. The Michigan Podiatric Medical Association (MPMA) would like to share several important factors that parents should consider while shopping:

\*Children's Feet Change with Age. Shoe and sock sizes may change every few months as a child's feet grow. \*Shoes That Don't Fit Properly Can Aggravate the Feet. Always measure the child's feet before buying shoes, and watch for signs of irritation.

\*Never Hand Down Footwear. Just because a shoe size fits one child comfortably doesn't mean it will fit another the same way. Also, sharing shoes can spread fungi like athlete's foot and nail fungus. \*Examine the Heels. Children may wear through the heels of their shoes quicker than outgrowing shoes themselves. Uneven heel wear can indicate a foot problem that should be checked by a podiatrist.

\*Take Your Child Shoe Shopping. Every shoe fits differently. Letting a child have a say in the shoe buying process promotes healthy foot habits down the road.

\*Always Buy for the Larger Foot. Feet are seldom precisely the same size.

\*Buy Shoes That Do Not Need a "Break-In" Period. Shoes should be comfortable immediately. Also make sure to have your child try on shoes with socks or tights, if that's how they'll be worn.

\*Consider Closed Toe Shoes. Covering the child's toes allows for more protection.

Do Your Child's Shoes "Make The Grade?"

\*Look For a Stiff Heel. Press on both sides of the heel counter. It shouldn't collapse. \*Check Toe Flexibility. The shoe should bend with your child's toes. It shouldn't be too stiff or bend too much in the toe box area.

\*Select a Shoe With a Rigid Middle. Does your shoe twist? Your shoe should never twist in the middle

\*Are the shoes secure on the foot? Laces or Velcro are best to hold the foot in place.

Additional Advice for Parents

\*Foot problems noticed at birth will not disappear by themselves. Do not wait until children get older to fix a problem! Foot problems in youth can lead to greater problems down the road.

\*Get your child checked by a podiatrist. A lack of complaint by a youngster is not a reliable sign that there is no problem. The bones of growing feet are so flexible that they can be twisted and distorted without the child being aware of it.

\*Walking is the best of all foot exercises. Observe your child's walking patterns. Does your child have gait abnormalities? Correct the problem before it becomes a bigger issue.


\*Going barefoot is a healthy activity for children under the right conditions. However, walking barefoot on dirty pavement can expose children's feet to the dangers of infection through accidental cuts and to severe contusions, sprains or fractures. Plantar warts, a virus on the sole of the foot, can also be contracted.

\*Children's sports-related injuries are on the rise. A child's visit to a podiatrist can help determine any concerns there may be regarding the child participating in specific sports and help identify the activities that may be best suited for the individual child. Protective taping of the ankles may be recommended to help prevent sprains and fractures.



# **Declaration of a State of Emergency** in Wayne County

and request for a Governor's Disaster Declaration



On August 12th, 2014 at 2:00 p.m. a disaster is being declared for Wayne County. Over the course of Monday August 11, 2014 an almost unprecedented heavy rainfall deluged Wayne County and the entire area of southeastern Michigan. This severe weather event created dangerous flooding throughout many areas of Wayne County, and as a result, we have declared а State Emergency and call on the Governor to do the same, so that state and federal resources may be made available to our local communities and citizens.

Therefore after assessment of Wayne County infrastructure and thousands of homeowner reports of significant flooding,

this incident has been determined to seriously threaten the health and safety of residents in the Charter County of Wayne, Michigan.

Accordingly, and in accordance with Wayne County **Emergency Operations Plan** and Section 10 of Act 390, P.A. 1976, as amended. I hereby declare that a State of Emergency exists therein. The response and recovery aspects of our Emergency Operations Plan have been activated, and all local resources are being utilized to the fullest possible extent.

Local resources are not sufficient to cope with this emergency situation. Therefore, in accordance with Section 12 of Act 390, P.A. 1976, as amended, I deem this incident to be beyond the control of this political subdivision and I respectfully request, for and on behalf of the citizens of Wayne County, that the Governor declare a State of Disaster or a State of Emergency exists therein and that consideration be given, if conditions warrant, to petitioning the President of the United States for assistance provided by the Robert T. Disaster Stafford Emergency Assistance Act (Public Law 93-288, as amended).

I have assigned Timothy McGillivary, Director of the Department of Homeland Security and Emergency Management, to provide liaison and coordination with local, state and federal authorities for assistance related to this emergency. In accordance with Section 14 of Act 390, P.A. 1976, as amended, he is directed to transmit this request to the **Emergency Management and** Homeland Security Division, Department of State Police, the most expeditious means.

This Declaration is effective August 12th, 2014 at 2:00p.m. and is in effect until further notice.

I do not believe people on welfare should be drug tested, as it opens Pandora's box. You're judging a group of people based on their living situation essentially. It sets a dangerous precedent.



## Yost settling in chief's seat

Vicki Yost can't seem to stop moving. Inkster's new interim police chief seems to be a patrolwoman at heart. "I don't want to sit behind a desk 24/7, and I still don't want to," she said during a recent interview. "I really enjoy being out there, being engaged and interacting with the community."

She could show better than she could tell, as she has been on several ride-along with a few officers and participated in an arrest. It is exactly this kind of hands-on approach that she wants to bring to her new post. She said that the community seems very engaged and responsive, and that the officers seem very dedicated.

"I appreciate the fact that one of my officers took 45 minutes to engage and mentor a young man that was making some poor choices, and I also like that the community came up and said thank you," she said. "That means a lot more than the officers know and would care to admit, quite frankly."

Which is good, because she knows that including them is crucial to solving crimes. "We do need the community to step up and join us and help to provide information," said Yost. "At some point, we're all responsible for the actions we take and we don't take. Inevitably, we're solving the crimes that were committed against the community, so their participation is critical."

Yost comes to Inkster after 19 years with the Detroit police department, most recently serving as a deputy chief. "Each community has their own little quirks," she said. "There may be some similarities, but I've found that most communities are unique."

Yost plans to have some meetand-greet events, including faith-based initiatives to reach out to the citizens. "I would like to talk them about our operations and seek opportunities for improvement," she said. "Sometimes the best answer doesn't come from the chief. Sometimes it's here, but we just have to ask the right ques-The Florida native received a bachelor's degree from the University of Maryland and a master's from Eastern Michigan University.

When she was first introduced at the Aug. 4 city council meeting, she pledged to bring datadriven and solution-based practices to her job. "The data is crime, and where our hotspots are and where we deploy our resources," she "Solution-based has to do with coming up with answers, and understanding that partnerships and collaborations have to occur. We have to have conversations, identify goals, and then work to get to that point." She will be very busy trying to reach out to the community. But there is something that she does want the public to know.

"I have the utmost confidence in the men and women in our department to provide the services," she said. "We'll enhance our services to better collaborate. I want the residents of Inkster to know that they have a police department that's working for them."

had been missing for more than 16 hours when a motorist in the area of 19th Street and Salliotte Road in Ecorse saw her jump from a slow-moving vehicle that then sped off, said Ecorse Police Cpl. Chris Trevino. The motorist then told Turner, who had fallen but got up and started walking, to come sit in her vehicle.

Police originally reported that Turner had been on the phone with a friend last Thursday night when she said she was being followed by a man who had a gun. Her car was found abandoned and still running in Bedford Township about forty miles from Ecorse.

Officer Blade and Public Safety Director Michael Moore took Haley to the area where she supposedly had been in Ecorse, but she was unable to give valid answers to questions about the area. It was revealed that Haley and her companion were trying to get to Detroit, but they ended up in Ecorse.

Director Moore said that many man hours went into the investigation for this case. "I am very proud of the work that the police department and community did on this case." Their hard work determined that Haley was not be truthful about the abduction and being brought to Ecorse.

Moore said his department would turn over its investigation to the Monroe County Sheriff's Office, which is spearheading the case. Charges could be issued in both Monroe County and Wayne County.

"My frustration was very high because we're in a cash-

strapped city ... we can't afford to spend any dollars unnecessarily," Director Moore said. Detective Blade said working on this case took him away from working on other cases.

If said bill is not paid within 90 days of the due date, said amount shall be placed on the next general tax roll and collected as part of the general city taxes.

PROPOSED REVISED ORDINANCE § 52.13

PROPOSED REVISED ORDINANCE

BILLING AND COLLECTION PRACTICES FOR SERVICES.

- (A) Schedule of rates. The City Council shall from time to time by resolution set the following rates:
- (1) Consumption rates.
- (2) Monthly service charge.
- (3) Penalty for late payment.
- (4) Service connection charges.
- (5) Debt service charges.
- (B) The schedule for reading of meters, method of billing and delivery of bills shall be set by resolution of the Council.
- (C) Payment of bills. Water bills are payable at the office of the Water Department. Bills paid to any other person, concern or agency are so paid at the risk of the customer.
- (D) Collection of delinquent accounts. Whenever the rates fixed by the Council or charges made by the Department for services rendered are not paid, the water may be shut off and collection enforced in accordance with the laws of the state and/or by placing said amounts on the city tax roll.
- (E) Shut-off notice. Customers whose bills are unpaid 30 days past the due date will be subject to shut off without further notice. A statement to this effect will be placed on the original bill. An additional penalty determined by Council resolution will then be charged to the customer and shall be paid together with all unpaid charges before service will be turned on again. If said bill is not paid within 90 days of the due date, said amount shall be placed on the next general tax roll and collected as part of the general city taxes.
  - (F) Temporary service connections.
- (1) The term temporary service connection is applied to a connection installed to serve an individual, firm or corporation for a definite temporary period for such purposes as supplying water to a construction project or to a temporary structure.
- (2) The Department reserves the right to refuse to install a temporary service connection for any reason that it deems sufficient.



# Family Secret To Tell or not to Tell

My cousin has suffered from depression and alcohol abuse in recent years. I think that this all stems from her need to "fit in". I believe that my aunt shared this information with me so that I would tell my cousin. I think that if my cousin knew that her feelings of being an outsider were valid, it may hurt, but it could help her in the long run. This secret is eating me up inside. Do you think I should tell my cousin that my aunt and uncle are not her birth parents?

No, I don't think you should

tell your cousin. First of all, it wasn't your business to know. Second, why do you think it's your place to reveal such deeply personal information? Stay in your lane! If you are concerned and feel like this information can in some way benefit her, talk to her parents. Let them decide if and when they want to tell her about her adoption. The truth of the matter is, you don't know if the information that you received from your aunt is accurate or not. Many a "secret" passed down as gospel, has later been revealed as nothing more than gossip. I don't mean to disrespect or dishonor your aunt in any way. However, is it possible that the information she has about your cousin could be false? I would consider the ramifications of your actions, should you choose to tell your cousin about this alleged adoption. What if you're wrong? How would this impact not only your relationship with your cousin, but also the one that you share with her parents? Could this in some way negatively affect your late aunt's character? And, what if you're right-that could pose problems as well. Let this be a conversation had by your cousin and her parents. In the mean time, continue to love and support her as you always have. Encourage her to seek professional help for her struggles with depression and substance abuse. If the time comes, and your cousin finds that she is indeed adopted, remind her what an honor and privilege it is to be her loved one-to be family.
