•Residential Shut Off moratorium ends August 25th Three major donors have stepped forward to contribute a total \$200,000 to the Detroit Water Fund, Mayor Mike Duggan's response to helping low-income Detroiters with their water bill. Representatives of United Way for Southeastern Michigan (UWSEM), the Ford Motor Company Fund and the General Motors Foundation announced their donations today at

The injustice, he said, was two-fold: a police shooting of an unarmed black teen followed by black youth from high-unemployment neighborhoods erupting in rage.

"Black men should not be the objects of target practice, Jackson said of the shooting. "It's not a unique situation. It's a prototypical American situation. Police departments do not reflect the population. It's awful, but it's not unique.'

The resulting community violence on Sunday, following a non-violent candlelight vigil to commemorate Brown, should be seen in the context of a chronic urban crisis, he said.

Poverty is a weapon of mass destruction," Jackson said. "Poverty is in the community, guns are in, drugs are in, jobs are out. Banks are bailed out without meaningful community reinvestment. Too many people have no stake in the culture

Jackson said that chronic urban problems remain to be addressed after the shooting of Michael Brown and the community's outrage are re-

These kids need educations, skills, job training, jobs, scholarships to college," Jackson said. "We need a national forum on urban policy, justice and repression. This is a national crisis that has manifested in Ferguson.'

Asked for advice to organizers on the ground, Jackson said, "That's tough. I saw a sign that said we need quietness. Quietness is not the answer. Quietness is the absence of noise. We need the presence of justice.

released a new report, "Community and Economic Benefits of Bicycling in Michigan." This report is Phase I of a twophase project that explains the economic benefit bicycling has on Michigan's local and statewide economies. The report and user friendly infographics are online www.michigan.gov/mdot/

The new report finds that bicycling provides an estimated \$668 million per year in economic benefit to Michigan's economy, including employment, retail revenue, tourism expenditure, and increased health and productivity.

Using both quantitative and qualitative data, the report takes a unique approach to illustrate both the economic benefits of bicycling on a statewide basis, as well as broader benefits bicycling can have on communities.

As part of Phase I of the study, five case study communities were identified across the state in an effort to measure the annual impact bicycling can have on a local economy. All of the case studies were within the limits of these cities and did not include the broader metro areas:

- Traverse City: \$5.5 million
- Holland: \$6.4 million
- Detroit (southwest Detroit and the Conner Creek Greenway area): \$20.7 million
- Ann Arbor: \$25.4 million
- Grand Rapids: \$39.1 million

Phase II of this project is under way and will include more specific data on the economic impact of bicycling "events," bicycle touring, and Michigan as a bicycle destination. That phase is scheduled to be complete in 2015.

Do we perpetuate black stereotypes?

Many African Americans feel like there has been an unofficial war declared on Blacks, especially young Black males. Just in the past month alone, there have been the police murders of Eric Garner (Staten Island, N.Y.), Ezell Ford (Los Angeles, and Michael Brown (Ferguson, Mo.). Each of these victims were all unarmed, young, Black and

In each instance, there were credible witnesses or video recordings that recounted events very differently from the official police version. Based on what we know so far, I think all the policemen involved in these uniustified deaths should be convicted of murder and sent to jail.

As abhorrent as these actions were, they should spark a larger, separate conversation about the images that we have created around Black life and Black culture. To reiterate, regardless of these images, there is no justification for killing those young Black men. Let's be clear about

But let's be equally clear and courageous enough to take another look at what we are contributing to the misperceptions and stereotypes of us as a race. This is a separate conversation from what happened in New York, LA and Ferguson, Mo., but this is as good a time to hold it as

For the past 30 years, we have created images of Blacks in the most negative of lights. For those who would say it's just music, it's just a movie, it's just a reality TV show; I say now there is just another Black body lying in the streets of America.

Before you go to war, the first thing that is needed is to create a psychological operations campaign (psy-ops). This is a tactic that the military uses to marginalize its targeted population so that when the troops are sent in to destroy this group, there is no public outcry.

Just look at how the U.S. military vilified and demonized former Iraqi president Saddam Hussein and terrorist Osama Bin Laden before we set out to kill them. Upon their deaths at the hands of the U.S. military, the American people cheered because we had devalued and marginalized them before the American people. I can't help but ask the Black community, have we unleashed a pys-ops campaign on our own

In the horror movie series Frankenstein, Dr. Frankenstein did not set out to create a monster; but rather he was a scientist playing around in his laboratory. As a result of this experimentation, he created a monster that

neither he nor society could con-

In a similar manner, one could argue that Blacks, specifically in Hip-Hop, have experimented in the laboratory called a recording studio; and by exercising their First Amendment Right of freedom of speech and expression through music, they have created their own version of Frankenstein.

In the beginning, like with Frankenstein, people marveled at this new creation and people were willing to pay to see and hear it. There was "Rappers Delight," there was "The Message," and there was "Fight the Power." Then, the imagery and lyrics took a twisted turn under a perverted interpretation of the First Amendment called "keeping it real.

Now, the establishment, especially the police, had become the enemy. Hip-Hop became a counter-culture movement that turned into a monster that could no longer be controlled. Women became "bitches and hoe's," men became hyper-sexualized thugs who were only out to force themselves on your daughters and to "get rich or die trying."

When rap music started, it was a verbal extension of the Civil Rights Movement of the 1960s in the spirit of the Dr. Martin Luther King, Jr.; it was about the uplifting of our community and providing a voice to those often without

Then in the 1990s, rap took a more militaristic tone with the creation of "gangsta rap." This too, was an verbal extension of the Civil Rights movement; but more in the spirit of Malcolm X on steroids. These artists represented those in the "hood" who felt trapped and abused by the system. They felt like no one cared about them and that life was about the here and now immediate gratification; so screw the future. They wanted to "get theirs now." They wanted to live fast, even if it meant dying

This ultimately led to the "thug" culture, personified by hit movies like Scarface. New Jack City and Carlito's Way; each glorified the criminal lifestyle.

Then you had the crack epidemic of the 1990s with the violence that it brought into the hood. All these factors combined to create a narrative that Black life was worthless and Black youth brought no value to society.

It's too bad the rap world didn't heed the words of Chuck D, KRS-One, Doug E. Fresh, Heavy D, MC Lyte, Kool Moe Dee. D-Nice, Daddy-O and others on the all-time classic, "Self Destruction," which had as its chorus. Self-Destruction, ya headed for Self-Destruction (repeat)."

These People Ain't Loyal

Most of us like to think that we are loval people. Few people will say that they are disloyal. No one wants the negative stigma associated with being disloyal. Few people are humble enough to admit that they have failed someone.

While some are more loval than others, I wonder if there is anyone who is truly loyal in every sense? What is loyalty anyway? Loyalty is synonomous to faithfulness.

In marriage, loyalty is expected. When a married person is unfaithful, it is called adultry. Adultry is a serious word. When you think of adultry, you think of one of the highest forms of betraval. It

means you totally disrespected a commitment. It means you did something that was forbidden. You broke the

Adultery is generally associated with unfaithfulness in marraige. But we have to remember that unfaithfulness in any area is just as wrong. Any act of unfaithfulness or whenever a commitment is violated. we have not been loyal. While it is popular in the day and age to point out disloyal people, even in songs, we have to remember that we too are disloyal in some fashion.

So someone who is accused of committing adultry is viewed unfavorably and often times those who feel victimized want the adulterer to be punished. You may recall a parable in the Bible found in the Book of John, chapter 8.

and they were like, "This woman ain't loyal. She was caught in the act." Well they didn't say it quite like that, but in our modern urban context, it could be interpretted that

So anyway, they were really trying to trip Jesus up and throw Him off His square. They made the woman stand in front of everyone. I guess to humiliate her and of course, they wanted her stoned because that's how they handled those situations in that era, in accordance to the law Moses put out. Instead of Jesus agreeing with them, He got quiet and kneeled down and wrote in the sand with his finger. I don't know what He wrote. But when He got up, He said, "Whichever one of you has committed no sin may throw the first stone at her (v.7).

They all just started walking away. None of them were blameless. She could not be condemned, but Jesus told her something very important before they parted. He said, 'Go, but do not sin again (v.11)." He warned her.

We must remember before we put someone on blast, saying

they (pardon the term) ain't loyal, that neither are we in some area of our life. No one really cared why she did what she did. They did not consider her circumstances or how she was raised from childhood and the impact it could have on her psyche. Not that there's any excuse, but it was not considered. They just wanted her punished, to the utmost with the harshest penalty, death by stoning.

The punishment we wish on others, could show up at our own doorstep. We have to watch our mouths and hearts. Also, we have to remember the mandate at the end of the

story, 'don't keep doing it." When our bad behavior is brought to our attention, we need to stop it, at least feel bad and move in the direction of correction.

We need to think about our own faithfulness to God. God is always faithful to us, even when we are not. We often assess others and that's good. But we cannot neglect to assess ourselves. We don't need to trust people who have proven untrustworthy, but we have to forgive. When we think about our own lack of loyalty in certain areas, it should make us more gracious overall. God bless.



IN THE SPIRIT

Marriage vs Water

A few months ago, many of my colleagues in ministry consisting of local preachers and pastors were shown rallying around the issue of same-sex marriage here in Michigan. Since February, there has been a plethora of ads, Bible studies, protests, rallies, sermons and statements around this issue. I do believe everyone's opinion and theology on the issue deserves to be heard.

Some stated that there were concerns about the quality of life that those children adopted by Jayne Rowse and April De-Boer would lack being forced to live in a same-sex marriage. Others stated that it was sinful and totally wrong, according to their belief in the Bible and their understanding of Scriptures. One particular pastor shared with me that it was an attack on the family and if the laws allowed for same-sex marriage, it would destroy the very fabric of the family. There has been a great "coming together" within the Christian community around this issue.

However, within the last month another issue that certainly deals with the issue of family has surfaced and I have yet to see any rallies on Fox News from many of my same colleagues. This colorless, odorless and tasteless substance that is vital to all life survival called water has been in the headlines nationally and I haven't seen the same enthusiasm from the Christian community. If there was ever a REAL REASON for my Christian colleagues to rally and stomp for the family, water should be one.

I am appalled, disappointed and embarrassed by what appears to be a proclivity and propensity for what's popular, and total silence by what should be prophetic. As Dietrich Bonhoeffer stated, "Silence in the face of evil is itself evil: God will not hold us guiltless. Not to speak is to speak. Not to act is to act." As a Social Gospel and Liberation Theology preacher and pastor, I find it ironic that the prophetic voice is either silent or whispering around this issue of water but there was a clangorous voice around marriage.

Perhaps some of my colleagues are unaware the gravity of this water issue, so I will share some of my concerns. It is beyond folks who simply are "trying to get water for free" as many of those persons unable to pay their bills have been portraved.

Water is a natural resource. God-given and owned, and I personally have a problem when persons make a profit off of God's resources. We are dangerously flirting with our water becoming privatized, and history has proven, once that occurs our bills will at least triple. In Bolivia on two occasions in 2000 and 2005, the Bolivian government turned the water system over to private companies and this lead to country-wide street protesting. Eventually, the Bolivian government retracted these private contracts and kept their water system public.

The Homrich Wrecking, Inc. Company has been given a \$5.6 million contract for two years to shut off the water of over 150,000 homes by the end of the summer. Only 10 prophetic voices stood up for these homes, and they were arrested on July 10, 2014 for blocking the trucks owned by Homrich Wrecking, Inc. Michigan law mandates that no child shall be raised in a home without water, and it is also against the law for dogs and cats to be without water. While many from the suburbs had plenty to say about Detroiters wanting "free water", they were "church mouse" quiet about the unpaid water bills of the State of Michigan's \$5 million. Joe Louis Arena's \$80,000 or Ford Field's

Are my colleagues aware that this is a family-breaking issue? Since it's against the law for children to be in homes without water, how long will children be allowed to live in these homes before they are turned over to Child Protective Services? Why are water bills connected to addresses and not individuals? Perhaps our enthusiasm over marriage has blinded us to the issue of life, water, and we are so focused on marriage that we are sleeping on life. No living creature can survive without water. I would encourage my Christian colleagues to engage in prophetic social justice, and leave the popularity be-

I do find it very interesting that this recent heavenly activity to gather Michigan's attention was not fire and brimstone but water. Just this past week, we encountered record rainfalls and flooding. Perhaps it's a divine sign to where our voices are really needed, and what should have our attention. Perhaps it just me and my theology, but I am aware that our tri-county area has been declared a disaster?

Local Schools awarded fourth year of grant funding after making positive strides



LANSING – Twenty-two Michigan high schools, including Harper Woods, Mumford, Pershing, Robichaud, River Rouge, Southeastern and Truman High School, have been awarded a fourth year of funding from a grant aimed at improving student learning by coordinating programs designed to improve the physical, mental and emotional climate of the schools.

Fourth-year funding of the Safe and Supportive Schools (S3) grant, titled think.respect. in Michigan, is based on the positive results seen over the first three years of the grant, including:

•83% of schools reporting an improvement in school safety scores

•61% of schools reporting a decrease in harassment/bullying incidences on school property

•57% of schools reporting a decrease in the number of students using alcohol

"For students, academics are only one part of the educational process," State Superintendent Mike Flanagan said. "We know that overall emotional and physical health affects academic performance – that personal safety, bullying, mental health, substance use, obesity, and other factors can have an impact on student's ability to learn and achieve."

The goal of think.respect. is to develop concrete strategies that address these issues, leading to a school climate that fosters great academic achievement.

"While the think respect. initiative still is in its infancy, the schools have made progress over the past three years," added Kyle Guerrant, deputy superintendent for administration and school support services for the Michigan Department of Education. "There still is work to be done, and we are proud of the results we're seeing, and feel that the improvement in school climate will, over time, continue to bring about positive academic changes."

Inkster resident learns to manage Diabetes through area programs



Fourteen years ago, Inkster resident Angie Ellis was diagnosed with type 2 diabetes. Angie had been prediabetic for years and lost a brother to diabetes. Following her diagnosis, Angie experienced mood swings, changes in appetite, and weight fluctuation. "I was really upset," she explains. "It took me awhile to adjust and I'm still adjusting."

Diabetes is a serious disease that affects an estimated one million Michigan adults. It is often called a "silent disease" because it can cause serious complications even before a person experiences symptoms. If not managed properly, diabetes can lead to serious health problems such as kidney failure, heart disease, stroke, and more.

In April of 2011 Angie moved to Inkster where she learned about the National Kidney Foundation of Michigan's

Inkster community (NKFM) coalition, the Inkster Partnership for a Healthier Community (IPHC). On the path to better health and in an effort to effectively manage her diabetes, Angie participated in the NKFM's Diabetes PATH and BodyWorks programs offered in Inkster.

"I really enjoyed Diabetes PATH," Angie says, "I got to know a lot about myself as a diabetic and how to survive with diabetes.

Angie explains that Body-Works and Diabetes PATH helped her to make healthy lifestyle changes, especially when it came to modifying her eating habits. She stopped frying foods, started eating more vegetables, and stopped drinking pop. Many of these choices were a challenge, but Angie says that moderation is important. "I learned that I can eat the things that I enjoy as

long as I don't overdo it. Sweets are okay sometimes,' savs Angie.

Angie has also participated in the NKFM's Enhance Fitness program, which was offered at her apartment complex. She says that she would like to take more of these classes if she has the opportunity. Lately, Angie has been trying to walk more, as physical activity is an important part of a healthy lifestyle.

"What stuck with me most from these programs is to watch my sugar intake. When the instructor filled up the cups to demonstrate how much sugar was in certain drinks, the visual really hit me," says Angie, "Now when I go to the grocery store, I look at how many grams of sugar are in what I am buying.

In the future, Angie hopes to continue walking regularly and maybe even run. "I want to lose this weight. I know it won't happen all at once, but I'm working on it.

Although there are challenges in living with diabetes, Angie explains that it can be controlled. By making healthy food choices; being physically active; and knowing your A1c, blood pressure, and cholesterol numbers (the ABCs of diabetes), it can be managed to prevent other health complications down the road. Holder has a compelling case in the Brown killing

Attorney General Eric Holder has a compelling federal case in the Michael Brown killing if he decides to bring civil rights charges against Ferguson, Missouri cop, Darren Wilson.

He's certainly taken almost unprecedented lightning fast first steps in that direction. He's got a phalanx of FBI agents assigned to the case. He's authorized an autopsy by a crack medical examiner from the military. He personally travelled to the city to review procedures with civil rights division attorneys and investigators. None of this would have been done without the personal approval of President Obama who already has made more statements on the Ferguson furor and the Brown killing than he has on any other racially charged flashpoint issue during his White House

There are several factors within federal law that Holder has to look at to make the final decision whether to go forward with a prosecution. There has to be a "compelling interest" that the defendant's conduct could constitute a federal offense and that there is sufficient evidence against the defendant that the government can obtain a conviction.

There are clear elements of each of these hard federal prosecution requirements in the Brown killing. The compelling interest is probably the easiest of the requisites to satisfy. He was not charged with a crime by Wilson. He was stopped by all accounts for jaywalking. The allegations that Brown was a suspect in a convenience store heist, and that he smoked marijuana, and even that he may have actually had some physical altercation with Warren came way after the fact. Multiple eyewitnesses have been ab solutely clear on this crucial point. He was shot on the ground with his hands up. An independent autopsy has confirmed that Brown could not have been shot during a scuffle as Wilson, police, and an anonymous eyewitness claim.

The key point is that he was on a public thoroughfare when he was killed. The right to freedom of movement without the danger of undue harm is a fundamental right that's enshrined in constitutional law and public policy. It's inviolate. The courts have repeatedly upheld a citizen's right to freedom of access and move-

ment in public places.

Though there was no apparent racial motive in Wilson confronting Brown, his action clearly violated Brown's right to exercise his freedom of movement. This directly impacts on an individual's right to life and liberty. This civil right was violated the moment Wilson presumed that a young black man walking in a public thoroughfare had committed a crime. The safeguard of that right must be a fundamental concern of federal prosecutors.

The Brown killing case also strongly pointed to systemic issues of excessive force by po-The obvious excessive force that was used was the slaying of Brown. This strikes to the heart of another basic right of citizens, namely the right to life and liberty, and again the freedom from undue harm. His killing once more raised deeply troubling questions about the power of the law to protect citizens from their unimpeded right to life and safety. Federal prosecutors play a major role in insuring that where there's the suspicion that an individual's rights might have been violated solely because of their race and gender that the power of federal law is brought to bear to insure that right is protected.

Wilson was a police office and the charge that he abused his power in killing Brown under the color of law is the linchpin of federal prosecutions of local police officers. This was the rationale that federal prosecutors used in the Rodney King beating case to bring civil rights charge against the four LAPD officers that beat King. The crucial legal point was that they acted in an official capacity when they violated King's rights.

The Justice Department scrupulously goes to great lengths to shield itself from the charge that it's bowing to media or public pressure to prosecute. This is why the percentage of civil rights prosecutions it authorizes is infinitesimally low especially against police officers. Yet in the Brown slaying there are crucial federal interests in insuring the rights of individuals to be free from undue harm because of their color, age, and being in a public area merely because someone perceives they shouldn't be in and then acts on that perception with no cause other than that belief or perception.

Holder will give serious consideration to the civil rights violations in the Brown killing. This alone sends the strong signal that civil rights violations will always be subject to full and public scrutiny by federal prosecutors. This is exactly why he has a more than compelling reason to not only consider a Warren civil rights prosecution, but has a compelling case for a prosecution.

tions will be able to immediately begin assisting residents.

How the Detroit Water Fund

Starting August 11th Detroit Water and Sewerage Department (DWSD) Customer Care Centers began processing applications for the Detroit Water Fund. By paying down only 10 percent of their past-due bal-ance, eligible city residents will receive up to 25 percent assistance with their bill from the new Detroit Water Fund. DWSD has partnered with United Way for Southeastern Michigan, which will prequalify residents. To be eligible for Detroit Water Fund assistance, customers must be Detroit residents who:

·Have an outstanding balance between \$300 and \$1000; and

 Maintain Average Water Usage for their household size; and ·Are either enrolled in DTE's Low Income Self-Sufficiency Plan

(LSP); or,
•Have income at or below 150 percent of the federal poverty level (for example, a family of 4 must have an annual income below

This funding is available on a firstcome first-served basis and is subject to availability.

"We have been working with our partners on an ongoing basis as the city works through its challenges, and are committed to the citizens of Detroit to make sure they have a plan to address their water needs." said Jim Vella.

10/30/50 Plan

Mayor Duggan's plan also included a new payment option called the 10/30/50 Plan. Customers must first enroll in this plan in order to be eligible to receive assistance from the Detroit Water Fund. The 10/30/50 Plan gives residents 24 months to pay off their delinquent amount once they put down an initial 10 percent of their balance. If they miss a payment, the customer must first pay 30 percent to renter the program and 50 percent if they miss a second pay-

Moratorium ends August 25th Mayor Duggan reminded customers that the residential water shut off moratorium ends on August 25th. After that date, shut offs will resume, he said. However DWSD has committed to increasing its communication to customers scheduled for shut off to give them sufficient time to get into a payment plan.

Beginning today, DWSD workers will begin hanging "door hanger" notices on the home of each location schedule for shut off after the moratorium ends. DWSD teams will move throughout the city area-by-area posting the notices at least seven days ahead of shut off crews. door hanger is in addition more descriptive notices that also are being mailed to customers to notify them of their shut off status.

"The goal at DWSD is to help Detroiters get to current status or to allow them opportunities to get on a payment agreement plan," said DWSD Director Sue McCormick. "The contributions of United Way, GM Foundation and Ford Motor Company Fund will really help us provide that extra layer of assistance to our customers that are in need DWSD is thankful to GM, Ford and United Way.


